VOLUNTARY CORRECTIVE ACTION PLANS AND PRODUCT RECALLS

Voluntary Corrective Action Plans and Recall of Products Subject to Product Safety Standards and Other Specific Regulations Exclusive of Section 15 of the Consumer Product Safety Act

The Directorate for Compliance and Administrative Litigation and the Regional Offices are jointly responsible for identification of consumer products which fail to comply with a specific product safety standard or other Commission product-related requirements mandated by statute or regulation. Commission staff works cooperatively with the responsible firms to obtain voluntary corrective action plans as appropriate to protect the public. Following is a list of these product recalls and corrective action plans monitored by the Commission staff during fiscal year 1990.

Consumers may find products on the market which resemble those appearing on this list. After manufacturers and importers correct violations, they may distribute complying versions of products which were recalled. CPSC monitors recalls to ensure that the noncomplying products have been removed from the market. It is unfair to responsible manufacturers and importers to conclude that toys and children's products on the list are still offered for sale.

APPENDIX G

Litigation and Settlements

LITIGATION AND SETTLEMENTS

This appendix summarizes the federal court cases to which the Commission was a party, civil penalty settlements, and consent agreements accepted by the Commission. Categorized by type, the following cases were pending in court during fiscal year 1990:

INJUNCTIONS

- United States v. Charles Focht and Mark Focht, d/b/a 1. Liberty Industries, Civil Action No. 88-1217 (W.D. Pa.) and No. 88-3781 (3d Cir.). On May 28, 1988 the government filed a complaint seeking an injunction against a mail order fireworks components supplier. Following a hearing on September 13, 1988, the District Court denied the preliminary injunction request, holding that the components distributed by the firm are not themselves necessarily components of banned fireworks. On August 8, 1989 the Court of Appeals reversed and remanded, holding (1) that the components at issue are banned hazardous substances and (2) that an objective test of how a product is intended to be used, rather than a subjective standard of intent, must applied in determining whether otherwise harmless components are intended to be made into banned hazardous fireworks. On November 9, 1989 the government filed a pleading seeking resolution of the injunction issue by the District Court. The firm responded on December 8, 1989. Negotiations took place between the parties, but did not resolve the case. On March 1, 1990 the government moved for a permanent injunction which the Court ordered on June 7, 1990.
- 2. United States v. L.W. Loyd Co., Inc. and Lew W. Loyd, Civil Action No. 1-89-452 (D. Tenn.). On September 14, 1989 the government filed a complaint and motion for preliminary injunction against an importer of fireworks. Following expedited discovery, the Court conducted a consolidated hearing on a preliminary and permanent injunction on October 26 and 27, 1989. Both sides filed post-hearing briefs on November 10, 1989. On February 20, 1990 the Court issued a permanent injunction, requiring the firm to test 20 samples of every firework it imports and to notify the CPSC of all failures. The Court ruled that an affirmative testing order was within its broad equitable powers, and deferred to CPSC's judgment on the scope of such an order. The Court further ruled that CPSC was not unfairly discriminating against the firm and that the "vagaries of Chinese manufacturing" did not relieve the firm of its obligations under federal law. On

- March 9, 1990 the government filed a motion seeking a modification of the Court's order to clarify that the injunction is not rulemaking under the Administrative Procedure Act. On May 8, 1990 the Court corrected the wording of its earlier memorandum "to avoid confusion."
- United States v. B. J. Alan Company, Inc. and Bruce Zoldan, Civil Action No. 4:89 CV 1843 (N.D. Ohio). On September 25, 1989 the government filed a complaint and motion for preliminary injunction against an importer of fireworks. The firm moved for summary judgment on December 11, 1989. Based on an agreement between the parties, the Court issued a preliminary injunction on December 19, 1989. On January 10, 1990 the government filed a cross motion for summary judgment and response to the firm's motion. On March 7, 1990 the Court entered a consent decree of permanent injunction which requires the firm to test 15 samples of every firework it imports.
- 4. United States v. South Carolina Distributors, Inc. and Herbert Livingston, Civil Action No. 7-89 2281-3 (D.S.C.)
 On September 12, 1989 the government filed a complaint and motion for preliminary injunction against an importer of fireworks. On December 29, 1989 the Court issued a preliminary injunction against the firm. On March 12, 1990 the Court entered a consent decree of permanent injunction which requires the firm to test 15 samples of every firework it imports.
- 5. United States v. Winco Fireworks and David Collar, Civil Action No. 89-2400-S (D. Kan.). On September 11, 1989 the government filed a complaint and motion for preliminary injunction against an importer of fireworks. On October 4, 1989 the firm filed an answer to the complaint. On March 6, 1990 the Court entered a consent decree of permanent injunction which requires the firm to test 15 samples of every firework it imports.
- Onited States v. Stonebraker Rocky Mountain Fireworks Co. and William Stonebraker, Civil Action No. 89-M-1555 (D. Colo.). On September 12, 1989 the government filed a complaint and motion for preliminary injunction against an importer of fireworks. On November 28, 1989 the firm filed a motion for summary judgment. On December 22, 1989 the government filed a cross motion for summary judgment and a response to the firm's motion. On April 2, 1990 the Court entered a consent decree of permanent injunction which requires the firm to test 15 samples of every firework it imports.

- 7. United States v. Red Rocket Fireworks Co., Inc. and Daniel Aycock, Civil Action No. 90-0363 (D. Colo.). On January 31, 1990 the government filed a complaint and motion for preliminary injunction against an importer of fireworks. On March 23, 1990 the Court entered a consent decree of permanent injunction which requires the firm to test 15 samples of every firework it imports.
- 8. United States v. Advanced Imports, Inc. and Gerald Dunnegan, Civil Action No. 90-1634 (D. Kan.). On July 3, 1990 the Court entered a consent decree of permanent injunction, which was filed simultaneously with the complaint and which requires the firm to test 15 samples of every firework it imports.
- 9. United States v. Clover Imports, Inc., Louis Casale and John Beckmann, Civil Action No. 90-1489 (MAC) (D.N.J.). On April 30, 1990 the Court entered a consent decree of permanent injunction, which was filed simultaneously with the complaint and which requires the firm to test 15 samples of every firework it imports.
- 10. U.S. v. O.K. Toys, Inc. and M. K. Chow, Civil Action No. 90-3970 RJK (GHKx) (C.D. Cal.). On August 10, 1990 the Court entered a consent decree of permanent injunction, which was filed simultaneously with the complaint and which prohibits the firm from importing toys that fail to comply with CPSC requirements.
- 11. U.S. v. Toys R Us, Inc., Charles Lazarus, and Michael Goldstein, Civil Action No. 90-3315 (D.N.J.). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys. Discovery began, with depositions taken on September 24, 26, and 28, 1990.
- 12. U.S. v. Illco Toy Co., USA and Martin Scheman, Civil Action No. 90-C-5405 (JFK) (S.D.N.Y.). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys.
- 13. U.S. v. Lionel Leisure, Inc. and Michael J. Vastola, Civil Action No. 90-5417 (E.D. Pa.). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys. A telephone status conference was held on September 7, 1990. Discovery began on September 17, 1990. A preliminary injunction hearing was scheduled for November 5, 1990.

- 14. U.S. v. Beachcombers International, Inc. and Harry Chernin, Civil Action No. 90-255-CIV-FTM-17D (M.D. Fla.). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys. Status hearings were held on September 5 and 29, 1990.
- 15. U.S. v. Child World, Inc. and Dennis H. Barron, Civil Action No. 1:90 CV 1486 (N.D. Ohio). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys.
- 16. U.S. v. Value Merchants, Inc. and Phillip Cohen, Civil Action No. 90-C-0824 (E.D. Wis.). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys. A telephone status conference was held on August 30, 1990. Discovery began, with a closing date of November 1, 1990. A preliminary injunction hearing was scheduled for November 28, 1990.
- 17. U.S. v. Division Sales, Inc., Justen Products and Morton Marks, Civil Action No. 90-C-4837 (N.D. Ill.). On August 20, 1990 the government filed a complaint and motion for preliminary injunction against an importer of toys. A status hearing was held on September 7, 1990.
- 18. <u>U.S. v. Hanstai International, Inc. and James Ou</u>, Civil Action No. CV-90-4168 DWW (EX) (C.D. Cal.). On August 31, 1990 the government filed a complaint and motion for preliminary injunction against an importer of bicycles.

SEIZURE

United States v. 52,823 Children's Dolls, More or Less, Civil Action No. 89 Civ. 4643 (JFK) (S.D.N.Y.). On July 7, 1989, the government seized dolls that failed to comply with the CPSC's small parts regulation. Etna Worldwide Corp. and Etna Products Company, Inc. filed a claim for the dolls on July 21, 1989, and moved to quash the warrant of seizure and dismiss the case. Following a status conference on July 28, 1989, both sides filed briefs on issues raised by the motion. On November 13, 1989 the Court denied Etna's motion, (1) affirming the CPSC's authority to seize banned hazardous products under the Federal Hazardous Substances Act and Supplemental Rule C of the Federal Rules of Civil Procedure; (2) confirming that the small parts regulation is self-executing; (3) upholding CPSC's position that a manufacturer's label is not dispositive on whether the regulation applies; (4) agreeing with CPSC's position that an objective test applies to age determinations; and (5) refusing Etna's request for a

retraction of CPSC's press release, but finding that CPSC issued it improperly. On May 7, 1990 the Court entered a Consent Order and Default Judgment, ordering Etna to return the dolls to their foreign manufacturer.

CRIMINAL ACTION

The government presented to a grand jury information concerning possible violations of a CPSC statute. No details on this matter can be disclosed.

INSPECTION WARRANT

Matter of Establishment Inspection of Skil In the Corporation, Civil Action No. 86-M-263 (N.D. Ill.) and No. 88-1126 (7th Cir.). Upon CPSC's application, the U.S. Magistrate issued a warrant on November 14, 1986, pursuant to section 16 of the Consumer Product Safety Act, for inspection of books and records concerning Skil circular saws. The warrant was served on November 17, 1986, but Skil refused the CPSC access. The government filed a motion for an order to show cause why Skil should not be held in contempt. Skil filed an opposition and a motion to quash the warrant. Following a January 8, 1987 hearing, the Magistrate granted the government's motion and denied Skil's motion. The District Court affirmed the Magistrate, and then the Court of Appeals affirmed the District Court on May 13, 1988. The parties continued to disagree about the CPSC's right to certain documents that Skil claims are privileged. Skil filed a motion for a protective order on December 19, 1989. The government moved for contempt on January 30, 1990 and opposed Skil's motion on February 23, 1990. The Magistrate held status conferences on March 22, 1990 and July 11, 1990.

SUBPOENA ENFORCEMENT

United States v. Spa Products of America, Inc. and M. Richard Williamson, Civil Action No. 89-0080 (C.D. Cal.). Following a refused inspection, the CPSC issued to Spa Products a Special Order and Subpoena for Production of Documents. The firm failed to comply with the subpoena, and in January 1989 the government filed an action to enforce compliance. On March 27, 1989, the Court ordered Spa Products to comply with the subpoena. The firm was undergoing Chapter 11 reorganization, but complied with the subpoena on October 20, 1989.

FREEDOM OF INFORMATION

Reliance Electric Company and Challenger Electric Equipment Corporation v. CPSC, Civil Action No. CV-87-1478 (D.D.C.) and No. 89-5396 (C.A.D.C.). On May 29, 1987, the plaintiff firms filed a complaint and application for temporary restraining order, to enjoin the disclosure of information under section 6 of the Consumer Product Safety Act. After a June 2, 1987 hearing, the Court issued a TRO and ordered the parties to file cross-motions for summary judgment. Both parties did so in July 1987. On September 19, 1989, the Court ruled that the CPSC had followed the proper procedures and that most of the documents could be released. The firms noticed their appeal and, on September 26, 1989, the District Court stayed its order pending resolution of the appeal. The firms filed their appellate brief on August 20, 1990, and the government filed its appellate brief on September 19, 1990. Oral argument was scheduled for November 2, 1990.

OTHER CASES AGAINST THE COMMISSION

- Kathryn O'Brien v. Anne Graham, Civil Action No. 89-1860-JH 1. (D. Md.) and No. 90-3002 (4th Cir.). In March 1989, a former CPSC employee filed a complaint challenging the Merit Systems Protective Board and Equal Employment Opportunity Commission decisions which had upheld CPSC's termination of her employment. Originally filed in the of Columbia, the Court ordered the District transferred to Maryland on May 31, 1989. The government filed a motion for summary judgment on July 31, 1989, which the Court granted on September 21, 1989. On appeal, both parties filed "informal" briefs. On March 19, 1990 the Court of Appeals dismissed the appeal as untimely and on April 17, 1990 denied Ms. O'Brien's petition for rehearing.
- 2. B.J. Alan Company, Inc. v. Nicholas Brady, et al., Civil Action No. 1:89-CV-02069 (N.D. Ohio). On October 25, 1989 the firm challenged a U.S. Customs Service/CPSC seizure of fireworks. The government filed a motion to dismiss on January 12, 1990. The parties settled the case and it was dismissed in February 1990.
- 3. <u>Kellner's Fireworks, Inc. v. U.S. et al.</u>, Civil Action No. 90-176 Erie (W.D. Pa.). On July 27, 1990 a fireworks firm moved for a temporary restraining order against the obtaining of an inspection warrant. The Court dismissed the action following a hearing on July 31, 1990.

CIVIL PENALTY SETTLEMENT AGREEMENTS ACCEPTED BY THE COMMISSION

The following civil penalty agreements were accepted by the Commission in 1990:

- In the Matter of Ames Department Stores, Inc., CPSC Docket No. 90-C0004. Ames agreed to pay a civil penalty of \$12,000 in settlement of Commission staff allegations that the retailer offered for sale, sold, and distributed in commerce, banned lawn darts in violation of 15 U.S.C. {{ 2068(a)(2) and The Settlement also resolves staff allegations that Ames failed to report that its lawn darts failed to comply with a Consumer Product Safety Rule and thereby violated the reporting requirements of 15 U.S.C. { 2064(b). The staff alleged that an Ames store in Doylestown, Pennsylvania sold banned lawn darts to an undercover CPSC investigator more than three months after the product was banned. Ames denied that it distributed in commerce banned lawn darts and/or knowingly failed to make reports and provide required information concerning lawn darts, in violation of section 15(b) of the CPSA. The Commission accepted settlement agreement on February 7, 1990.
- In the Matter of Caldor, Inc., CPSC Docket No. C0005. Caldor agreed to pay a civil penalty of \$50,000 in settlement of Commission staff allegations that the Connecticut chain store offered for sale, sold, and distributed in commerce banned lawn darts in violation of 15 U.S.C. ({ 2068(a)(2) and (4). The settlement also resolves staff allegations that Caldor failed to report that its lawn darts failed to comply with a Consumer Product Safety Rule and thereby violated the reporting requirements of 15 U.S.C. { 2064(b). The staff alleged that three Caldor stores sold or offered for sale a total of 64 sets of banned lawn darts over three months after the effective date of the ban. Caldor denied that it distributed in commerce banned hazardous products and/or knowingly failed to make reports and provide information concerning lawn darts, in violation section 15(b) of the CPSA. The Commission accepted a settlement agreement on February 7, 1990.
- 3. In the Matter of Consumer Direct, Inc., CPSC Docket No. 88-C0009. Consumer Direct agreed to pay a civil penalty of \$130,000 in settlement of allegations by the Commission staff that the Ohio corporation failed to report defects in its "Gut Buster exercise device" which could create a substantial product hazard as required by 15 U.S.C. { 2064(b). The staff alleged that although Consumer Direct had received hundreds of consumer complaints alleging personal injury due to spring breakage of the Gut Buster, it failed to report that information to the Commission. The firm denied that the Gut Buster contained any

defect which could create a substantial product hazard within the meaning of section 15(b) of the CPSA. The firm also denied any obligation to report information to the Commission under section 15(b) of the CPSA. The Commission accepted a settlement agreement on April 25, 1990.

- In the Matter of Etna Products Co., Inc., CPSC Docket Etna agreed to pay a civil penalty of \$5,000 in No. 90-C0002. settlement of allegations by the Commission staff that the company failed to report defects in its electric mousetrap which could create a substantial product hazard as required under 15 U.S.C. { 2064(b). The staff alleged that Etna was aware of the product's electrocution potential, and recalled the mousetraps from Wisconsin consumers, but failed to report this information Etna denied that the imported electric mousetraps to the CPSC. contained a defect which could create a substantial risk of further denied that it violated the injury. Ιt reporting οf section 15(b) of the CPSA. The Commission accepted a settlement agreement on January 24, 1990.
- In the Matter of Hedstrom Corp., CPSC Docket No. 90-C0010. Hedstrom Corp. agreed to pay a civil penalty of \$165,000 in settlement of allegations by the Commission staff that the firm failed to report a defect which could create a substantial product hazard involving several models of its backyard gym sets equipped with the "Glide Ride" attachment, as required under 15 U.S.C. { 2064(b). The staff alleged that Hedstrom knew or should have known that the hanging bracket holding the Glide Ride to the contained cross bar of these gym sets а dangerous pinching/crushing point, that constituted a defect which could create a substantial product hazard, but failed to report it in a timely manner. Specifically, 10 children over a three year period sustained pinched, lacerated, or partially amputated tips before Hedstrom reported the problem to the Commission on April 27, 1988. Hedstrom denied that its products contained a defect which creates or which could create substantial product hazard under the CPSA. It further denied any obligation to report to the Commission under section 15(b) of the It alleged that its products did not have a design defect under the CPSA and that the incidents were caused by unusual circumstances or possibly through inappropriate use by the user. The Commission accepted the settlement on May 22, 1990.
- 6. In the Matter of K Mart Corp., CPSC Docket No. 90-C0003. K Mart agreed to pay a civil penalty of \$60,000 in settlement of allegations by the Commission staff that the firm failed to report a defect which could create a substantial product hazard involving its School Days Scissors Desk Sets, as required under 15 U.S.C. { 2064(b). The staff alleged that the firm knew or should have known that the scissors desk sets

contained a razor blade cutting knife component and that this defect could result in children sustaining severe lacerations. K Mart denied that its product contained a defect which creates or which could create substantial product hazard; and denied that it had an obligation to report information to the Commission under section 15(b) of the CPSA. The Commission accepted a settlement agreement on January 24, 1990.

- 7. In the Matter of Toys "R" Us, Inc., CPSC Docket No. 90-C0001. Toys "R" Us agreed to pay a civil penalty of \$60,000 in settlement of allegations by the Commission staff that the firm failed to report a defect which could create a substantial product hazard involving its submarine stationery sets, as required under 15 U.S.C. { 2064(b). The staff alleged that the firm knew or should have known that the toy stationery sets contained a razor blade cutting knife component and that this defect could result in children sustaining severe lacerations. Toys R Us denied that its product contained a defect which creates or which could create substantial product hazard; and denied that it had an obligation to report information to the Commission under section 15(b) of the CPSA. The Commission accepted a settlement agreement on January 24, 1990.
- In The Matter of Water Refining Company, Inc., CPSC Docket No. 90-C0012, Ecodyne Corporation, on behalf of subsidiary Water Refining Company, Inc., and Guthrie North America, Inc., the previous owner of Water Refining Company, Inc., agreed to pay a civil penalty of \$300,000 in settlement of the staff's allegations that Water Refining Company, Inc. and Guthrie North America, Inc. failed to report a defect which could create a substantial product hazard involving two models of softeners, as residential water required under 15 U.S.C. The defect was reported to the Commission by Ecodyne { 2064(b). more than one year after it learned of the defect. The staff alleged that electrical shorts can occur in the solenoid coils that are used to start and stop various operations within the The solenoids can fail unexpectedly and without warning. This defect may result in fire that can spread to surrounding combustibles. Although no personal injuries or deaths have been reported, the possibility exists that such a fire could result in serious personal injury or death to the occupant of the residence in which the water softener is located. Ecodyne and Guthrie denied that they knew or should have known of the defect and hazard associated with the solenoids, and any risk of injury allegedly presented by the water softeners, and denied the existence of any obligation to report any information regarding the water softeners to the Commission under 15 U.S.C. { 2064(b). The Commission accepted a settlement agreement on September 13, 1990.

CONSENT AGREEMENTS ACCEPTED BY THE COMMISSION

The following consent agreements were accepted by the Commission in 1990:

In the Matter of Sun Tui, LTD and Daniel S. Weiss, CPSC Docket No. 90-C0006. The Commission accepted a consent agreement containing a cease and desist order from Sun Tui and Weiss to settle the staff's allegations that the firm sold futon mattresses in violation of the Standard for the Flammability of Mattresses and Mattress Pads. The Commission accepted the agreement on February 22, 1990.

In the Matter of Contempo Futons, and David Butitta, CPSC Docket No. 90-C0007. The Commission accepted a consent agreement containing a cease and desist order from Contempo and Butitta to settle the staff's allegations that the firm sold futon mattresses in violation of the Standard for the Flammability of Mattresses and Mattress Pads. The Commission accepted the agreement on February 22, 1990.

In the Matter of Buddha's, Inc., and S. Trinity, CPSC Docket No. 90-C0008. The Commission accepted a consent agreement containing a cease and desist order from Buddha's and Trinity to settle the staff's allegations that the firm sold futon mattresses in violation of the Standard for the Flammability of Mattresses and Mattress Pads. The Commission accepted the agreement on February 15, 1990.
