Filing Instructions (Paper Copies)

1. Remove and discard the old 9 FAM 41.31 Notes (CT:VISA-1235; 06-25-2009, 32 pages) and insert the new 9 FAM 41.31 Notes (CT:VISA-1365; 10-29-2009, 32 pages).

Remove and discard the old 9 FAM 41.52 Notes (CT:VISA-661; 12-10-2004, 4 pages) and insert the new 9 FAM 41.52 Notes (CT:VISA-1365; 10-29-2009, 4 pages).

Remove and discard the old 9 FAM 42.52 Notes (CT:VISA-694; 02-09-2005, 4 pages) and insert the new 9 FAM 42.52 Notes (CT:VISA-1365; 10-29-2009, 4 pages).
2. After inserting the material in the binder, insert this change transmittal letter immediately following the CT Checklist, then fill in the entry line for CT:VISA-1365, and initial.
