<p>Stuffing shall be free from dangerous chemicals or hazardous substances Check for E Coli and Coliforms Certificate of disinfection required on second hand and animal origin stuffing</p>	<p>All stuffing materials must be new Certification of disinfection required for material of animal origin</p>	<p>All stuffing material must be new Material checked for bacteria contamination Content label required</p>	<p>Stuffing material must be free from harmful substances Certificate of disinfection required for all stuffing of animal origin.</p>
<p>Attached label or tag must contain name of manufacturer or vendor, plus statement indicating the kind of stuffing material used</p>	<p>Attached label or tag must contain content The stuffing must be all new materials The label must contain the name and address or the Massachusetts license number of the manufacturer or vendor</p>	<p>Attached label or tag must state that all new material is used, name and the address of the manufacture wholesaler or importer</p>	<p>Attached label or tag must state that all new or all new type material is used plus the registration number assigned to the manufacturer</p>
