Must have or be able to obtain a Top Secret Clearance.** Duties and Responsibilities: Advises the Chief, Combat Forces Branch, on all issues involving ANG fighter operations. This is an API-8 Flying position and preferred applicant will need to be a current and qualified as A-10, F-16, F-15 or F-22 pilot, A-10. Applicant will be the ANG's subject matter expert with regard to all A-10C, F-16C, F-15C, F-22A and F-35A mission areas. Manages CAF operations and training requirements, simulators, regulations and stan/eval for the all ANG Fighter/Attack aircraft. Should have extensive Fighter/Attack operational experience and be instructor pilot qualified. Desire a mature, experienced officer whose expertise and knowledge of operational flying is authoritatively accepted. Current or previous Flying Training Unit (FTU) instructor or Weapons Instructor Course (WIC) graduate desired. Required to make judgmental decisions regarding aircrew operational support requirements and must manage limited fighter assets (subsystems, upgrades, etc.) in a demanding and fiscally austere environment. Formulates policy on operations and training issues for NGB/A3. A3 Distributed Mission Operation (DMO) and Live Virtual Constructive (LVC) subject matter expert. Member of the A-10C, F-16C, F-15C, F-22A and LVC Integrated Process Team
