Headquarters ANG Title 10 2-4 years Statutory Tour at **NGB/A3 (Joint Base Andrews, MD)**. Must be Air Force Specialty Code (AFSC) **11F3/4**. **Must have or be able to obtain Top Secret SCI. API 8**. Duties and Responsibilities: Advises the Chief, Combat Forces Branch, on all issues involving ANG fighter operations. This is a flying position and applicant should be a current and qualified F-16, F-15 or F-22 pilot, F-16 preferred. Applicant will be the ANG's subject matter expert with regard to all F-16C, F-15C, F-22A and F-35A mission areas. Manages CAF operations and training requirements, simulators, regulations and Stan/Eval for the F-16C, F-15C, F-22A and F-35A. Should have extensive Fighter operational experience and be instructor pilot qualified. Requires a mature, experienced officer whose expertise and knowledge of operational flying is authoritatively accepted. Current or previous Flying Training Unit (FTU) instructor or Weapons Instructor Course (WIC) graduate desired. Required to make judgmental decisions regarding aircrew operational support requirements and should manage limited fighter assets (subsystems, upgrades, etc.) in a demanding and fiscally austere environment. Formulates policy on operations and training issues for NGB/A3. NGB/A3 Distributed Mission Operation (DMO) and Live Virtual Constructive (LVC) subject matter expert. Member of the F-16C, F-15C, F-22A and LVC Integrated Process Teams

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.
