#### **Scope and Content**

The materials in FOIA 2009-0442-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA case 2009-0442-F contains responsive photos from the White House Photograph Office. President Clinton attends the Martin Luther King/Robert F. Kennedy Peace Memorial Groundbreaking adjacent to Martin Luther King Memorial Park. The event is held in Indianapolis, Indiana. Participants at the event include: Governor Evan Bayh, Ethel Kennedy, Senator Edward "Ted" Kennedy, Prime Minister Albert Reynolds of Ireland, Martin Luther King III, Dexter King, and Diane Meyer Simon. President Clinton makes remarks at the event and the dignitaries break ground at the site for the proposed memorial.
