Scope and Content

The materials in 2009-0623-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2009-0623-F consists of records related to Secretary of State Madeline Albright's trip to Mongolia on May 2, 1998. Secretary Albright's trip to Mongolia was to affirm the United States' commitment to further cooperation between the two countries and show support for Mongolia's developing democracy and economic reforms.

Documents which may be responsive to this FOIA were found in the NSC Cable, Email, and Records Management Systems. The cables include background information from the American Embassy in Ulaanbaatar, Mongolia describing the recent history and status of Mongolian politics. The cables also include information relating to the arrangements made by State Department personnel concerning the Secretary's trip. The emails include remarks made by Secretary Albright to the Mongolian parliament and press releases of the joint statement by Secretary Albright and the Prime Minister of Mongolia,

Tsahiagiyn Elbegordi, on U.S. – Mongolian relations, and the text of a press conference held by Secretary Albright and Prime Minister Elbegdori.

System of Arrangement

Records that were responsive to this FOIA request were found in three collection areas - Clinton Presidential Records: Automated Records Management System (ARMS) Emails, Clinton Presidential Records: Tape Restoration Project (TRP) and Clinton Presidential Records: NSC Cable, Email, and Records Management Systems.
