Rapid Acquisition Fund (RAF): The RAF establishes a flexible means for the Joint Rapid Acquisition Cell (JRAC) to rapidly respond in the current year to the Joint Urgent Operational Needs (JUON) and Immediate Warfighter Needs (IWN) from Combatant Commanders (COCOM), as validated according to the Chairman, Joint Chiefs of Staff Instruction (CJCSI) 3470.01. The DepSecDef established the JRAC to address Joint solutions for immediate, rapidly changing, asymmetric, time-sensitive, global terrorism challenges. Established in 2004, the JRAC overcomes bureaucratic delays, responds to unforeseen urgent needs, and helps speed essential materiel solutions to the joint warfighter that will reduce the risk of casualties or mission failure. The JRAC oversees the JUON process of CJCSI 3470.01, facilitating among the COCOMs, the Joint Staff, the Services, and other agencies to resolve identified IWNs. The RAF provides resources for urgent and compelling requirements that will prevent mission failure and avoid unnecessary casualties for any of the COCOMs.

Joint Rapid Acquisition Cell (JRAC): Activities of OIF, OEF and the GWOT highlight the DoD's responsibility to ensure that bureaucracy, interagency coordination, and funding availability do not unreasonably delay critical solutions. The JRAC rapidly assesses requirements and solutions, collaborating with the Joint Staff J-8 and the respective COCOM, and facilitates the transfer of funds to DoD components to resolve IWNs. The COCOMs confront a dynamic, highly adaptive, and very intelligent enemy. By using the RAF, the JRAC provides the COCOMs the means to rapidly resolve shortfalls and capability gaps identified during ongoing operations. The FY09 President's Budget supports IWNs for all Combatant Commanders, globally. The JUON process draws upon the RAF, and supports the Department's response to urgent needs of the joint warfighter to avoid combat casualties and ensure mission effectiveness. FY 2007 Accomplishments: To date, the JRAC has delivered funding for numerous IWN solutions to the Warfighter, and executed some of the Department's highest priorities for winning the Global War on Terrorism, effectively strengthening Combined/Joint Warfighting capabilities. Specific initiatives funded from FY07 Budget Supplementals are detailed on the continuation sheet. See notes.

FY 2008 Funding: The absence of baseline funding severely inhibits rapid support to the joint warfighter, and limits the JRAC's ability to successfully resolve unanticipated threats to the COCOMs named operations. The Joint Warfighting Commands face emerging, unforeseen asymmetric threats on a global basis, with only a bureaucratic, time consuming course of action that requires the USD(C) to identify and reprogram funding, or submit and await approval of supplemental budget requests. Without timely funding, the JRAC is prevented from effectively addressing IWNs, which will likely lead to mission failures for Combatant Commanders, and increased risk of serious injuries and deaths for numbers of our military and coalition forces. Specifically, delays of seven to eight months resulted in 2007 and 2008, because the JRAC was unable to fund mission critical requests of Combined Joint Task Force, Horn of Africa, and US Southern Command. This delay could have been avoided, had the RAF been funded and available for COCOM operations beyond Iraq and Afghanistan. Additional remarks on the continuation sheet. See notes.

FY 2009 Requirements: The RAF will fund IWN requirements that are identified in the year of execution by the COCOMs involved in countering the threat of global terrorism and asymmetric threats to National Security. The IWNs are categorized according to the Joint Warfighting Functional Capability Areas, and typically address Force Protection, Battlespace Awareness, and Net Centric Operations/Joint Force Command & Control.

FY 2008: To date, the JRAC and the JUON process have no separate funding in FY08. The FY08 PB requested \$100 million for the RAF in the baseline budget, while the FY08 Amended GWOT Supplemental requested \$150 million. Neither request was supported, and no funding was made available for IWNs in the FY08 Iraq Freedom Fund. Reprogramming from other appropriations will be required in order to support the COCOM IWNs identified to the JRAC.

FY 2009 Requirements: The RAF will fund IWN requirements that are identified in the year of execution by the COCOMS. The JRAC gains DepSecDef approval for each IWN that uses RAF, and the OSD Comptroller provides The Congress a five-day notification prior to transfer of funds from the RAF to the appropriation and account that will be used to implement/execute the respective JUON/IWN. The functional breakout with amounts estimated are listed, below: - Battlespace Awareness - \$47.0M - Force Protection - \$22.0M - Net Centric Operations/Joint Force Command & Control - \$31.0M Total FY 2009 -- \$100.0M

FY 2010 and out: Approximately the same categorization of requirements are anticipated as in FY09, and are reflected in the P-5 exhibit.
