### **BIA-NIFC Welcomes Gini Broyles to the Administrative Management Specialist Position**

The Bureau of Indian Affairs Branch of Wildland Fire Management - NIFC is pleased to announce the selection of Gini Broyles as the new Administrative Management Specialist for BIA- NIFC.

“Gini has been an asset to our Budget staff for several years. Her valuable expertise is welcome as she will be a fine addition to our NIFC team,” said BIA Deputy Fire Director Bodie Shaw.



Gini is a member of the Nations Potawatomi Tribe in Shawnee, Oklahoma. She started her career with the National Park Service in 1973 as a Staff Assistant to the Grand Canyon South Rim Unit Manager. In 1976, she and husband Paul, moved to Point Reyes National Seashore in California where she worked as a Naturalist in Interpretation. Supporting two Park visitor centers, she provided public tours, developed brochures and issued backcountry permits. In 1978 she became the Secretary to the Park Superintendent at Mesa Verde National Park for a short time until she crossed into Fiscal Management to work with the Administrative Officer. Resigning for a short period to raise her two daughters, she resumed her career in administration in 1986 at Big Cypress National Preserve, Florida.

In 1988 the Broyles family moved to Boise, Idaho. Gini worked with the Engineering staff for the Bureau of Reclamation for three years and in 1991, she accepted a statistician position for the
