Dear Sir:

A problem has arisen since I started using your product, "PERFECT NAIL." I purchased your product from a local store in Cutler Ridge, Florida. The clerk recommended your product since I desired to harden my nails and keep them from splitting. "Perfect Nail" seemed to be improving my nails at first, but after a period of six months, my nails rapidly deteriorated. They lifted away from the matrix, and my nails broke off, and some were bent back. After encountering problems of this nature, I sought the help of a dermatologist, Bruce M. Esplin, M. D., 602 Huntington Medical Building, Miami, Florida 33131. Dr. Esplin identified the problem as Onycholysis, which in order to eradicate the problem, I must cut my nails to the base, which on many nails was almost gone. In my work as a legal secretary, filing became difficult and typing was painful because of the soreness that I encountered on the tips of my fingers. I also found difficulty in grasping and holding small things.

I must mention the fact that the nail's appearance were something DREADFUL, since they had to be cut down all the way to the matrix; and in most instances, I had almost none or very little nail left.
