1. Total persons assisted for recruiting services: This means the total number of people that came to the recruiting office inquiring about joining the Navy and who completed a Voter Registration Information (DD-2645) for the first time.
2. This figure includes any eligible citizen who came in only wanting to register to vote and those who came in for recruiting purposes.
3. Total of all registration applications forms submitted (eligible citizens and recruiting Prospects/Applicants)
4. Total of all DD-2645 forms completed by prospects themselves. This figure will normally match that in the first column unless some of the DD-2645's were completed by the Recruiter for records purposes.
5. For weekly statistics gathering purposes, put a piece of paper in the ballot box noting each time a person gets a registration application but takes it with them rather than completing and returning it to the Recruiter at that time. The respective states' instructions are located at the bottom of the voter registration application.
