Dear Ms. Hedges,

The Hanford Advisory Board (Board) extends its appreciation to the Washington State Department of Ecology (Ecology) for continuing the dialogue on the draft Hanford Site-wide Permit (Permit).

The Board requests an early review and comment opportunity on draft SEPA documents related to the draft Permit. The Board is interested in seeing these materials prior to the public review period for the draft Permit. This early review will enable the Board to provide meaningful feedback before a more finalized version of the draft Permit and associated SEPA documents go out for public review.

The Board is also concerned with Ecology's plan to submit a draft Permit before the draft Tank Closure and Waste Management Environmental Impact Statement (TC&WM EIS) is finalized. The Board believes it is be more logical to complete the draft TC&WM EIS first. Normally, a draft permit is accompanied by a draft EIS or other proposed SEPA/National Environmental Policy Act determinations in order for the public to review and comment on alternatives, potential impacts, and whether mitigating permit conditions will prevent impacts.

The Board would like advance review and comment opportunities on the following documents:

- The SEPA checklists for each unit.
- The Draft SEPA determinations for each unit.
- The Draft SEPA mitigating conditions.

By reviewing these documents early, the Board will be in a position to share comments with Ecology and advise Ecology as to whether and how the public will be able to understand potential impacts, alternatives, and effectiveness of mitigation. Sincerely,
