

The Office of Naval Research is sponsoring an Historically Black Colleges and Universities (HBCU) Future Engineering Faculty Fellowship Program. The program is designed to develop and attract qualified engineering faculty to HBCUs with engineering programs. Three recipients that have accepted engineering faculty positions at HBCUs are competitively selected for study and research support leading to doctoral degrees in engineering. Disciplines include the following:

- Aerospace engineering
- Electrical engineering
- Mechanical engineering
- Manufacturing science and engineering
- Civil engineering
- Ocean engineering
- Chemical engineering

Women, underrepresented minorities, and persons with disabilities are encouraged to apply to the program, however, eligibility is limited to citizens or nationals of the United States. This program is administered by North Carolina A&T

On 30 July 2003, McDonnell Douglas was awarded a contract valued at \$422,267.00 to develop a conceptual design for an aircraft suitable for the Airborne Laser (ABL) mission. This Cost plus fixed fee contract has a seven month base period and no options.

On November 17, 2003, Vista Technology Service, Inc. was awarded a contract, valued at \$228,788.64, to provide technical and functional support to the MDA Program Integration Directorate for the collection, storage and use of MDA data in support of analysis for BRAC 2005. The period of performance for this firm fixed price contract is from 17 November 2003 to 30 September 2004.

# Department of Defense News . . .

### **CCR Registration Now Mandatory**

Effective January 1, 2004, Central Contractor Registration (CCR) is a requirement for all federal contractors. The integration of the U.S. Small Business Administration's (SBA) PRO-NET system and the Department



of Defense's Central Contract Registration database has been created as one portal for entering and searching for small business sources. The CCR can be utilized by: (a) small businesses as a marketing tool for their goods and services; (b) large businesses to search for qualified small businesses both for subcontracting and partnering purposes and (c) by various federal government departments and agencies to solicit offers for contracts.

The new system has kept all of PRO-Net's search capabilities and functions and allows small businesses to only register once. All government procurement offices can use the system to conduct market research and confirm eligibility for SBA's procurement preference programs. Users can go to the CCR website at <a href="www.ccr.gov">www.ccr.gov</a> and click on the "Dynamic Small Business Search" button. ◆

# Legislation/Regulation Update



### **Defense Acquisition Regulations**

#### **Final Rule**

Electronic Submission and Processing of Payment Request (DFARS) Case 2002-D001)

Finalizes an interim rule published on February 21, 2003 (DFARS Change Notice 20030301), to implement statutory requirements for contractors to submit, and DOD to process, payment requests in electronic form. The final rule clarifies that scanned documents may be used to support electronic payment requests; and that the contract administration office will be involved in decisions to permit submission of payment requests in other than electronic form.

DEPARTMENT OF DEFENSE 48 CFR Parts 216 [DFARS Case 2001-D013]

Defense Federal Acquisition Regulation Supplement; Provisional Award Fee Payments

SUMMARY: DOD has issued a final rule amending the Defense Federal Acquisition Regulation Supplement (DFARS) to address the use

of Provisional award fee payments under cost-plus-awardfee contracts. The Rule provides for successfully performing contractors to receive a portion of award fees within an evaluation period prior to a final evaluation for that period.

DATES: Effective date: January 13, 2004.

### Payment Withholding (DFARS Case 2002-D017)

Provides administrative contracting officers additional flexibility when determining the need to withhold payments under time-and-materials and lab or-hour contracts. Clarifies that, normally, there should be no need to withhold payment for a contractor with a record of timely submittal of a release discharging the Government from all liabilities, obligations, and claims under a contract. Adds an alternate paragraph for use with the clause at FAR 52.232-7, Payments under Time-and-Materials and Labor-Hour Contracts, to implement this policy.

#### **Interim Rule**

FAC 2001-20, FAR Case 2003-022 (Interim Rule), Special Emergency Procurement Authority [Published in the Federal Register at 69 FR 8312, February 23, 2004]

The Civilian Agency Acquisition Council and the Defense Acquisition Regulations Council (Councils) have agreed on an interim rule amending the Federal Acquisition Regulation (FAR) to implement the special emergency procurement authorities of Section 1443 of the Services Acquisition Reform Act of 2003 (Title XIV of Public Law 108-136). The Councils will publish a final rule upon receipt and evaluation of comments received in response to this interim rule. •

### **MDA NEWS**

Over the years the Missile Defense Agency (MDA) has funded the development of various technologies which greatly contributed to the success of MDA programs as well as to our environment, our health and to protect against bio-terrorism. Many of these technologies are often adapted to commercial use that provides benefits to our society, the business owners and to our government. Listed below are three technologies that have contributed greatly to our quality of life.

IntraMicron, Inc. has developed an escape mask using microfibrous filter technology that traps toxins an irritants ranging from sarin and anthrax to pollen and dust mites. The mask is small and compact and can fit inside a shirt pocket. It offers a lower pressure drop to make breathing easier for the elderly or young children. The mask cost less than traditional masks and is available for use now.

MDA has also funded technology that has lead to the development of an x-ray imaging system that offers higher resolution and lower radiation dosages than existing systems. Nanocrystal Technology, Limited Partners, of Braircliff Manor, New York, has developed a prototype system for medical and dental x-ray imaging. This technology is expected to significantly enhance diagnostic value in areas such as digital mammography.

InTransTech, Inc. has developed a wildlife protection system that provides a warning to motorists when animals are approaching a roadway. The system can operate in the dark through fog, rain, and smoke. InTransTech, Inc. is a Canadian subsidiary of the Rainbow group. The company applies cutting edge technology to transportation safety.

The above are a few of the many cutting edge technologies that have been derived from funding by the MDA. Small businesses are at the forefront of developing technologies that are easily commercialized and adapted to everyday use. ◆

#### Small Firms Have Big Impact On High Tech

#### Small Firm Patents A Vital Element In Many Industries

WASHINGTON, D.C. – Small highly innovative firms have a big impact on many high tech industries, according to a report issued today by the Office of Advocacy. The report shows that large firms in the biotechnology, medical electronics, semiconductor, and telecommunications industries are citing patents by small firms in higher than expected numbers.

"Small firms are contributing to technological innovation at an incredible rate," said Thomas M. Sullivan, Chief Counsel for Advocacy. "Small firms are a vital element of new technology in many industries. This is particularly true in high tech areas that rely on young, innovative firms. As our report points out, small firms are making important contributions to America's world wide technological leadership."

Sullivan made the remarks at Calence, Inc. in Tempe, Arizona while addressing members of the Arizona Technology Council. Calence builds, manages, and optimizes customized, client-centric networks that meet an organization's specific business goals and requirements. The Arizona Technology Council represents over 30,000 employees across more than 400 of Arizona's leading technology companies.

The report, Small Firms and Technology: Acquisitions, Inventor Movement, and Technology Transfer written by CHI Research, also examines small firms contribution to the innovation process through acquisition by larger firms and the hiring of elite inventors. The report found that small firm contributions to technological innovations are best measured industry by industry. Their importance is not immediately apparent when all industries are considered, because small firms tend to be excluded from such key capital-

intensive industries as automotive, aerospace, and oil research.

The Office of Advocacy, the "small business watchdog" of the government, examines the role and status of small business in the economy and independently represents the views of small business to federal agencies, Congress, and the President. It is the source for small business statistics presented in user-friendly formats and it funds research into small business issues.

agencies to include eight years as Director of Customer Support for the White House Communications Agency. Mr. Bartol states, "TKC Communications is built on trust and hard work." TKC Communications is focused solely on providing the Federal Government and Department of Defense, the best possible service at the best possible price and takes pride in getting the job done."

TKC is contracted with the Missile Defense Agency to provide services on a multi-task contract to include the following:

- Provide a Sensitive Compartmented Information Facility (SCIF) with oversight and management to assure that the required secure infrastructure is provided uninterrupted and within MDA's specifications.
- 2) Accounting, Auditing, Testing and Training (AATT) – TKC is tasked to support the AATT expansion requiring MDA to incorporate an independent Certified Public Accounting firm composed of accountants, and support staff, and provide the necessary orientation, training and infrastructure support staff.
- 3) Foreign National Capabilities TKC provides foreign national support as well as oversight and management to assure the required infrastructure to meet U.S. Government obligations for providing a working environment for Foreign Nationals to integrate into the ballistic missile program.
- 4) BMD Information Resource Center support TKC provides an MDA Technical Information Research Library to include two sections: one section for unclassified use and another section for classified research with secure office space for individual or small discussion groups.
- 5) Secure Conference Room/Management Information Center (MIC) and VTC support TKC provides a Secure Conference Room for approximately 120 people, which can also serve as a Management Information Center.
- 6) Concession, hot food service and catering capability TKC provides these services in

- support of the MIC, VTC, Conference rooms at the Suffolk building.
- 7) Secure building perimeter grounds and parking area TKC provides security for the Suffolk Building meeting MDA security requirements.

TKC also provides support to the Department of Treasury, Department of Homeland Security, Department of Interior, and National Aeronautics and Space Administration.

TKC brings to the Information Technology and Telecommunications industry the technical strength, advantage contracting, and financial backing of its parent organization. NANA Regional Corporation's affiliated businesses employ more than 4000 technical and service professionals in more than 30 industries.
