

## New Social Innovation Fund Subgrantees Added Spring, 2012

*The Social Innovation Fund added 49 promising programs to its portfolio of selected community solutions in the spring of 2012. These programs were chosen by grantmaking organizations that receive funding directly from the Social Innovation Fund, match the federal funds on a dollar for dollar basis, and then make subgrants to effective nonprofits and local public agencies to expand their proven solutions. With their subgrant awards of at least \$100,000 per year for up to five years and their own dollar for dollar matching funds, these 49 programs will transform the lives of more people by attacking challenges in youth development, economic opportunity, and healthy futures.*

[The Corporation for Supportive Housing awarded grants to four subgrantees](#) working in California, Connecticut, and Michigan to address chronic homelessness among people with complex health needs. These programs provide supportive housing and health services to frequent users of public health systems to improve health and housing outcomes for these individuals and reduce their use of public health crisis systems. The total amount awarded to these four organizations in the first year is \$1.4 million.

Building upon a strong state movement for reform and with bipartisan support from Colorado's Governor, Lieutenant Governor and state legislature, these 11 grantees and the Mile High United Way are poised to introduce key transformations in Colorado's education system. The total amount awarded to these 11 organizations in the first year is over \$2.5 million.

[NCB Capital Impact awarded grants to 10 subgrantees](#) working in California, Florida, New Jersey, New York, Tennessee, Texas, Utah, Vermont, Washington, and the District of Columbia. Each will replicate “shared equity homeownership” (SEH) programs to address a troubling decline in nationwide homeownership rates among low-income families. SEH programs enable new homebuyers to partner with a government or nonprofit agency acting as a co-investor. In return, homebuyers agree to limit, or share, their equity appreciation to preserve affordability so that the initial public investment can ultimately serve far more families. The total amount awarded to these 10 organizations in the first year is \$1.3 million.
