1. Notification of Violation

The Chairman of the National Indian Gaming Commission (NIGC) hereby gives notice that the Fort Sill Apache Tribe of Oklahoma (Respondent or Tribe), located in Apache, Oklahoma, has violated the Indian Gaming Regulatory Act, 25 U.S.C. § 2719, by gaming on Indian lands ineligible for gaming at 20885 Frontage Road Southeast, Deming, New Mexico, otherwise known as "Akela Flats."

2. Authority

Under the Indian Gaming Regulatory Act (IGRA) and NIGC regulations, the Chairman of the NIGC (Chairman) may issue a Notice of Violation (NOV) to any person for violation of any provision of the IGRA, NIGC regulations, or any provision of a tribal gaming ordinance or resolution approved by the Chairman. 25 U.S.C. § 2713; 25 C.F.R. § 573.3.

3. Applicable Federal Laws and Regulations

- A. IGRA provides that a Tribe may engage in class II gaming only on Indian lands. 25 U.S.C. § 2710(b).

B. IGRA defines Indian lands to mean (A) all lands within the limits of any Indian reservation and (B) any lands title to which is either held in trust by the United States for the benefit of any Indian tribe or individual or held by any Indian tribe or individual subject to restriction by the United States against alienation and over which an Indian tribe exercised governmental power. 25 U.S.C. § 2703(4).

C. NIGC regulations defines Indian lands to mean (a) land within the limits of an Indian reservation; or (b) land over which an Indian tribe exercises governmental power and that is either (1) held in trust by the United States for the benefit of any Indian tribe or individual; or (2) held by an Indian tribe or individual subject to restriction by the United States against alienation. 25 C.F.R. § 502.12.

D. IGRA further provides in 25 U.S.C. § 2719:

(a) that gaming shall not be conducted on lands acquired by the Secretary in trust for the benefit of an Indian tribe after October 17, 1988 unless --

(1) such lands are located within or contiguous to the boundaries of the reservation of the Indian tribe on October 17, 1988; or

(2) the Indian tribe has no reservation on October 17, 1988, and

(A) such lands are located in Oklahoma and

(i) are within the boundaries of the Indian tribe's former reservation, as defined by the Secretary, or

(ii) are contiguous to other land held in trust or restricted status by the United States for the Indian tribe in Oklahoma; or

(B) such lands are located in a State other than Oklahoma and are within the Indian tribe's last recognized reservation within the State or States within which such Indian tribe is presently located.

(b) Exceptions

(1) Subsection (a) of this section will not apply when --

(A) . . .

(B) lands are taken into trust as part of --

- (i) a settlement of a land claim,
- (ii) the initial reservation of an Indian tribe acknowledged by the Secretary under the Federal acknowledgement process, or
- (iii) the restoration of lands for an Indian tribe that is restored to Federal recognition. . . .

C. Under 25 C.F.R. § 292.7, gaming may occur on newly acquired lands under the “restored lands” exception only when all of the following conditions are met:

- (a) The tribe at one time was federally recognized, as evidenced by meeting the criteria in § 292.8;
- (b) The Tribe at some later time lost its government-to-government relationship by one of the means specified in § 292.9;
- (c) At a time after the tribe lost its government-to-government relationship, the tribe was restored to Federal recognition by one of the means specified in § 292.10; and
- (d) The newly acquired lands meet the criteria of “restored lands” in § 292.11.

D. For a tribe to qualify as having lost its government-to-government relationship under 25 C.F.R. § 292.9, it must show that its government-to-government relationship was terminated by one of the following means:

- (a) Legislative termination;
- (b) Consistent historical written documentation from the Federal Government effectively stating that it no longer recognized a government-to-government relationship with the tribe or its members or taking action to end the government-to-government relationship; or
- (c) Congressional restoration legislation that recognizes the existence of the previous government-to-government relationship.

4. Role of Prohibition against Gaming on Land Acquired after October 17, 1988

IGRA explicitly limits the trust lands where Indian gaming can be conducted to trust lands acquired before October 17, 1988 and, in limited circumstances, upon trust lands acquired after that date as set forth in 25 U.S.C. § 2719. There is no legislative history regarding § 2719. However, it is apparent from the statutory scheme that Congress intended to limit the expansion of Indian gaming on trust land acquired after October 17, 1988.

5. Circumstances of the Violation

- A. Respondent is a federally recognized Indian Tribe with tribal headquarters in Apache, Oklahoma.
- B. On June 26, 2002, the parcel known as Akela Flats located in Deming, New Mexico was acquired into trust by the United States on behalf of the Fort Sill Apache Tribe.
- C. On May 19, 2008, the NIGC Office of General Counsel issued an advisory legal opinion that considered whether the Tribe could lawfully game under IGRA on Akela Flats. Because the land is held in trust for the benefit of the Tribe by the United States, it qualifies as “Indian lands” under IGRA, 25 U.S.C. § 2703(4)(B). However, the Tribe acquired the land into trust after October 17, 1988. Therefore, the advisory legal opinion considered whether Akela Flats was eligible for gaming under the after acquired trust land prohibition of IGRA, 25 U.S.C. § 2719.
- D. The May 19, 2008 advisory legal opinion concluded that the Tribe did not meet any of the exceptions to the general prohibition of gaming on after acquired trust land or as the Tribe’s last recognized reservation within the State that it is presently located. Therefore, the NIGC Office of General Counsel concluded that the Tribe could not lawfully game under IGRA on Akela Flats.
- E. On April 30, 2009, the Office of General Counsel issued an addendum to the May 19, 2008 advisory legal opinion. This legal opinion supplements the Office of General Counsel’s May 19, 2008 legal opinion and considers a new argument made by the Tribe after the Office of General Counsel issued its May 19, 2008 legal advisory opinion. Specifically, the Tribe contends that it should be considered a restored tribe pursuant to the restored lands exception, 25 U.S.C. § 2719(b)(1)(B)(iii) and 25 C.F.R. § 292.7, because the United States once maintained a government-to-government relationship with the Chirachua and the Warn Springs Apache Tribes, of which the Fort Sill Apache Tribe is the successor of interest, and the United States no longer recognize the Chirachua and the Warn Springs Apache Tribes was a Federally recognized Tribe.

Therefore, the Tribe contends that its government-to-government relationship was terminated as required by 25 C.F.R. § 292.9.

- F. The OGC legal advisory addendum concluded that the Tribe had not demonstrated historical written documentation from the Federal government effectively stating that it no longer recognizes a government-to-government relationship with the Fort Sill Apache Tribe or its members or taking action to end the government-to-government relationship. Therefore, the opinion concluded that the Tribe failed to produce the necessary documentation to support a claim that its government-to-government relationship was terminated as required by 25 C.F.R. § 292.9(b).
- G. Nor did the Tribe establish government-to-government termination by legislative termination or Congressional restoration legislation that recognizes the existence of the previous government-to-government relationship, as required by 25 C.F.R. § 292.9 (a) and (c).
- H. Because the Tribe cannot establish that its government-to-government relationship was terminated, it does not meet the requirements of the restored lands exception defined in 25 C.F.R. § 292.7. As a consequence, the Akela Flats site, although Indian lands, remains ineligible for gaming under IGRA.
- I. Today, I adopt the Office of General Counsel's reasoning and conclusions set forth in its advisory legal opinions, dated May 19, 2008 and April 30, 2009.
- J. As a consequence, the Akela Flats parcel, although Indian lands, is ineligible for gaming under IGRA because it fails to satisfy any exception to the prohibition on gaming on after acquired trust lands.
- K. On or about April 9, 2009, the Tribe opened its gaming facility, Apache Homeland Casino, at Akela Flats.
- L. The Tribe operated its gaming facility, Apache Homeland Casino, during April 2009, undertaking the play of Class II gaming at the gaming facility. Specifically, on April 16, 2009, at approximately 6:15 pm, sixty-five (65) people engaged in a game of bingo at the Apache Homeland Casino and received monetary prizes for winning eight (8) different bingo games.
- M. As of July 16, 2009, the Tribe was continuing to conduct class II gaming at the Apache Homeland Casino located on the Akela Flats parcel.
- N. By conducting Indian gaming on Indian lands ineligible for gaming, the Tribe is in violation of IGRA, 25 U.S.C. § 2719.

6. Measures Required to Correct the Violation

There is no way for the Tribe to cure any past action of gaming on lands ineligible for gaming under IGRA. To correct the on-going violation, the Tribe must immediately cease all gaming operations at Akela Flats.

7. Appeal


Within thirty (30) days after service of this Notice of Violation, Respondent may appeal to the full Commission under 25 C.F.R. Part 577 by submitting a notice of appeal, and, if desired, request for hearing to the National Indian Gaming Commission, 1441 L Street NW, Ninth Floor, Washington, DC 20005. Respondent has a right to assistance of counsel in such an appeal. A notice of appeal must reference this Notice of Violation.

Within ten (10) days after filing a notice of appeal, Respondent must file with the Commission a supplemental statement that states with particularity the relief desired and the grounds therefore and that includes, when available, supporting evidence in the form of affidavits. If Respondent wishes to present oral testimony or witnesses at the hearing, Respondent must include a request to do so with the supplemental statement. The request to present oral testimony or witnesses must specify the names of proposed witnesses and the general nature of their expected testimony, whether a closed hearing is requested and why. Respondent may waive its right to an oral hearing and instead elect to have the matter determined by the Commission solely on the basis of written submissions.

8. Fine-Submission of Information

The violation cited above may result in the assessment of a civil fine against Respondent in an amount not to exceed \$25,000 per violation per day. Under 25 C.F.R. § 575.5(a), Respondent may submit written information about the violation to the Chairman within fifteen (15) days after service of this notice of violation (or such longer period as the Chairman may grant for good cause). The Chairman shall consider any information submitted in determining the facts surrounding the violation and the amount of the civil fine, if any.



## MEMORANDUM

**To:** Philip N. Hogen, Chairman

**Re:** The Merits of the Fort Sill Apache Tribe's New Argument  
**Date:** April 30, 2009

### Introduction

This opinion supplements the Office of General Counsel's May 19, 2008 opinion and considers the Fort Sill Apache Tribe's (Tribe) new argument that its settlement agreement (Agreement) establishes that the Tribe's government-to-government relationship was terminated as required by 25 C.F.R. § 292.9.

On March 10, 2008, the Tribe submitted a site-specific amended gaming ordinance for the Chairman's consideration. On May 19, 2008, the Tribe withdrew its gaming ordinance from the Chairman's consideration. The Office of General Counsel, however, issued an advisory legal opinion that concluded the site was Indian lands, but not eligible for gaming under IGRA. *See* Memorandum from Penny J. Coleman, Acting General Counsel, NIGC, to Philip N. Hogen, Chairman, NIGC (May 19, 2008). In reaching this decision, the Office of General Counsel reviewed all documents that the Tribe presented and found insufficient evidence to support, among other things, the Tribe's restored lands claim.

However, on September 26, 2008, the Tribe filed a brief containing a new argument to support its claim of restored lands with the U.S. District Court for the Western District of Oklahoma. *See* Brief for Defendant, *Comanche Nation v. United States*, Reply to Opposition to Motion for Enforcement of Agreement of Compromise and Settlement, (W.D. OK 2008) (No. CIV 05-328-F). In 2005, the Comanche Nation sued the United States over a parcel of Comanche land that the United States had put in trust for the Fort Sill Apache Tribe.<sup>1</sup> The Fort Sill Apache Tribe intervened in the

<sup>1</sup> On April 2, 1999, the Fort Sill Apache acquired into trust a .53 acre parcel of land that was located in lands of the former Kiowa, Comanche and Apache Reservation in Oklahoma. *Comanche Nation v. United States*, Agreement of Compromise and Settlement Recitals (Agreement), CIV-05-328-F at 1. The Department of Interior approved the trust acquisition without acquiring the written consent of the Comanche Nation. *Id.* The Comanche Nation sought a declaration voiding the trust transfer. *Id.* The parties entered into the Agreement to settle the matter.



litigation. In 2007, the suit was resolved by a settlement agreement. In its September 26, 2008 brief, the Fort Sill Apache Tribe asserted that the advisory legal opinion of the NIGC Office of General Counsel breached its Agreement with the United States by failing to acknowledge the Tribe's restored tribal status allegedly set forth in the Agreement. *Id.* Specifically, the Tribe cited paragraph 7(i) of the Agreement for the proposition that the United States acknowledged that it terminated the federal recognition of the Chiricahua and/or Warm Springs Apache Tribes, to which the Fort Sill Apache Tribe is the successor in interest. As a consequence, the Tribe argued that the advisory legal opinion of the Office of General Counsel was incorrect because it failed to acknowledge the termination of its federal recognition and, thus, the Fort Sill Apache Tribe's restored status. *Id.* at 2.

The Office of General Counsel now considers the Tribe's new argument in light of the presented evidence. This memorandum supplements our May 19, 2008 opinion. We conclude that the Tribe has failed to provide additional evidence, and the presented evidence remains insufficient to support its claim that it is a restored tribe.<sup>2</sup>

### **Legal Background**

The United States Department of the Interior (DOI) issued regulations interpreting the restored lands exception of the Indian Gaming Regulatory Act, 25 U.S.C. § 2719. Those regulations specifically address the standards to demonstrate the termination of the government-to-government relationship. *See* 25 C.F.R. part 292; 73 Fed. Reg. 29,354. These regulations became effective on August 25, 2008. *See* 73 Fed. Reg. 35579 (June 24, 2008). The Commission subsequently adopted the regulations. Accordingly, the regulations are applied to this case for the limited purpose of determining whether the Tribe's government-to-government relationship with the United States was terminated.

We note that the Tribe advised us that it did not believe that the new regulations should be used in this analysis. *See* Letter from Jeff Houser, Tribal Chairman, Fort Sill Apache Tribe, to Jo-Ann Shyloski, Associate General Counsel – Litigation and Enforcement, and Esther Dittler, Staff Attorney, National Indian Gaming Commission. We understand and appreciate that concern. The regulations were not intended to disrupt tribal gaming operations that were developed in reliance on the existing caselaw and earlier opinions that were issued. Consequently, we are focusing our analysis on the one and only argument presented by the Tribe and its impact on the Tribe's ability to game on the New Mexico site. We believe that this approach is appropriate because the regulations and the caselaw do not essentially establish different standards for concluding that a tribe had a period of time that it did not have a government-to-government relationship with the federal government. In other words, as described below, the regulatory standard for

<sup>2</sup> The Fort Sill Apache Tribe asserts that it was "formally recognized by the Federal government in 1976." *See* Memorandum in Support of Fort Sill Apache Tribal Gaming Commission Luna County, New Mexico Gaming License, 16 (Feb. 22, 2008). As the Tribe may have been recognized after 1934, we understand that the trust status of the Akela Flats property might be impacted by the recent decision in *Carcieri v. Salazar*, 129 S. Ct. 1058 (Feb. 24, 2009). However, we need not address this matter as we conclude that the Tribe may not game on the Akela Flats property.

the tribe having “lost its government to government relationship,” 25 C.F.R. § 292.9, is not significantly different from the requirement in caselaw that there was a termination of federal recognition.

Under the regulations, a tribe seeking to establish itself as a restored tribe must, among other things, demonstrate that “[t]he tribe at one time was federally recognized” and “[t]he tribe at some later time lost its government-to-government relationship by one of the means specified in § 292.9 . . .” 25 C.F.R. § 292.7. For a tribe to qualify as having lost its government-to-government relationship under 25 C.F.R. § 292.7, it must show that its government-to-government relationship was terminated by one of the following means:

- (a) Legislative termination;
- (b) Consistent historical written documentation from the Federal Government effectively stating that it no longer recognized a government-to-government relationship with the tribe or its members or taking action to end the government-to-government relationship; or
- (c) Congressional restoration legislation that recognizes the existence of the previous government-to-government relationship.

25 C.F.R. § 292.9.

Section 292.7 of DOI’s regulations capture the elements outlined by courts for determining whether a tribe has demonstrated that the federal government terminated its federal recognition and whether such recognition has been restored. For example, the U.S. District Court for the Western District of Michigan stated:

In order to determine whether the Band meets the restoration exception under [25 U.S.C.] § 2710(b)(1)(B)(iii), the court must first determine whether the Band is a “restored” tribe within the meaning of the provision, and second, whether the land was taken into trust as part of a “restoration” of lands to such restored tribe.

*Grand Traverse Band of Ottawa and Chippewa Indians v. Office of the United States Attorney for the Western District of Michigan*, 198 F. Supp.2d 920, 927 (W.D. MI 2002). For a tribe to establish that it is a restored tribe, it must establish: 1) federal government recognition; 2) withdrawal of recognition; and 3) restoration of recognition. *See Grand Traverse Band of Ottawa and Chippewa Indians v. Office of the U.S. Attorney for the W. Dist. of Mich.*, 369 F.3d 960, 967 (6th Cir. 2004).

The Section 20 regulations build upon the caselaw. As mentioned above, 25 C.F.R. § 292.9 specifies how a tribe qualifies as having its government-to-government relationship terminated. Because the Tribe does not contend the termination of its

government-to-government relationship was evidenced by legislative termination or Congressional restoration legislation, we can focus on section 292.9(b) which requires consistent historical written documentation from the federal government effectively stating that it no longer recognizes a government-to-government relationship with the tribe or its members or taking action to end the government-to-government relationship.

#### ANALYSIS

We conclude that the Tribe has not provided consistent historical written documentation effectively stating that the federal government no longer recognized a government-to-government relationship with the Tribe or its members or taking action to end the government-to-government relationship.

**1. Paragraph 7(i) of the Agreement and the Tribe's history do not evidence that the Tribe's government-to-government relationship was terminated and fails to support the Tribe's claim that it is a restored tribe**

In this instance, the Tribe argues that it has met its burden to show that it is a restored tribe and relies on two pieces of evidence. On January 9, 2007, the Fort Sill Apache and the Comanche Nation entered into a settlement agreement with the United States concerning the federal government's transfer of Comanche trust land for the benefit of the Fort Sill Apache Tribe. *Comanche Nation, Agreement of Compromise and Settlement Recitals*, CIV-05-328-F at 1-2. The Agreement states:

- g) The Fort Sill Apache Tribe is a successor-in-interest to the Chiricahua and Warm Springs Apache Tribes whose aboriginal territory, as defined by the Indian Claims Commission and as affirmed by the United States Court of Claims, includes those parts of Arizona and New Mexico where the United States currently holds land in trust for the benefit of the Fort Sill Apache Tribe. See Fort Sill Apache Tribe v. United States, 19 Ind. Cl. Comm. 212 (1968); Fort Sill Apache Tribe v. United States, 477 F.2d 1360, 201 Ct.Cl. 630 (1973), cert. denied, 416 U.S. 933 (1974).
- h) The United States once maintained a government-to-government relationship with the Chiricahua and Warm Springs Apache Tribes, as evidenced by treaties, negotiations with tribal leaders, provision of services to the tribes and tribal members, and other government-to-government relationships clearly identified in numerous legal actions maintained before the Indian Claims Commission, United States Court of Claims, United States District Courts, and the United States Department of Interior Board of Indian Appeals. See e.g., Fort Sill Apache Tribe v. United States, supra, 19 Ind. Cl. Comm. at 212.

- i) The United States does not acknowledge and/or recognize the Chiricahua and/or Warm Springs Apache Tribes as “Federally Recognized Tribes”, or as entities “acknowledged to have the immunities and privileges available to other federally acknowledged Indian tribes by virtue of their government-to-government relationship with the United States as well as the responsibilities, powers, limitations and obligations of such tribes.” 70 Fed. Reg. 71194 at 1 (Nov. 25, 2005).
- j) On or about August 16, 1976, the Commissioner of Indian Affairs formally approved the Constitution of the Fort Sill Apache Tribe, and thereafter the United States acknowledged the Fort Sill Apache Tribe to be a Federally Recognized Tribe, and has maintained a government-to-government relationship with the Fort Sill Apache Tribe since that date. See 70 Fed. Reg. 71194.

*Id.* at 7(g) - (j).

The Agreement acknowledges that the Tribe is a successor in interest to the Chiricahua and Warm Springs Apache Tribes who once maintained a government-to-government relationship with the United States and this satisfies the first requirement of the restored lands exception. 25 C.F.R § 292.7(a). As we stated in our May 19, 2008 opinion, these stipulations support the view that the Tribe was once recognized as the Chiricahua and Warm Springs Apache Tribes and that the Chiricahua and Warm Springs Apache Tribes were subsequently recognized as the Fort Sill Apache Tribe.

The Tribe argues that the Agreement shows that the federal government has already acknowledged its restored status. Specifically, the Tribe focuses on the language of paragraph 7(i) as evidence that the federal government acknowledges its status as a successor in interest to tribes once terminated and its status as a restored tribe. *See* Brief for Defendant at 2.

Further, the Tribe also relies on the history presented to the Federal Court of Claims to support its argument that the federal government terminated the federal recognition from its ancestors, the Chiricahua and Warm Springs Apache, to whom it is a successor in interest. The history presented in the Federal Court of Claims is already set forth in the General Counsel’s May 19, 2008 advisory legal opinion. Simply put, the Tribe argues that the Federal Court of Claims acknowledged the termination of federal recognition of the Chiricahua and Warm Springs Apache tribes when it noted that the Chiricahua and Warm Springs Apache were taken as prisoners of war. *Fort Sill Apache Tribe v. United States*, 19 Ind. Cl. Comm. 212, 244-5 (June 28, 1968).

Based upon these two pieces of evidence, and its new argument, the Fort Sill Apache Tribe argues that the General Counsel’s May 19, 2008 advisory legal opinion is incorrect. Upon closer review of the Agreement, we do not agree. These pieces of



evidence remain insufficient to support the Tribe's claim, and the advisory legal opinion's reasoning with this addition remains sound.

As stated in the advisory legal opinion, the Tribe's evidence from the Federal Court of Claims case remains insufficient to support its claim that its government-to-government relationship was terminated. The evidence is insufficient because taking Chiricahua and Warm Springs Apache members as prisoners of war in 1886 did not necessarily constitute the federal government's termination of the Chiricahua and Warm Springs Apaches' federal recognition and a cessation of the government-to-government relationship. In fact, the United States military force's decision to take the Chiricahuas as prisoners of war indicates that the Tribe was still considered a hostile but separate and sovereign entity. Because this history fails to indicate or acknowledge any type of loss of federal recognition, it does not support the Tribe's assertion that the federal government terminated the federal recognition of the Chiricahua and Warm Springs Apache tribes.

Nor does the Tribe's Agreement with the United States and the Comanche Nation constitute consistent historical written documentation from the federal government effectively stating that it no longer recognized a government-to-government relationship with the Chiricahua and Warm Springs Apache tribes or its members or taking action to end the government-to-government relationship. The Agreement provides

The United States does not acknowledge and/or recognize the Chiricahua and/or Warm Springs Apache Tribes as "Federally Recognized Tribes", or as entities "acknowledged to have the immunities and privileges available to other federally acknowledged Indian tribes by virtue of their government-to-government relationship with the United States as well as the responsibilities, powers, limitations and obligations of such tribes."

*Comanche Nation*, Agreement of Compromise and Settlement Recitals, CIV-05-328-F at 7(i). While the language of the Agreement acknowledges that the United States does not recognize the Chiricahua and Warm Springs Apache Tribes, this document states the facts as they were on the date the Agreement was entered into. It reflects that the successor tribe, the Fort Sill Apache Tribe is a Federally recognized tribe. In other words, the fact that the Chiricahua or Warm Springs are not presently recognized is not evidence that the federal government terminated the government-to-government relationship within the meaning of 25 C.F.R. § 292.9. It merely evidences that in the present day the Chiricahua and Warm Springs Apache are no longer recognized<sup>3</sup> and does not explain

<sup>3</sup> This interpretation is consistent with the U.S. District Court for the Western District of Oklahoma's Order denying the Tribe's motion for Enforcement of Agreement of Compromise and Settlement. The U.S. District Court noted that ". . . it was made abundantly clear to the court that the Chiricahua Tribe and the Warm Springs Apache Tribe are not federally recognized Indian tribes. No such status, with respect to those tribes, has been confirmed by publication in the Federal Register, nor has any such status been memorialized in any list of federally recognized tribes maintained by or at the direction of the Secretary of the Interior or any subordinate official in the Department of the Interior." See *Comanche Nation v. United States* No. CIV 05-328-F (W.D. Okla. Oct. 7, 2008) (order denying motion for Enforcement of Agreement of Compromise and Settlement). why or how its successor, the Fort Sill Apache Tribe, took its place or how or if its successor in interest's recognition or government-to-government relationship was terminated. Because the Tribe has not demonstrated that its government-to-government relationship was terminated, it does not meet the requirements for the restored lands exception under 25 C.F.R. § 292.7.

This analysis is consistent with previous NIGC legal opinions. As explained below, the statute and regulations require evidence of action on the part of the federal government ending or terminating federal recognition. A tribe's attempt to prove the termination of federal recognition has always required greater evidence than the Fort Sill Apache Tribe provided in this case.

For example, the Cowlitz Indian Tribe presented numerous records from the federal government where the government explicitly denied its federal recognition of the Tribe. *See* Memorandum to Philip N. Hogen, Chairman from Penny J. Coleman, Acting General Counsel, Re: Cowlitz Tribe Restored Lands Opinion at 8-9 (Nov. 22, 2005). The Bureau of Indian Affairs refused to discuss enrollment in the Cowlitz Tribe with an individual on the grounds that they did not recognize the Tribe. *Id.* Further, the Department of the Interior represented to Congress that the Cowlitz Tribe was no longer federally recognized. These acts and other documentation represents consistent written documentation from the federal government stating that it no longer recognized a government-to-government relationship with the Tribe or its members, and constitutes action to end the government-to-government relationship.

In contrast, the Karuk Tribe of California presented no evidence of the federal government's termination of recognition to support its restored tribe claim. *See* Letter to Bradley G. Beldsoe Downes, Esq., Dorsey & Whitney LLP from Penny J. Coleman, Acting General Counsel (Oct. 12, 2004). While the federal government appeared to have no dealings with the Tribe for a time, individual members still received benefits from the federal government. *Id.* at 3. Because the Tribe presented no evidence of action by the federal government to terminate recognition, the Office of General Counsel concluded that the Tribe was not restored. *Id.*

In the present matter, the evidence presented by the Fort Sill Apache Tribe is more analogous to the evidence presented by the Karuk Tribe than the Cowlitz Indian Tribe. In support of its claim as a restored tribe, the Cowlitz Indian Tribe presented evidence of an explicit denial of the Tribe. The Karuk Tribe, on the other hand, failed to provide any proof of a termination of recognition. *See* Letter to Bradley Bledsoe Downes from Penny J. Coleman, Acting General Counsel (Oct. 12, 2004). The lack of evidence to support its claim led the Office of General Counsel to find that it was not a restored tribe. *Id.*

---

Department of the Interior, or any subordinate officer or agency thereof." *Id.* Thus, the U.S. District Court's Order is only evidence of the fact that the United States does not recognize the Chiricahua and Warm Springs Apache Tribes, not evidence of the United States' action to end the government-to-government relationship.

The lack of sufficient evidence presented here leads to the same result. In presenting its case for restoration, the Fort Sill Apache Tribe failed to provide evidence of consistent historical written documentation from the federal government effectively stating that it no longer recognized a government-to-government relationship with the Chiricahua and Warm Springs Apache tribes or its members or taking action to end the government-to-government relationship. Without such evidence to support its claim, the Tribe fails to meet the requirements of the restored lands exception.

### **Conclusion**

The Tribe presented a new argument with the same evidence, challenging the General Counsel's May 19, 2008 advisory legal opinion as incorrect. The Tribe's argument, however, fails to change the previous analysis undertaken by the Office of General Counsel. The Tribe presented no additional evidence to support its claim as a restored tribe. Because the Agreement does not constitute historical written documentation from the federal government effectively stating that it no longer recognizes a government-to-government relationship with the Fort Sill Apache Tribe or its members or take action to end the government-to-government relationship, it cannot support the Tribe's claim that its government-to-government relationship was terminated as required by 25 C.F.R. § 292.9(b). Because the Tribe cannot establish that its government-to-government relationship was terminated, it does not meet the requirements of the restored lands exception. 25 C.F.R. § 292.7. As a consequence, the Akela Flats site, although Indian lands, remains ineligible for gaming under IGRA.

### Introduction

Chairman Houser informed the General Counsel at a meeting in Scottsdale, Arizona, on January 16, 2008, that the Ft. Sill Apache Tribe (Tribe) planned to open a new Class II gaming operation on trust lands, known as Akela Flats, in Luna County, New Mexico. Chairman Houser expressed concern about the potential applicability of new National Indian Gaming Commission (NIGC) facility license regulations which were scheduled to become effective on March 3, 2008. The regulations require a tribe to notify the NIGC 120 days in advance of its plans to license a new facility. Although I assured the Tribe that the NIGC would work with the Tribe to diminish any adverse consequences of the 120 day rule, the Tribe apparently attempted to open its gaming facility at Akela Flats on February 28, 2008. It did not do so however.

On March 10, 2008, the Tribe submitted an amended gaming ordinance for the Chairman's consideration. The amended gaming ordinance is site specific and the Tribe's goal in submitting the amendment is to attain final agency action. As a result, the Office of General Counsel has worked with all due diligence to review the Tribe's claims that it is entitled to operate gaming on its New Mexico property pursuant to the Indian Gaming Regulatory Act (IGRA). As detailed below, we conclude that the NM property does not qualify for gaming under IGRA.

On February 22, 2008, the Fort Sill Apache Tribe (Tribe) submitted its analysis that the Tribe's trust land located in Luna County, New Mexico, is Indian lands upon which it may lawfully game pursuant to IGRA, 25 U.S.C. § 2701 *et seq.* Specifically, the Tribe asserted that the land satisfies the "last recognized reservation" exception, 25 U.S.C. § 2719(a)(2)(B), and the "restored lands" exception, 25 U.S.C. § 2719(b)(1)(B)(iii). In

addition, the Tribe indicated that it also wishes to claim the "initial reservation" exception.<sup>1</sup> 25 U.S.C. § 2719(b)(1)(B)(ii).

### The Land Acquisition

On October 23, 1998, the Tribe acquired approximately thirty (30) acres of land in fee, in Luna County, New Mexico. The legal description of the land known as Akela Flats follows:

That part of the North half (NH) of Section Eleven (11), lying North of the Interstate 10 right-of-way, Township Twenty-four (24) south, Range Six (6) west, N.M.P.M., Luna County, New Mexico, being described as follows: Beginning at a spike in the center of an abandoned asphalt roadway at the Northeast corner of said Section Eleven (11) and Northeast corner of this tract; Thence S0°21'53"W., along the east line of Section Eleven (11), a distance of 500.76 feet to a no. 5 steel rod at the Southeast corner of this tract and on the North boundary of the Interstate 10 right-of-way; Thence adjoining the North boundary of said I-10 right-of-way through the following courses and distances; along a curve to the left from a tangent which bears N.89°56'18"W., having a radius of 789.30 feet, a delta angle of 32°47'40", a cord which bears S.73°39'52"W., 445.63 feet through an arc length of 451.77 feet to I-10 P.C. marker 10+30.62; Thence S.57°12'44"W., a distance of 231.01 feet to I-10 P.T. marker 8+00; Thence along a curve to the right from a tangent which bears S.57°16'18"W., having a radius of 1096.00 feet, a delta angle of 39°58'50", a cord which bears S.77°15'43"W., 749.36 feet through an arc length of 764.78 feet to I-10 P.C. marker 45+11.53; Thence N.82°45'27"W., a distance of 340.58 feet to a no. 5 steel rod at the Southwest corner of this tract; Thence N.0°21'53"E., along a line parallel with the east line of Section Eleven (11), a distance of 871.49 feet to a no. 5 steel rod at the Northwest corner of this tract; Thence N.89°55'55"E.,

<sup>1</sup> On February 25, 2008, Richard Grellner, an attorney representing the Tribe, sent an e-mail to Staff Attorney Esther Dittler, expressing the Tribe's intention to claim the settlement of a land claim exception. 25 U.S.C. § 2719 (b)(1)(B)(i). The Tribe has submitted no other information supporting this exception. The Tribe might have argued that it settled a land claim in *Comanche Nation v. United States of America*. The resolution of that case is embodied in the Agreement of Compromise and Settlement Recitals that was executed on January 9, 2007 See *Comanche Nation v. along the North line of Section Eleven (11), a distance of 1688.27 feet to the point of beginning.<sup>2</sup>

Initially, the Tribe requested that the Bureau of Indian Affairs (BIA) take the land into trust under 25 C.F.R. Part 151 and Section 20 of the IGRA. However, the Governor of New Mexico declined to concur with the Tribe's request.<sup>3</sup> The Tribe reconsidered the use of the land, passing a resolution that its use would not change. At that time, the land known as Akela Flats was vacant and undeveloped. See Tribal Council Resolution No. FSAABC-2000-19 (Feb. 15, 2000).

On July 23, 2001, the BIA issued a trust acquisition approval letter. In approving the acquisition the BIA noted that:

The acquisition was in the best interest of the Fort Sill Apache of Oklahoma thereby promoting tribal self-determination and land for reestablishment of the Tribe's land base in New Mexico. The Tribe stated the purposes for which this land will be used are for a land base to reestablish its presence in its aboriginal and former reservation territories in New Mexico. No development is proposed at this time. By letter dated April 21, 1999, the Tribal Planner transmitted a copy of Tribal Council Resolution No. FSABC-99-14 dated April 20, 1999, and advised that through this Resolution the Tribe was removing gaming as a purpose for this acquisition. Based upon these statements, I also make a finding that this acquisition is not for gaming purposes. Therefore, I am signing this letter of intent to take the Akela property into trust status for the Fort Sill Apache Tribe of Oklahoma.

See Letter from Ethel Abeita, Acting Regional Director of BIA to Ruey Darrow, Chairwoman of the Fort Sill Apache Tribe of Oklahoma (July 23, 2001) (emphasis in original).

#### **Applicable Law**

For tribes to conduct gaming under IGRA, such gaming must be conducted on "Indian lands," defined as:

(A) all lands within the limits of any Indian reservation; and

- (B) any lands title to which is either held in trust by the United States for the benefit of any Indian tribe or individual or held by any Indian tribe or individual subject to restriction by the United State against alienation and over which an Indian tribe exercises governmental power.

25 U.S.C. § 2703(4). *See also* 25 C.F.R. § 502.12 (NIGC's implementing regulation further defining Indian lands).

The land at issue here is not within a present day reservation. Thus, for trust or lands subject to a restriction to qualify as Indian lands, a Tribe must present evidence that it exercises governmental power over the land at issue. Prior to answering that question, however, we must consider the Tribe's jurisdiction over the land, as a tribe must possess theoretical and actual jurisdiction to enable it to exercise governmental power over a parcel of land.

## **Jurisdiction and the Exercise of Governmental Power**

### **A. Jurisdiction**

As stated before, tribal jurisdiction is a threshold requirement to the exercise of governmental power. *See e.g., Rhode Island v. Narragansett Indian Tribe*, 19 F.3d 685, 701-703 (1st Cir. 1994), *cert. denied*, 513 U.S. 919 (1994), *superseded by statute as stated in Narragansett Indian Tribe v. National Indian Gaming Commission*, 158 F.3d 1335 (D.C. Cir. 1998) ("In addition to having jurisdiction, a tribe must exercise governmental power in order to trigger [IGRA]"); *Miami Tribe of Oklahoma v. United States*, 5 F. Supp. 2d 1213, 1217-18 (D. Kan. 1998) (*Miami II*) (a tribe must have jurisdiction in order to be able to exercise governmental power); *Miami Tribe of Oklahoma v. United States*, 927 F. Supp. 1419, 1423 (D. Kan. 1996) (*Miami I*) ("the NIGC implicitly decided that in order to exercise governmental power for purposes of 25 U.S.C. § 2703(4), a tribe must first have jurisdiction over the land"); *State ex. rel. Graves v. United States*, 86 F. Supp. 2d 1094 (D. Kan. 2000), *aff'd and remanded sub nom., Kansas v. United States*, 249 F.3d 1213 (10th Cir. 2001). This interpretation is consistent with IGRA's language limiting the applicability of its key provisions to "[a]ny Indian tribe having jurisdiction over Indian lands," or to "Indian lands within such tribe's jurisdiction." 25 U.S.C. §§ 2710(d)(3)(A), 2710(b)(1)); *see also Narragansett Indian Tribe*, 19 F.3d at 701-703. As a threshold matter, we must therefore analyze whether the Tribe possesses jurisdiction over the trust parcel.

Generally speaking, an Indian tribe possess jurisdiction over land that the tribe inhabits if the land qualifies as "Indian country." *Alaska v. Native Village of Venetie Tribal Gov't*, 522 U.S. 520, 527 n.1 (1998). Congress defined the term "Indian country" as: "(a) all land within the limits of any Indian reservation . . . , (b) all dependent Indian communities . . . , and (c) all Indian allotments, the Indian titles to which have not been

extinguished . . .” 18 U.S.C. § 1151. Although this definition applies directly only to federal criminal jurisdiction, the courts have also generally applied this definition to questions of civil jurisdiction. *Venetie*, 522 U.S. at 527.

In its review of 18 U.S.C. § 1151, the *Venetie* court found that the statute contains two of the indicia previously used to determine what lands constitute “Indian Country”: (1) lands set aside for Indians and (2) Federal superintendence of those lands. *See Venetie*, 522 U.S. at 527. In *Venetie*, the court observed that Section 1151 reflects the two criteria the Supreme Court previously held necessary for a finding of “Indian Country.” 522 U.S. at 527. Further, reservation status is not necessary for a finding of “Indian Country.”<sup>4</sup>

The Tenth Circuit found that “[o]fficial designation of reservation status is not necessary for the property to be treated as Indian Country under 18 U.S.C. § 1151,” rather, “it is enough that the property has been validly set aside for the use of the Indians, under federal superintendence.” *United States v. Roberts*, 185 F.3d 1125, 1133, n.4 (10th Cir. 1999). Further, “reservation status is not dispositive and lands owned by the federal government in trust for Indian tribes are Indian Country pursuant to 18 U.S.C. § 1151.” *Roberts*, 185 F.3d at 1130. Thus, as long as the land in question is in trust, the courts make no distinction between the types of trust lands that can be considered “Indian Country.” *Roberts*, 185 F.3d at 1131, n.4. Accordingly, lands held in trust, fee simple restricted status, allotments and reservations are all considered “Indian Country.”<sup>5</sup> Consistent with the Supreme Court decisions discussed above, Akela Flats qualifies as “Indian country,” because the land has been validly set-aside for the Tribe under the superintendence of the Federal government. Because the land is Indian country held in trust for the Tribe, we conclude that the Tribe has jurisdiction over it.

## **B. Governmental Power on Non-Reservation Trust Land**

Next we look to whether the Tribe exercises governmental power over Akela Flats. *See* 25 U.S.C. § 2703(4)(B); *see also Rhode Island v. Narragansett Indian Tribe*, 19 F.3d 685, 703 (1st Cir. 1994).

IGRA is silent as to how NIGC is to decide whether a tribe exercises governmental power over lands at issue. Furthermore, the manifestation of governmental power can differ dramatically depending upon the circumstances. For this reason, the NIGC has not formulated a uniform definition of “exercise of governmental power,” but rather decides that question in each case based upon all the circumstances. *See National Indian Gaming Commission: Definitions Under the Indian Gaming Regulatory Act*, 57 Fed. Reg. 12382,

<sup>4</sup> *See Oklahoma Tax Comm'n v. Citizen Band Potawatomi Indian Tribe of Oklahoma*, 498 U.S. 505, 511 (1991) (“No precedent of this Court has ever drawn the distinction between tribal trust land and reservation that Oklahoma urges.”)

<sup>5</sup> *See United States v. Sandoval*, 231 U.S. 28 (1913) (fee restricted land as Indian Country); *United States v. Pelican*, 232 U.S. 442 (1914) (allotment as Indian Country); *United States v. McGowan*, 302 U.S. 535 (1938) (trust land as Indian Country).

12388 (1992). Caselaw provides some guidance. The First Circuit in *Narragansett Indian Tribe* found that satisfying this requirement depends “upon the presence of concrete manifestations of [governmental] authority.” 19 F.3d at 703. Such examples include the establishment of a housing authority, administration of health care programs, job training, public safety, conservation, and other governmental programs. *Id.*

In *Cheyenne River Sioux Tribe v. State of South Dakota*, 830 F. Supp. 523 (D.S.D. 1993), *aff’d*, 3 F.3d 273 (8th Cir. 1993), the court stated that several factors might be relevant to a determination of whether off-reservation trust lands constitute Indian lands. The factors were:

- (1) Whether the areas are developed;
- (2) Whether the tribal members reside in those areas;
- (3) Whether any governmental services are provided and by whom;
- (4) Whether law enforcement on the lands in question is provided by the Tribe; and
- (5) Other indicia as to who exercises governmental power over those areas.

*Id.* at 528.

In this matter, the Tribe has identified several actions that demonstrate its present exercise of governmental power over Akela Flats. Specifically, the following actions are significant:

- (1) The Tribe has fenced off the land;
- (2) The Tribe has begun construction of a gaming facility on the site;
- (3) The Tribe has issued a facility license to the gaming facility; and
- (4) The Tribe is in the process of improving the roads on the site.

These actions constitute “concrete manifestations of governmental authority” over Akela Flats. Therefore, the Tribe exercises governmental power over Akela Flats.

#### **Application of 25 U.S.C. § 2719**

A determination of whether a tribe is exercising governmental powers over the subject parcel, however, is not necessarily the end of the inquiry. IGRA generally prohibits gaming on lands acquired in trust after October 17, 1998, unless one of the statute’s



exceptions apply. 25 U.S.C. § 2719. Accordingly, for lands taken into trust after October 17, 1988, it is necessary to review the prohibition and its exceptions to determine whether a tribe can conduct gaming on such lands.

The Tribe alleges that the land at issue qualifies for IGRA's last recognized reservation exception and its restored lands exception. The last recognized reservation exception allows gaming on Indian lands acquired in trust after October 17, 1988, if the Indian tribe has no reservation on the October 17, 1988, and "such lands are located in a State other than Oklahoma and are within the Indian tribe's last recognized reservation within the State or States within which such Indian tribe is presently located." 25 U.S.C.

§ 2719(a)(2)(B). The restored lands exception allows gaming on Indian lands acquired in trust after October 17, 1988, if the lands are taken into trust as part of the "restoration of lands for an Indian tribe that is restored to Federal recognition." 25 U.S.C.

§ 2719(b)(1)(B)(iii). The Tribe also claims that the land satisfies the "initial reservation" exception which allows gaming on Indian lands taken into trust as part of a tribe's "initial reservation of an Indian tribe acknowledged by the Secretary under the Federal acknowledgment process." 25 U.S.C. § 2719(b)(1)(B)(ii).

### **I. Last Recognized Reservation**

The last recognized reservation exception allows gaming on Indian lands acquired in trust after October 17, 1988, if the Indian tribe had no reservation as of October 17, 1988, and "such lands are located in a State other than Oklahoma and are within the Indian tribe's last recognized reservation within the State or States within which such Indian tribe is presently located." 25 U.S.C. § 2719(a)(2)(B). The first two parts of this exception are met: the Tribe had no reservation on October 17, 1988, and the land is in New Mexico, a state other than Oklahoma. We now consider to whether Akela Flats is within the State or States within which the Tribe is presently located and whether Akela Flats is within the Tribe's last recognized reservation.

IGRA does not define "presently located." Whether the Tribe is "presently located" in New Mexico turns on the scope and meaning of the term "presently located." To determine the scope of a statute, we look first to its language. *Reves v. Ernest & Young*, 507 U.S. 170, 177 (1993). To ascertain the plain meaning of a statute we look to the particular statutory language at issue, as well as the language and design of the statute as a whole. *Kmart Corp. v. Cartier, Inc.*, 486 U.S. 281, 291 (1988); (See also, *U.S. v. Seminole Nation of Oklahoma*, 321 F.3d 939, 944 (10th Cir. 2002), "In interpreting a statute, the [Tenth Circuit] gives effect to a statute's unambiguous terms. In ascertaining the plain meaning of the statute, the court must look to the particular statutory language at issue, as well as the language and design of the statute as a whole.") Furthermore, we must give the words of the statute "their ordinary, contemporary, common meaning, absent an indication Congress intended them to bear some different import." *Williams v. Taylor*, 529 U.S. 420, 432 (2000).



The NIGC has defined “presently located” to mean where a tribe physically resides, and “to determine where this is the NIGC looks to the seat of tribal government and population center.” *Wyandotte Nation v. National Indian Gaming Commission*, 437 F.Supp.2d 1193, 1205 (Kansas 2006). The *Wyandotte* court, however, accepted a less restrictive definition of “presently located.” It concluded that a tribe is presently located where “a tribe has its population center and major governmental presence.” *Id.* at 1206. We conclude that under either test, the Tribe is not presently located in the State of New Mexico.

#### **A. Seat of Tribal Government and Population Center**

To determine where the Tribe is located, we first consider the location of the Tribe’s seat of government and the location of the Tribe’s population center. The Tribe meets neither test.

The Tribe argues that it is presently located in New Mexico because the Tribe has:

1. expressed its intent to repatriate back to the State;
2. received correspondence from the Governor in which the Governor expressed his support of the Tribe’s effort to return to the State;
3. purchased Akela Flats in 1998 and Akela Flats was taken into trust;
4. submitted an application requesting a Reservation Proclamation be issued;
5. allegedly opened tribal offices at Akela Flats and is administering programs to its tribal members from that location;
6. sought to purchase additional land within the New Mexico;
7. entered into discussions with the Bureau of Land management regarding taking over the conservancy of protected sites in Dona Ana County, New Mexico;
8. received numerous communications from Federal, State, and local agencies seeking the Tribe’s participation, comments on, or consultation regarding projects or actions throughout the Tribe’s former reservation in New Mexico;
9. asserted that individuals who are now members of the Mescalero Apache Tribe may qualify for membership to the Tribe if they choose to revoke their Mescalero Apache membership;
10. asserted that thirty current members of the Tribe live in New Mexico;

11. provides educational program benefits and per capita payments to all members, including those members that reside in New Mexico; and
12. conducted elections in which any member may participate through mail-in ballot, including those members who reside in New Mexico.

The Tribe's governmental headquarters is located in Apache, Oklahoma. *See* Memorandum of Support of Fort Sill Apache Tribal Gaming Commission Luna County, New Mexico Gaming License, page 10 (Feb. 22, 2008). On March 27, 2008, the Tribe passed resolutions transferring several of its tribal programs to the Tribe's New Mexico Office. The following programs were allegedly transferred:

- 1) Section 106 Consultation Program;
- 2) Cultural Resource Management Program;
- 3) Native American Graves Protection and Repatriation Act Program;
- 4) Environmental Protection Agency Program; and
- 5) Higher Education Program.

*See* Fort Sill Apache Business Committee Resolution Number FSABC-2008-15; FSABC-2008-16; FSABC-2008-17; FSABC-2008-118; FSABC-2008-19. In addition, the Tribe may have also relocated its per capita program to New Mexico. While the Tribe may have authorized the transfer of these programs, the Tribe did not submit any evidence that these programs are presently administered from the site. Moreover, the transfer of several tribal programs does not equate to the establishment of the seat of tribal government in New Mexico. Thus, the seat of the Tribe's government remains in Apache, Oklahoma.

The Tribe has not demonstrated that its population center is located in New Mexico. The Tribe notes that half of the Tribe's members live outside the State of Oklahoma and that this resulted from the Tribe's lack of an adequate land base in Apache, Oklahoma. The Tribe also acknowledges that its tribal rolls do not reflect a large number of members in New Mexico. The Tribe's current tribal membership roll indicates that the Tribe has approximately 635 enrolled members. *See* Letter from Phillip Thompson, Attorney for Fort Sill Apache Tribe, to Esther Dittler, Staff Attorney, NIGC, Enclosure 10 (April 7, 2008). Approximately two hundred ninety seven (297) tribal members, forty-seven percent (47%), live in Oklahoma. *Id.* By contrast, approximately twenty six (26) tribal members, four percent (4%), live in New Mexico. *Id.*

The tribal membership rolls demonstrate that a majority of the Tribe's membership is disbursed over a great many states.

The Tribe notes that there are an undetermined number of individuals who are now members of the Mescalero Apache Tribe, some of whom may qualify for membership in the Tribe if they chose to renounce their Mescalero Apache membership. Potential tribal members, by definition, are not members of the Tribe; therefore, such individuals are not properly considered in this analysis. The approximately twenty six (26) tribal members who reside in New Mexico do not represent the Tribe's population center. *Wyandotte Nation v. National Indian Gaming Commission*, 437 F.Supp.2d 1193,1207 (Kansas 2006) (rejecting the assertion that approximately 100 members residing in the county constitutes a population center).

Consequently, the Tribe's population center is clearly located in Oklahoma. Furthermore, the Tribe's seat of government is in Apache, Oklahoma.

#### **B. Major Governmental Presence and Population Center**

Some tribes have reservations that span more than one state. (e.g. the Navajo Nation's reservation spans the borders of Arizona, New Mexico, and Utah). In such a case, a tribe may be "presently located" in more than one state, that is, the Tribe may be presently located in "states." 25 U.S.C. § 2719(a)(2)(B). Although it is possible for a tribe to have more than one seat of government (e.g., the Seneca Nation's seat of government rotates between two reservations), generally a Tribe has only one seat of government. If the NIGC applied the seat of tribal government test in circumstances where a tribe's former reservation spanned more than one state, any tribe with one seat of government would be precluded from gaming on at least part of its last recognized reservation, and we would have failed to give effect to the term "states" within the meaning of 25 U.S.C. § 2719(a)(2)(B).

However, while a tribe that may be located in more than one state and may have one seat of government, generally, the tribe will maintain a major governmental presence in the states through the provision of services to tribal members. Therefore, in circumstances where a tribe's last recognized reservation spans more than one state, and in order to give effect to the term "states," the NIGC looks to a tribe's population center and for a "major governmental presence." Where statutory language is ambiguous, a court will defer to the NIGC's reasonable interpretation of the language. *U.S. v. Seminole Nation of Oklahoma*, 321 F.3d 939, 944 (10th Cir. 2002). In *Wyandotte Nation*, the District Court for the District of Kansas found that a review based upon population center and major governmental presence was a "reasonable interpretation in light of the plain meaning of the phrase presently located, and adopt[ed] the same." *Wyandotte Nation v. NIGC*, 437 F.Supp.2d 1193, 1206 (2006).

The Tribe has not demonstrated that it has a "major governmental presence" in New Mexico. An expression of intent to repatriate back to the State, correspondence from the Governor expressing his support of the Tribe's effort to return to the State, purchase of the land at issue and subsequent trust acquisition, the submission of an application requesting a Reservation Proclamation, and the Tribe's effort to purchase additional land within the New Mexico simply do not demonstrate a major governmental presence in New Mexico.

The Tribe also asserts that it has opened tribal offices on the land at issue and is administering programs to its tribal members from that location. Based on observations made by NIGC field staff, there are no tribal offices on the site and no programs being administered on the site. As mentioned above, the Tribe recently authorized the transfer of several tribal programs to New Mexico. While the Tribe may have authorized the transfer of these programs, we have no evidence that any programs are presently being administered from the site.

The Tribe further asserts that it has a governmental presence in New Mexico through the provision of certain services to members who live in the state. The Tribe's government is located in Apache, Oklahoma, and it permits tribal members to participate in various tribal programs through the mail. Specifically, the Tribe permits its members to participate in its education programs, distributes per capita payments, and conducts elections through the mail. These activities instead of establishing a governmental presence in New Mexico, establish that the Tribe is exercising its governmental power from the State of Oklahoma.

Further, the Tribe has indicated that it has entered into discussions with the Bureau of Land management regarding taking over the conservancy of protected sites in Dona Ana County, New Mexico, and suggests that this contributes to the Tribe's presence in the State. The Tribe has not asserted that it is currently acting as the conservator for these sites; therefore, these discussions do not support the claim of a major governmental presence within the State.

In addition, the Tribe notes that it received numerous communications from Federal, State, and local agencies seeking the Tribe's participation, comment, or consultation regarding projects or actions in New Mexico, including one letter from the Department of the Interior, Bureau of Indian Affairs, providing the Tribe with notice and an opportunity to comment on a two-part determination for the Pueblo of Jemez pursuant to the exception contained in 25 U.S.C. § 2719(b)(1)(a).<sup>7</sup> The Tribe suggests that these communications represent the acknowledgement of the various governmental agencies of the Tribe's physical presence in New Mexico. At most, these communications acknowledge the Tribe's potential interest in the proposed action. In particular, Section

20 of IGRA requires the Secretary of the Interior to consult with any “nearby Indian tribe” while considering a two-part determination. The Secretary has not yet adopted a definition for “nearby Indian tribe.” However, the Secretary has published a proposed definition for “nearby Indian tribe.” Under the proposed definition:

Nearby Indian tribe means an Indian tribe with tribal Indian lands, as defined in 25 U.S.C. 2703(4) of IGRA, located within a 25-mile radius of the location of the proposed gaming establishment, or if the tribe is landless, within a 25-mile radius of its governmental headquarters.

Gaming on Trust Lands Acquired After October 17, 1988, 71 Fed. Reg. 58769 (Oct. 5, 2006) (to be codified at 25 C.F.R. pt. 292). Similar to the other requests for comment or consultation, the Secretary’s notice and request for comment acknowledge that the Tribe holds Indian lands in New Mexico and is not an acknowledgement that the Tribe is “presently located” in New Mexico as contemplated by 25 U.S.C. § 2719(a)(2)(B) or is eligible to game on such lands under § 2719.

Taken together, the actions taken by the Tribe establish that it is exercising its governmental power from the State of Oklahoma and that, at best, its governmental presence in New Mexico is limited. Therefore, the Tribe has not established that it has a “major governmental presence” in New Mexico, or, as noted above, that its population center is located in New Mexico.

**C. The Tribe failed to show that the parcel is located within its last recognized reservation.**

The Tribe has failed to demonstrate that the land it intends to game on is “within the Indian tribe’s last recognized reservation . . .” 25 U.S.C. § 2719(a)(2)(B). The Tribe failed to show that any land was designated a reservation for its benefit in New Mexico, let alone that Akela Flats was part of it. Letter from Phillip Thompson, Attorney for Fort Sill Apache Tribe, to Esther Dittler, Staff Attorney, NIGC, 6 (April 7, 2008). The Tribe states:

In New Mexico, the only reservation which may have been designated for the Chiricahua or Warm Springs Apaches was the Hot Springs Reservation. . . The Executive Order establishing the Hot Springs Reservations mentions the Southern Apaches. The Souther [sic] Apaches [however] is not a designation used to describe the Tribe in the ICC opinions.

*Id.* at 6.

The Fort Sill Apache was found to be the successor-of-interest of the Chiricahua and Warm Springs Apache Bands. *Fort Sill Apache Tribe v. United States*, 19 Ind. Cl. Comm.



212, 215 (June 28, 1968). As the Tribe indicated, the ICC opinion did not specifically find that Southern Apache was a designation used to describe the Tribe. Therefore, it has no claim to the Warm Springs reservation.

Alternatively, the Tribe claims that its last recognized reservation is the land described in Finding of Fact 13(a) of the case *Fort Sill Apache Tribe v. United States*, 19 Ind. Cl. Comm. 212, at 241-242. The land defined in that case encompasses Akela Flats because it encompasses half of Arizona, half of New Mexico, and part of Mexico. The Tribe wants to claim that this entire area constitutes a reservation, and thus Akela Flats is part of the last recognized reservation. However, Finding of Fact 13(a) designates the lands to which the Tribe held aboriginal title as of September 4, 1886 and does not connote a reservation. *Id.* at 241.

Many definitions exist for what constitutes a reservation. Reservation originally meant any land reserved from a Tribe's cession of aboriginal territory. *See F. Cohen, Handbook on Federal Indian Law*, note 3 at 34 (1982 ed.). Over the years a number of definitions have arisen in Indian law including the following:

Reservation includes Indian reservations, public domain Indian allotments, former Indian reservations in Oklahoma, and land held by incorporated Native groups, regional corporations, and village corporations under the provisions of the Alaska Native Claims Settlement Act [43 U.S.C. 1601 et seq.].

25 U.S.C. § 1452(d). Another definition of reservation is that:

Reservation means, for purposes of this part, that area of land which has been set aside or which has been acknowledged as having been set aside by the United States for the use of the tribe, the exterior boundaries of which are more particularly defined in a final treaty, Federal agreement, Executive or secretarial order, Executive or secretarial proclamation, United States patent, Federal statute, or final judicial or administrative determination.

25 C.F.R. § 151.2. However, the Tribe's claim as to the land described in Finding of Fact 13(a) cannot meet any of the definitions of reservation because the Tribe does not provide evidence that it ceded its lands and reserved a part or that the federal government set aside any tracts for its use as a reservation. Because the Tribe failed to present evidence of a last recognized reservation, it cannot claim that Akela Flats is located within that area. Thus, the Tribe cannot claim that exception under IGRA.



## II. Restored Lands for a Restored Tribe

The Fort Sill Apache Tribe also claims that Akela Flats meets the restored lands exception of IGRA. However, because the land was not placed into trust for the Tribe as part of a restoration, it does not qualify for the exception.

For trust lands to qualify for the restored lands exception, the tribe must present evidence that meets both of the following requirements: 1) the tribe has been restored to its federal recognition and, 2) the land at issue was placed in trust as part of a "restoration of lands" for the tribe. If the evidence presented fails to meet either of these requirements, then the land at issue cannot qualify for the restored lands exception.

After an examination of the evidence, we conclude that the Fort Sill Apache Tribe is not a restored tribe, and Akela Flats does not qualify for the restored lands exception under 25 U.S.C. § 2719(b)(1)(B)(iii).

### A. The Ft. Sill Apache Tribe's evidence is insufficient to prove that it constitutes a restored tribe.

To be considered restored, a tribe must present evidence of: 1) federal government recognition; 2) termination of recognition; and 3) restoration of recognition. *See Grand Traverse Band of Ottawa and Chippewa Indians v. Office of the U.S. Attorney for the W. Dist. of Mich.*, 369 F.3d 960, 967 (6th Cir. 2004).

#### 1. The federal government recognized the Fort Sill Apache's ancestors, the Chiricahua and Warm Springs Apache.

To claim federal recognition, a tribe must present evidence that shows that the federal government views it as an entity with:

Immunities and privileges available to other federally acknowledged Indian tribes by virtue of their government-to-government relationship with the United States as well as the responsibilities, powers, limitations, and obligations of such tribes.<sup>8</sup>

The Fort Sill Apache descend from the Chiricahua and Warm Springs Apache Bands and claims its ancestors' federal recognition for its own. The Fort Sill Apache take their language, history, and culture from the Tribes that lived as one community. *Fort Sill Apache Tribe v. United States*, 19 Ind. Cl. Comm. 212, 221-223 (June 28, 1968). The Tribe considers the Chiricahua and Warm Springs Apache's territory to be its own ancestral homeland, and the courts agree. *Fort Sill Apache*, 19 Ind. Cl. Comm. at 224. Further, the court has declared the Fort Sill Apache Tribe to be the successor-in-interest

to the Chiricahua and Warm Springs Apache. *Id.* at 215. Thus, the Fort Sill Apache Tribe is the same tribe and can claim the political history of its ancestors as its own. *Id.* at 220 (citing *Nooksack Tribe v. United States*, 3 Ind. Cl. Comm. 479; *Snake or Piute Indians v. United States*, 4 Ind. Cl. Comm. 576, 612).

With this in mind, the history of federal recognition of the Tribe is evidenced by the Treaty of July 1, 1852, and other contacts with the federal government.

#### **a. The Treaty of July 1, 1852.**

In 1852, Colonel Sumner represented the federal government in treaty negotiations with the southwestern Apache tribes. *Id.* at 227. On July 11, 1852, Mangas Coloradas, chief of the Chiricahua Apaches signed the Treaty of July 1, 1852. *Id.* at 228. In this treaty, the Apache agreed to remain peaceful and not make war on each other or the United States. See Treaty with the Apache, July 1, 1852, Art. 2. The tribes agreed to designate formal boundaries and wield their sovereign powers to pass laws within their territory. See Treaty of July 1, 1852, Art. 9. Congress ratified the treaty on March 23, 1853. 10 Stat. 979.

This agreement is evidence of the federal government's recognition of the Chiricahuas Apache's sovereign status and the government-to-government relationship. *Fort Sill Apache*, 19 Ind. Cl. Comm. at 239. Because the Fort Sill Apache Tribe is a successor-in-interest to the Chiricahua and Warm Springs Apache, the Fort Sill Apache Tribe may also claim this previous recognition. *Comanche Nation*, CIV-05-328-F at 7(g).

#### **b. Other contacts with the federal government.**

The Act of February 27, 1851<sup>9</sup> allowed the United States to extend the Indian Trade and Intercourse Act of June 30, 1834<sup>10</sup> to tribes in New Mexico. This included all Apache tribes. The Act extended the right of occupancy to all tribes in that area and made it illegal to dispossess tribes and individual members of that right.

This Act further evidenced the government-to-government relationship between the Chiricahua and Warm Springs Apache and the federal government. Thus, the descendants of the Chiricahua, its successor in interest known as the Fort Sill Apache Tribe, enjoyed that relationship and federal recognition.

### **2. The Tribe's evidence is insufficient to support the claim of termination of the Chiricahua and Warm Springs Apaches.**

Resisting removal to the San Carlos Reservation, bands of Chiricahua and Warm Springs Apache engaged in hostilities with federal forces. *Fort Sill Apache*, 19 Ind. Cl. Comm. at

244. On September 4, 1886, the Chiricahua under Geronimo surrendered, and the Apaches were taken to Florida as prisoners of war. *Id.* at 245. On this date, the federal government took away the Chiricahua Apache's aboriginal title to its lands in Arizona, New Mexico, and Mexico. *Id.*

This action, however, did not necessarily constitute the federal government's termination of the Tribe and a cessation of the government-to-government relationship. In fact, the United States military forces' decision to take the Chiricahuas as prisoners of war indicates that the Tribe was still considered a hostile but separate and sovereign entity. The Fort Sill Apache Tribe failed to provide any further evidence to connote termination of federal recognition. Thus, the Tribe's presented evidence fails to definitively establish termination.

**3. The federal government accepted the Fort Sill Apache Tribal Constitution and agreed that the Fort Sill Apache acts as the successor in interest for its ancestors Tribe, the Chiricahua and Warm Springs Apache.**

One way that the federal government may recognize an Indian tribe is through the Indian Reorganization Act (IRA) of 1934. 25 U.S.C. § 476(a). Under the IRA, a tribe may adopt a constitution by majority vote that is then sent to the Secretary of the Interior for approval. 25 U.S.C. § 476(a). On August 16, 1976, the Bureau of Indian Affairs approved the Fort Sill Apache Tribe's Constitution. *Comanche Nation*, CIV-05-328-F at 7(j) (citing 70 Fed. Reg. 71194). This approval reflects the government-to-government relations between the Tribe and the Federal government.

Further, the Tribe's status became a stipulated point in a 2007 trust land case involving the Comanche Nation and a Fort Sill Apache casino. *Id.* In that case, the Department of the Interior had transferred into trust a parcel of land that had once belonged to a member of the Comanche Nation but did this on behalf of the Fort Sill Apache Tribe. *Id.* at 1. The department's failure to notify the Comanche Nation led to a lawsuit that the parties settled under a set of stipulations. *Id.* The relevant stipulations are as follows:

7(g). The Fort Sill Apache Tribe is a successor-in-interest to the Chiricahua and Warm Springs Apache Tribes whose aboriginal territory, as defined by the Indian Claims Commission and as affirmed by the United States Court of Claims, includes those parts of Arizona and New Mexico where the United States currently holds land in trust for the benefit of the Fort Sill Apache Tribe.

(h). The United States once maintained a government-to-government relationship with the Chiricahua and Warm Springs Apache Tribes, as evidenced by treaties, negotiations with tribal leaders, provision of services to the tribes and tribal members, and other government-to-

government relationships clearly identified in numerous legal actions maintained before the Indian Claims Commission, United States Court of Claims, United States District Courts, and the United States Department of the Interior Board of Indian Appeals.

(j). On or about August 16, 1976, the Commissioner of Indian Affairs formally approved the Constitution of the Fort Sill Apache Tribe, and thereafter the United States acknowledged the Fort Sill Apache Tribe to be a Federally Recognized Tribe, and has maintained a government-to-government relationship with the Fort Sill Apache Tribe since that date.

(l). The Fort Sill Apache Tribe has land in New Mexico held in federal trust status within the former aboriginal and/or Indian Title lands of the Chiricahua and/or Warm Springs Apache Tribes as defined by the Indian Claims Commission and the United States Court of Claims. The United States agrees to accept and timely process a Fort Sill Apache Tribe application for a reservation proclamation on land currently held in trust for the Fort Sill Apache Tribe which is located in Luna County, New Mexico.

Thus, the court and the United States agreed to the Fort Sill Apache's sovereignty and federal recognition. Further, these stipulations support the view that the Tribe was once recognized as the Chiricahua and that the Chiricahua Tribe was subsequently recognized as the Fort Sill Apache. The evidence presented, however, fails to show that the government-to-government relationship with the Chiricahua, and thus the Fort Sill Apache, suffered termination. Thus, the Fort Sill Apache Tribe has not presented sufficient evidence to establish that it is a restored tribe.

Because the Tribe has not established that it is a restored Tribe, we need not determine whether Akela Flats is part of a restoration of lands. However, the NIGC is concerned with the evidence presented and details its concerns below.

#### **B. Akela Flats is not conclusively part of a "restoration of lands."**

IGRA does not define *restore* and *restoration*, but absent express indication from Congress to the contrary, we must give the words their plain meaning. *Grand Traverse Band of Ottawa and Chippewa Indians v. Office of the U.S. Attorney for the W. Dist. of Mich.*, 198 F.Supp. 2d 920, 928 (W. D. Mich. 2002). IGRA does not require that a "restoration of lands" be accomplished through congressional action or in the very same transaction that restored the tribe to Federal recognition. Lands may be restored to a tribe through the administrative fee-to-trust process under 25 C.F.R. Part 151.<sup>11</sup>

Limits exist, however, as to what constitutes restored lands. The exception is not meant to extend to “any lands that the tribe conceivably once occupied throughout its history.” *NIGC Grand Traverse Opinion* at 15 (August 31, 2001). The United States District Court for the Western District of Michigan noted these limitations, stating that they exist to avoid a result that “any and all property acquired by restored tribes would be eligible for gaming.”<sup>12</sup> The court continued:

The term “restoration” may be read in numerous ways to place belatedly restored tribes in comparable position to earlier recognized tribes while simultaneously limiting after-acquired property in some fashion.

*Grand Traverse I*, 198 F.Supp. 2d at 935. Thus, courts now apply a three-factor test to determine whether land meets the restored lands exception under IGRA: (1) the factual circumstances of the acquisition, (2) the location of the acquisition, or (3) the temporal relationship of the acquisition to the tribal restoration. *Id.* These factors are a balancing test and not all factors must weigh in the Tribe’s favor to meet the exception. *Id.* at 936. These factors together, however, must indicate overall that the Tribe acquired Akela Flats as part of its initial attempt to rebuild its land base.

On balance, we remain concerned that the factual circumstances and the location of the acquisition are not strong enough to fully support the Tribe’s claim to restored lands.

**1. The Tribe’s evidence regarding the temporal relationship and the factual circumstances of the acquisition is insufficient to fully support the restored land claim.**

**a. Temporal relationship**

One factor to be considered is whether there is a reasonable temporal connection between the restoration and the trust land acquisition. *Grand Traverse Band II* at 936 (finding that the land may be considered part of a restoration of lands on the basis of timing alone). The NIGC understands that once recognition occurs, a tribe still needs time to organize and create a constitution before taking land into trust. With that in mind, the NIGC analyzes a restored land claim to see if the land in question constitutes “part of a systematic effort to restore tribal lands.” *Id.* at 936. Thus, the NIGC looks at two factors: 1) the time span between when the tribe was restored and when the land was acquired in trust, and 2) how many other parcels the tribe acquired in that time.

The Tribe’s evidence of a temporal relationship between the acquisition and restoration is insufficient. The Tribe was recognized in 1976, but it admits that it waited to purchase

Akela Flats until 1998. Further, the Tribe did not request that Akela Flats be placed into trust until 1999, and Akela Flats did not go into trust until 2002.<sup>13</sup> In short, the Tribe waited 23 years from recognition to acquire Akela Flats and request that it be placed into trust for gaming.

To date, the longest temporal period that the NIGC has considered for restored lands is 14 years.<sup>14</sup> The NIGC has found in favor of restored land claims for both the Grand Traverse Band<sup>15</sup> and the Bear River Band of Rhonerville Rancheria<sup>16</sup> when those tribes obtained trust land within nine and ten years after restoration respectively. The NIGC has not found in favor of the Karuk Tribe<sup>17</sup> and the Wyandotte Nation<sup>18</sup> when those tribes claimed restored lands for parcels taken into trust eighteen years after the tribes were restored.

The Tribe's evidence here is not strong enough to satisfy this temporal factor. We cannot find that Akela Flats constitutes restored lands solely on the passage of 23 years. Perhaps if the Tribe had met the other factors, we would be willing to push the outer limits of what has been previously considered an acceptable delay. However, that is not the case here.

#### **b. Other factual circumstances**

The Fort Sill Apache Tribe asserts poverty and a difficult time with the land-into-trust process as circumstances that mitigate its late restored lands claim. To illustrate its point, the Tribe refers to the current settlement with the Comanche Nation. The Comanche Nation threatened to assert its jurisdiction over a parcel held in trust for the Fort Sill Apache Tribe. *See Comanche Nation v. United States*, Case No. CIV-05-328-F (W.D. OK May 27, 2005). (The Fort Sill Apache Tribe bought a parcel of allotted land from a Comanche member, placed it into trust, and started gaming on it. The Comanche Nation asserted that a treaty with the United States required its notification. As such, they sought to prevent Fort Sill Apache from acquiring any further Comanche parcels.). The Tribe insists that under these circumstances, its ability to acquire land into trust was precarious.

Despite the Tribe's claim to the contrary, the evidence does not support the idea that Akela Flats is part of the Tribe's initial attempts to reestablish its land base. In fact, the factual circumstances surrounding the acquisition of Akela Flats weigh against the Tribe. This factor weighs against the Tribe because the evidence indicates that the Tribe has

acquired numerous parcels and focused its land acquisition efforts not in New Mexico but in Oklahoma.<sup>19</sup>

Prior to 1981, the Tribe received a \$6 million award from the Court of Claims. *See* Fort Sill Apache Tribal Resolution, FSA-81-01 (January 17, 1981). Soon after receiving the money, the Tribe purchased 36.25 acres (and a 1/6 share of mineral rights) in Caddo County, Oklahoma for \$52,562.50. Shortly after the Tribe purchased the land and accepted the deed, it passed a resolution permitting tribal leaders to purchase the 36.25 acres, and more land in Oklahoma, using funds from the Court of Claims. *See* FSA-81-01. However, the tribal resolution only authorized \$150,000.00 to purchase land. *Id.* The resolution decreed that 80% of the \$6 million award would become a per capita distribution for tribal members. *Id.*

Further, in June 1983, the Tribe used monies from the Bureau of Indian Affairs' land acquisitions fund to purchase more land. *See* Fort Sill Apache Tribal Resolution, FSA-83-7 (June 11, 1983). The Tribe purchased 2.5 acres in Caddo County, Oklahoma for \$3,850.00.<sup>20</sup>

The Tribe made three more purchases in 1987. On January 5, 1987, the Tribe paid \$8,600.00 for 3.75 acres in Oklahoma.<sup>21</sup> On that same day, the Tribe paid \$14,500.00 for another 8.75 acres (absent mineral rights) in Caddo County, Oklahoma.<sup>22</sup> In addition, the Tribe spent \$3,750.00 to purchase the mineral rights to a 12.5 acre parcel in Caddo County, Oklahoma.<sup>23</sup>

Additionally, the Tribe spent \$24,056.25 in April 1988 for a 17.1975 acre parcel in Caddo County, Oklahoma.<sup>24</sup> In addition, the Tribe added to these holdings in 1989 by purchasing 1.25 acres (not including mineral rights) for \$1,900.00.<sup>25</sup>

In 1998, the Tribe acquired Akela Flats but did not request that it go into trust until 1999. Thus, the Tribe had already spent \$109,218.75 to acquire 7 parcels totaling over 82 acres in trust in Oklahoma prior to this purchase.

Further, the Tribe continued to acquire parcels in Oklahoma after its purchase of Akela Flats. The Tribe's last two land acquisitions occurred in 1999 and 2001. In 1999, the Tribe paid \$175,000.00 for 0.53 acres (absent mineral rights) in Comanche County, Oklahoma.<sup>26</sup> In 2001, the Tribe paid \$200,000.00 for 160 acres in Caddo County, Oklahoma.<sup>27</sup>

Thus, the acquisition of so many Oklahoma parcels of land prior to the purchase of Akela Flats is contrary to an assertion of hardship and a claim that Akela Flats is part of the Tribe's initial attempts to rebuild its land base.

The NIGC has considered the issue of prior acquisitions in other cases. For example, the NIGC found that the Cowlitz Tribe's parcel constituted restored lands because the tribe had no land base when it applied for trust land. *Cowlitz Indian Tribe's Class II Gaming Ordinance*, NIGC Opinion (Nov. 23, 2005). Likewise, both the Mechoopda Tribe and the Bear River Band had very few parcels of land in trust before receiving a restored lands determination. *NIGC Mechoopda Opinion* (March 4, 2003). (The Mechoopda Tribe requested a restored lands determination for only its second trust acquisition.); *NIGC Bear River Band Opinion* (Aug. 5, 2003). (The Bear River Band requested a restored lands determination for its first trust acquisition.). In contrast, the NIGC found that the Wyandotte Tribe had acquired too many parcels in the interim for the requested land to be considered part of their initial attempts at rebuilding their land base. *In re: Wyandotte nation Amended Gaming Ordinance*, NIGC Final Decision and Order at 10 (Sept. 10, 2004). (The Wyandotte Tribe amassed three parcels totaling over 194 acres prior to obtaining the trust parcel at issue.).

Much like the Wyandotte Nation, the Fort Sill Apache Tribe has acquired many parcels of land during the years prior to its acquisition of the Akela Flats parcel. Further, the Tribe's attempts to move into New Mexico did not come until after the conflict and litigation involving the Comanche Nation. *See* Letter from Raymond Naudi Jr., Tax Administrator for the Comanche Tax Commission to Davis Qualls, Manager of the Fort Sill Apache Casino (March 21, 2000). (The letter warns the Fort Sill Apache Tribe of Comanche jurisdiction over its newly acquired Oklahoma lands two years prior to its Akela Flats land being placed into trust.). The factual circumstances indicate that Akela Flats is not part of the Tribe's earliest attempts to establish its land base. Thus, the factual circumstances do not appear to weigh in the Tribe's favor.

As an aside, opponents to the Tribe's right to game at Akela Flats have raised concerns about the Tribe's promise not to use Akela Flats for gaming prior to the decision to take it into trust.<sup>28</sup> We address these concerns as a means to clarify what factors are relevant to a restored lands determination.

Opponents to the Tribe's claim point to the Tribe's initial plan to game on the parcel by obtaining the governor's consent for a two-part determination.<sup>29</sup> They also cite the Tribe's resolution to take the land in trust for gaming and the subsequent resolution that removed the gaming language. Fort Sill Apache Resolution FSA-98-26; *see also* Fort Sill Apache Resolution FSA-99-14. The opponents assert that many others have relied on what they considered a promise not to game and feel that they have done so to their detriment. *See* Letter from Ethel Abeita, BIA Acting Regional Director to Tribal Chairman Ruey Darrow dated July 23, 2001 (stating the Tribe dropped its request to take the land into trust *for gaming*, thus the parcel would be taken into trust absent the previously stated objections) (emphasis added); *see also* letter from BIA Acting Director Omar Bradley to Governor Gary Johnson dated August 11, 1999. Under this reasoning, they assert that the promise not to game on the land should be considered a factor in denying the Tribe's claim for restored lands.

The NIGC, however, has already found that a Tribe's original intended use of the land is not a relevant factor in a restored lands determination. *See* Memorandum from NIGC Acting General Counsel to NIGC Chairman Deer, Re: Bear River Band of Rohnerville Rancheria at 2, 14 (August 5, 2002). Further, case law does not support the contention that subjective intent and reliance on that intent may be considered as relevant factors in a restored lands analysis. *See Confederated Tribes of Coos, Lower Umpqua, & Siuslaw Indians v. Babbitt*, 116 F. Supp.2d 155 (D.D.C. 2000). Because the focus of the analysis is to determine the legal status of the land, and not the intended use, promises concerning future uses of the land cannot be considered an analytical factor.

For example, the Tribes in *Confederated Tribes of Coos* took land into trust for one reason, and then announced their intention to game 22 months after the acquisition was complete.<sup>30</sup> Despite the change of plan, the Tribes met all the requirements for the restored lands analysis and were able to use the parcel for gaming. Thus, broken promises are not part of the restored lands analysis.

That is not to say that the NIGC is not disappointed when the government-to-government relationship is affected by broken promises. Broken promises affect the overall integrity of the process and the relationship between the federal family and tribes. The law, however, consistently shows that the NIGC cannot consider such factors in its analysis. See *Confederated Tribes of Coos*, 116 F. Supp.2d 155.

**2. The Tribe's evidence regarding the location of the acquisition does not support the restored land claim.**

The physical location of a trust acquisition is an important factor in determining whether the parcel constitutes restored lands. *NIGC Wyandotte Final Decision and Order* at 10; *NIGC Grand Traverse Opinion* at 17-18. In reviewing the Tribe's evidence, it is necessary to examine the location of Akela Flats to determine the Tribe's historical and modern connections to it. *Id.* In this case, the Tribe's modern connections to Akela Flats do not weigh in favor of finding that the land is restored.

**a. Historical Connections to the Land**

The evidence presented shows that the land was historically significant to the Tribe. The NIGC looks at whether lands located "within areas historically occupied by the Tribe" were taken into trust as part of the restoration. *Grand Traverse I*, 198 F.Supp.2d at 701. To inform its decision, the NIGC looks at the Tribe's historical use of the land and the land's significance.

For example, the Bear River Band was able to show a historical connection to a site that was located one mile away from former villages, trails, and locations featured in tribal myths. *NIGC Bear River Band Opinion* at 10-11. Further, the Tribe occupied the land since 1300 B.C., making clear its historical significance to the Tribe. *Id.* Likewise, in order to prove a historical connection to its land, the Mechoopda Tribe provided evidence that the land in question was part of their aboriginal territory. *Id.*

Similar to the Bear River Band and Mechoopda, the Fort Sill Apache's land has historical significance to the Tribe. Much like the Bear River Band, the Tribe occupied its aboriginal territory "from time immemorial." *Fort Sill Apache*, 19 Ind. Cl. Comm. at 215. Until September 1886, the Chiricahua Apaches, to whom the Tribe is a successor in interest, occupied part of what is known today as Arizona, New Mexico, and Mexico. *Id.* More specifically, the Tribe lived in three primary locations that extended from Navajo country in the north down into northern Mexico. *Id.* at 220. The westernmost portion of the Tribe extended past the Chiricahua Mountain Range. The Tribe ranged westward along the Gila River to the Burro Mountains. *Id.* at 231.

Additionally, the Tribe hunted and subsisted for food, and thus it traveled over large tracts of semi-arid land to reach that food. *Id.* at 232. Subsistence, and the constant search

for water in a semi-arid land, required the Tribe to control and traverse great distances for its survival. *Id.* at 233. Seasonal camp sites were located throughout the territory, and these camps were generally near water because water meant good hunting and good pasture for horses. *Id.* Camps also moved with the changes in seasons, corresponding to the wild harvests. *Id.*

The Tribe's defense of its lands from both Spanish conquistadors and Mexican invaders also indicates its importance to the Tribe. *Id.* at 230. The Tribe continually defended its territory until 1886 from foreign invaders and American settlers. *Id.* at 234. The ferocity of the Tribe's defense is counted as a reason for the slow advance of white settlers in the area. *Id.* at 257-8.

Thus, the Tribe's evidence supports the historical connection to the land and its significance to the Tribe.

#### **b. Modern Connection to the Land**

The Tribe's evidence of a modern connection does not support its restored lands claim. To find a modern connection to Akela Flats, the NIGC considers the Tribe's post-termination activities surrounding the land and its tribal members. *NIGC Wyandotte Opinion* at 21. Specifically, the NIGC asks whether the Tribe has maintained its connection to the land. In other words, the Tribe must show that Akela Flats has always been important to the Tribe and its members. The Tribe must show that Akela Flats maintained its significance throughout tribal history and into the present day. The Tribe's evidence, however, fails to definitively establish Akela Flats' on-going importance to the Tribe.

NIGC is concerned that the Tribe has not presented sufficient evidence that Akela Flats has maintained its significance throughout tribal history and into the present day. The Tribe had no contact with the parcel until 1998. The Tribe presented evidence of a general historical connection to the area until its forced removal in 1886. The Tribe provided a warranty deed indicating purchase and ownership of Akela Flats in 1998. *See Warranty Deed between the Schoeppner Family Trust and the Fort Sill Apache Tribe (October 23, 1998).*

The Fort Sill Apache Tribe also presents evidence of their modern connection to Akela Flats by way of consultations with government offices regarding actions near the site. For example, the Tribe received a request for consultation regarding archeological sites near Akela Flats.<sup>31</sup> Additionally, the Tribe received a request for consultations on utility lines

in Dona Ana County, New Mexico.<sup>32</sup> The Tribe has also received a request from the City of Sunland Park to consult on the improvements to a wastewater treatment plant located in Dona Ana County, New Mexico.<sup>33</sup> Further, the Tribe received a request for input from the Bureau of Indian Affairs regarding the cultural and archeological impact of a proposed casino in nearby Dona Ana County, New Mexico. *See* Letter from Bureau of Indian Affairs, Real Estate Superintendent Ms. Gutierrez to Chairman Houser dated Nov. 18, 2005. This request also inspired the Tribe to consider taking over the conservancy of protected sites in the area. *Id.*

These consultations, however, came after the Tribe acquired the parcel in 1998. The Tribe presents no other evidence of contact or local relationships before it acquired Akela Flats. Because the Tribe has provided no other evidence regarding a connection to the parcel in between the years of 1886 and 1998, it has failed to provide sufficient evidence of an on-going modern connection to Akela Flats.

Further, Akela Flats is over 540 miles away from all major Fort Sill Apache governmental offices. The Tribe currently maintains an inoperative casino and gaming commission office on the site but little else. In April 2008, the Tribe opened a restaurant and smoke shop.<sup>34</sup> The restaurant and smoke shop are in the same building that houses the inoperative casino. The lack of evidence regarding tribal offices dating from the land's initial purchase indicates that the Tribe has not maintained an on-going connection to Akela Flats.

Additionally, the Tribe presented evidence that it has approved the movement of the following programs to New Mexico: the Native American Graves Protection and Repatriation Act program; the Cultural Resources Management program; the Fort Sill Apache Environmental Protection Agency program; the Higher Education program; and the Per Capita program. *See* Letter from Phil Thompson, Fort Sill Apache Attorney to Esther Dittler, Attorney for the National Indian Gaming Commission, Re: Fort Sill Apache Tribe (April 7, 2008).

However, the Tribe has presented no evidence of the programs' actual movement and its activities in New Mexico. The Tribe's major programs, one for higher education credits and one for per capita payments, service its members by mail. Aside from the higher education program and the per capita program, it remains unclear how the programs service tribal members directly. Furthermore, no tribal members live on-site or adjacent

to Akela Flats. In fact, most of the tribal members live in Oklahoma. Therefore, Akela Flats does not appear to have maintained its significance to tribal members.

Evidence of an on-going connection to the land, from historical times to the present day, is an important factor in establishing a restored lands claim. For example, the NIGC found that the Bear River Band was able to show that the desired parcel was only 11 miles from a tribal residential area and government offices. *NIGC Bear River Band Opinion* at 10. Likewise, the Grand Traverse Band had tribal members living near the parcel and receiving BIA services. *Grand Traverse Band II*, 198 F. Supp. 2d at 936.

On the other hand, the Wyandotte Nation did not possess a sufficient modern connection to a parcel that was 175 miles away from any major governmental office and population. *NIGC Wyandotte Opinion* at 21. Further, the Tribe could provide no evidence that the land maintained its importance to the Tribe's members because the Tribe's programs serviced members in Oklahoma. *Id.* (Wyandotte, Oklahoma was also home to the Tribe's Turtle Stop Convenience Store, Turtle Tot Learning Center, a Seniors Program, and education assistance programs).

The Tribe's forced removal from their aboriginal territory, and subsequent settlement in Oklahoma, helps explain the Tribe's lack of modern connections to Akela Flats. That fact alone, however, fails to explain why the Tribe did not establish any connections to the land until 1998. The Tribe received new recognition in 1976 but failed to establish modern connections to Akela Flats as a trust parcel for another 23 years. Instead, the Tribe focused on obtaining trust land in Oklahoma. As stated before, the Tribe's evidence of connections established to Akela Flats do not include functioning government offices. Nor do the connections established clearly indicate that Akela Flats has maintained its significance in the eyes of tribal members. Thus, the Tribe's evidence of modern connections to Akela Flats is insufficient.

### **III. Initial Reservation**

The initial reservation exception permits gaming on Indian lands acquired in trust after October 17, 1988, where the lands are taken into trust as part of the initial reservation of an Indian tribe acknowledged by the Secretary under the Federal acknowledgement process. 25 U.S.C. § 2719(b)(1)(B)(ii). This exception requires: 1) the land is part of the tribe's reservation; 2) the reservation is the Tribe's initial reservation; and 3) the Tribe was acknowledged by the Secretary of the Interior under the Federal acknowledgement process. The Tribe has failed to demonstrate that Akela Flats is designated a reservation, that Akela Flats is the Tribe's initial reservation, and that the Tribe was acknowledged through the Federal acknowledgment process.

The Tribe also asserts that the land has reservation status based upon the assignment of a reservation code to Akela Flats as indicated on the BIA's Land Titles and Records Office (LTRO) Document Recordation form. The BIA has informed us of the following:



A function of the Bureau of Indian Affairs (Bureau) LTRO is to record documents, a function similar to a county recording office. Documents submitted by servicing Bureau agencies are to be accompanied by a document recording transmittal.

The current form used in the Albuquerque LTRO contains a field titled "Reservation Code". [sic] This title is merely a field name intended to identify a code for a land area used in the automated land records system. It does not mean that the code identified in the field is strictly associated with a reservation – only a land area.

The previously automated land records system has recently undergone an entire enhancement and data was converted to a new system. Many field names were changed to better identify their contents. The previously identified field name "Reservation Code" was changed to "Land Area Code". [sic]

The document recordation form, itself, has not yet been modified to coincide with the new system's field names. The LTROs are in the process of upgrading [sic] all associations to the new system. The previous "Reservation Code" field will also be changed to "Land Area Code". [sic]

*See* letter from Donna M. Peigler, Manager, Albuquerque Land Titles Records Office, Bureau of Indian Affairs, to Whom It May Concern (March 13, 2006). The assignment of a reservation code does not mean that it is strictly associated with a reservation, but identifies a particular land area. *See* Letter from George T. Skibine, Acting Deputy Assistant Secretary for Policy and Economic Development, Department of the Interior, to Esther Dittler, Staff Attorney, NIGC (May 15, 2008). Assignment of a reservation code does not demonstrate that Akela Flats has been designated a reservation.

The Secretary has not yet processed the Tribe's application requesting that its trust land be proclaimed a reservation.<sup>35</sup> The Tribe has informed the NIGC that it filed a lawsuit in the United States District Court of the Western District of Oklahoma seeking enforcement of the Agreement of Compromise and Settlement in which the United States

agreed “to accept and timely process an [sic] Fort Sill Apache Tribe application for a reservation proclamation on land currently held in trust for the Fort Sill Apache Tribe which is located in Luna County, New Mexico.” *Comanche Nation v. United States of America*, Agreement of Compromise and Settlement Recitals, CIV-05-328-F at 7(l) (W.D.OK, March 8, 2007).

Moreover, the initial reservation exception is limited to tribes acknowledged through the federal acknowledgment process. “Acknowledgment is a specifically defined term under the IGRA, because the statute expressly references a federal administrative process [,] 25 C.F.R. Part 83, by which the agency acknowledges the historical existence of a tribe.” *Grand Traverse Band of Ottawa and Chippewa Indians v. United States Attorney for the Western District of Michigan*, 46 F. Supp. 2d 689, 699 (W.D. Mich. 1999). George Skibine, Acting Deputy Assistant Secretary for Policy and Economic Development, informed the NIGC that the Tribe was not acknowledged through the federal acknowledgment process. See Letter from George T. Skibine, Acting Deputy Assistant Secretary for Policy and Economic Development, Department of the Interior, to Esther Dittler, Staff Attorney, NIGC (May 15, 2008); also see Status Summary of Acknowledgment Cases, Prepared by the Office of Federal Acknowledgment, Assistant Secretary – Indian Affairs (Feb. 15, 2007) (Lists forty tribes whose status was determined through the acknowledgment process, as of February 15, 2007). Rather, the most recent evidence of the Tribe’s recognition is when the Commissioner of Indian Affairs approved the Tribe’s constitution on August 16, 1976. *Comanche Nation v. United States of America*, Agreement of Compromise and Settlement Recitals, CIV-05-328-F at 7(j) (W.D.OK, March 8, 2007).

The Tribe argues that the exception applies to all federal actions that result in the recognition of a tribe. The Tribe argues that the term “federal acknowledgement process” is ambiguous. Under this theory, the Tribe attempts to argue that statutory rules of construction enable it to interpret “federal acknowledgment process” under a plain meaning standard and that the phrase means any federal action that constitutes recognition. However, “federal acknowledgement process” is a term of art that is commonly understood to refer to the regulations adopted by the Secretary in Part 83. “It is a well-established rule of statutory construction that when Congress uses a term of art . . . unless Congress affirmatively indicates otherwise, we presume Congress intended to incorporate the common definition of that term.” *United States of America v. Dante Vargas-Amaya*, 389 F.3d 901, 904 (9th Cir. 2004).

Further, the recognition of tribes prior to the development and implementation of the BIA’s federal acknowledgment regulations cannot be fairly identified as a process. It was, in fact, this lack of process that required the development of the process now contained in 25 C.F.R. Part 83. The preamble to the final rule explains:

Various Indian groups throughout the United States have requested that the Secretary of the Interior officially acknowledge them as Indian tribes.

Heretofore, the limited number of such requests permitted an acknowledgment of the group's status on a case-by-case basis at the discretion of the Secretary. The recent increase in the number of such requests before the Department necessitates the development of procedures to enable the Department to take a uniform approach in their evaluation.

*See Procedures for Establishing that an American Indian Group Exists as an Indian Tribe*, 40 Fed. Reg. 39361 (Sept. 5, 1978). The purpose of these procedures is the "establish a departmental procedure and policy for acknowledging that certain American Indian tribes exist." *Id.* at 39362.

The Tribe may not claim this exception because it was not recognized through the Federal acknowledgement process. Furthermore, Akela Flats is not a reservation and the Tribe's application for a reservation proclamation remains pending. Therefore, if the Tribe had been acknowledged by the Secretary under the Federal acknowledgment process, 25 C.F.R. Part 83, the Tribe's land would not qualify under the initial reservation exception because the land has not been proclaimed a reservation.

#### **Conclusion**

Based upon the foregoing, we conclude the Tribe may not lawfully conduct gaming on the proposed site. The Tribe has failed to demonstrate that its New Mexico trust land is located within the Tribe's last recognized reservation within the State or States within which the Tribe is located. In addition, the Tribe does not meet the requirements of the initial reservation or demonstrated that it is a restored tribe.

The Department of the Interior Office of the Solicitor concurs that the Tribe may not game on Akela Flats.
