**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION FINDING CERTAIN RESPONDENTS IN DEFAULT**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 17) finding the following respondents in default: Anbess Electronics Co. Ltd. of Shenzhen, China ("Anbess"); Guangzhou Evotech Industry Co., Ltd. of Guangdong, China ("Evotech"); Hoffco Brands, Inc. d/b/a Celltronix of Wheat Ridge, Colorado ("Celltronix"); Hong Kong HJJ Co. Ltd. of Shenzhen, China ("HJJ"); Sinatech Industrial Co., Ltd. of Guangzhou City, China ("Sinatech"); Suntel Global Investment Ltd. of Guangzhou, China ("Suntel"); Trait Technology (Shenzhen) Co., Ltd. of Shenzhen, China ("Trait"); Papaya Holdings Ltd. of Central, Hong Kong ("Papaya"); Quanyun Electronics Co., Ltd. of Shenzhen, China ("Quanyun"); Topter Technology Co. Ltd. of Guangdong, China ("Topter"); and Cellet Products of Santa Fe Springs, California ("Cellet").

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on June 30, 2011, based on a complaint filed by Otter Products, LLC of Fort Collins, Colorado ("Otter"). 76 *Fed. Reg.* 38417 (June 30, 2011). The complaint alleged violations of section 337 of the Tariff Act

of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain protective cases and components thereof by reason of infringement of various claims of United States Patent Nos. 7,933,122; D600,908; D617,784; D615,536; D617,785; D634,741; and D636,386; and United States Trademark Registration Nos. 3,788,534; 3,788,535; 3,623,789; and 3,795,187. The complaint named several respondents, including Anbess, Evotech, Celltronix, HJJ, Sinatech, Suntel, Trait, Papaya, Quanyun, Topter, and Cellet. The complaint and notice of investigation were served on these parties on June 27, 2011.

On September 8, 2011, the ALJ issued a show-cause order (Order No. 9), ordering Anbess, Evotech, Celltronix, HJJ, Sinatech, Suntel, and Trait to show by September 23, 2011, why they should not be found in default for failure to respond to the complaint and notice of investigation. Anbess, Evotech, Celltronix, HJJ, Sinatech, Suntel, and Trait did not respond to the show-cause order.

On October 9, 2011, the ALJ issued a show-cause order (Order No. 15), ordering Papaya, Quanyun, and Topter, to show by November 3, 2011, why they should not be found in default for failure to respond to the complaint and notice of investigation. Papaya, Quanyun, and Topter did not respond to the show-cause order.

On October 14, 2011, Respondent Cellet filed a notice electing to default. No party responded to Cellet's notice. Cellet did not respond to either the complaint or notice of investigation.

On November 8, 2011, the ALJ issued the subject ID, finding Anbess, Evotech, Celltronix, HJJ, Sinatech, Suntel, Trait, Papaya, Quanyun, Topter, and Cellet in default under 19 C.F.R. § 210.16(a)(1) for failing to respond to the complaint and notice of investigation. None of the parties petitioned for review of the ID.

The Commission has determined not to review the ID. Accordingly, Anbess, Evotech, Celltronix, HJJ, Sinatech, Suntel, Trait, Papaya, Quanyun, Topter, and Cellet have defaulted.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
