## NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION GRANTING A MOTION TO AMEND THE COMPLAINT AND NOTICE OF INVESTIGATION

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ's") initial determination ("ID") granting complainant's motion to amend the complainant and notice of investigation to add allegations of infringement of the asserted patents, *viz.* claim 13 of U.S. Patent No. 6,633,187 ("the '187 patent") and claim 10 of U.S. Patent No. 6,137,279 ("the '279 patent"), by the ATJ2085 device of respondent; and (2) to assert claims 1, 6, 9 and 13 of complainant's U.S. Patent No 6,366,522 ("the '522 patent") against the ATJ2085 device.

SUPPLEMENTARY INFORMATION: The Commission instituted this patent-based section 337 investigation on April 18, 2005, based on a complaint filed by SigmaTel, Inc. ("SigmaTel"), of Austin Texas. 70 Fed. Reg. 20172. The respondent named in the investigation is Actions Semiconductor Co. ("Actions"), of China. The complaint alleged that respondent violated section 337 by importing into the United States, selling for importation, and/or selling within the United States after importation certain audio processing integrated circuits and products containing same by reason of infringement of certain claims of the '279 patent, and certain claims of the '187 patent.

On June 9, 2005, the ALJ issued the subject ID, Order No. 5, granting SigmaTel's motion to amend the complainant and notice of investigation to add allegations of infringement of claim 13 of the '187 patent and claim 10 of the '279 patent by the ATJ2085 device of respondent Actions and to assert claims 1, 6, 9 and 13 of SigmaTel's '522 patent against the ATJ2085 device.

No party filed a petition to review the subject ID.

This action is taken under the authority of section 337 of the Tariff Act of 1930, 19 U.S.C. § 1337, and section 210.42 of Rules of Practice and Procedure, 19 C.F.R. § 210.42.
