IMPORTANT PROTOCOLS FOR THE OFFICE OF THE SPECIAL TRUSTEE FOR AMERICAN INDIANS

4400 Masthead NE, Albuquerque, NM

- Park in designated areas (parking lot will be marked off for visitors).
- A federal or state issued photo identification card must be presented upon entering the building.
- Visitors will be issued a temporary visitor's badge, which must be visibly worn while in the facility.
- Laptops must be accompanied with a property pass (DI-1934) or a DI-105 before entering the building.
- Possession of a firearm or weapon in this Federal facility is a <u>federal crime</u> regardless if a license to carry a concealed handgun is authorized (Title 18 USC, Section 930). The list of weapons include but are not limited to: firearms, knives (including small pocket knives and box cutters), stun-guns, mace, and pepper sprays.
