SUBJ: ON-SITE INSPECTION AGENCY (OSIA) CHEMICAL WEAPONS (CW)
TREATY ORIENTATION COURSE

1. OSIA WILL CONDUCT MODULE I OF THE CHEMICAL WEAPONS (CW)
TREATY ORIENTATION COURSE ON 28-31 JAN 97, AT THE BDM
FAIRFAX BUILDING, 1501 BDM WAY, MCLEAN, VA 22102. THE PURPOSE
OF THE CW MODULE I COURSE IS TO PROVIDE ATTENDEES WITH CHEMICAL
WEAPONS AND ARMS CONTROL KNOWLEDGE FOR OSIA ESCORT OR OTHER
DUTIES RELATED TO THE CHEMICAL WEAPONS CONVENTION (CWC) AT U.S.
FACILITIES. THIS COURSE WILL ALSO PROVIDE A STARTING POINT FOR
CONTINUING SELF-STUDY IN ORDER TO BECOME MORE KNOWLEDGEABLE ON
THE CWC.

2. SUCCESSFUL COMPLETION OF THE CW MODULE I COURSE IS A
PREREQUISITE FOR ATTENDANCE AT ANY OTHER OSIA CW COURSE.

3. ATTENDANCE WILL BE LIMITED TO A MAXIMUM OF 75 STUDENTS.
HIGHEST PRIORITY FOR ENROLLMENT WILL GO TO INDIVIDUALS WHO MAY
BE DIRECTLY INVOLVED IN THE CW TREATY PROCESS IN CALENDAR YEAR
1997, PRINCIPALLY OSIA ESCORT PERSONNEL AND ARMS CONTROL
MANAGERS/SUPERVISORS. COMPLETION OF AN OSIA FORM 56 IS NOT AN
AUTOMATIC ENROLLMENT IN THE COURSE. ALL OSIA FORM 56'S WILL BE
SCREENED BY THE CW DIVISION TO DETERMINE STUDENT ELIGIBILITY AND
PRIORITY OF ENROLLMENT. THE JUSTIFICATION SECTION OF THE FORM 56
MUST BE COMPLETED AND THE INDIVIDUAL'S ROLE IN IMPLEMENTING THE
CWC MUST BE STATED.

4. EACH ORGANIZATION IS REQUESTED TO ESTABLISH A POINT OF

FOLLOWING RECEIPT OF NOMINATIONS, OSIA WILL PROVIDE FURTHER ADMINISTRATIVE INFORMATION AND FUNDING DATA FOR ALL ATTENDEES.
