Dear General Loper:

The November 1958 Planning Estimates* are transmitted herewith. The Commission is currently preparing a production program designed to meet the special nuclear material requirements stated in the Acting Secretary of Defense's letter** of October 16, 1958. In conjunction with this effort we are, of course, effecting jointly a comprehensive review of the predicted diversions of or alloy for purposes other than weapons.

In view of this situation, we have not attempted herein to project special nuclear material forecasts beyond FY 1962. The current material estimates through FY 1962, Attachment 1 hereto, do not differ significantly from those provided in the May 1958 Planning Estimates.***

The forecast of weapon deliveries, Attachment 2, is essentially as that contained in the May 1958 Planning Estimates for July 1, 1959 and July 1, 1960 except for the following:

In the May 1958 Planning Estimates and again in the General Manager's letter* of July 30, 1958, we indicated that we could not then give positive assurance of being able to meet the planned schedule of (b)(1),(b)(3):42 USC § 2162 (a) (RD)

Persistent difficulties in manufacturing some components and production startup problems have caused initial production rates to be low. As a result, meeting the presently planned schedule for July 1, 1959 would require an acceleration of production to a point beyond our capability. You will recall that in the May Planning Estimates in an effort to effect a more likely attainable and economical production workload that the Commission pointed out the desirability of producing the (b)(1),(b)(3):42 USC § 2162 (a) (RD)

and requested whether such would be militarily acceptable.

Your letter** of October 14, 1958 to the Chairman, AEC requested a proposed program which incorporates the desired production delays. A recent review of our production capabilities indicates that we can produce (b)(1),(b)(3):42 USC § 2162 (a) (RD) with completion of the program in October 1959. Details of the proposal are contained in Attachment 2.

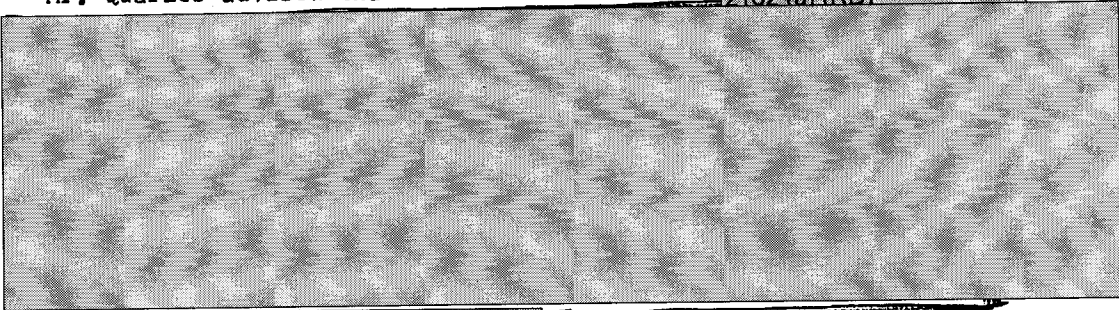

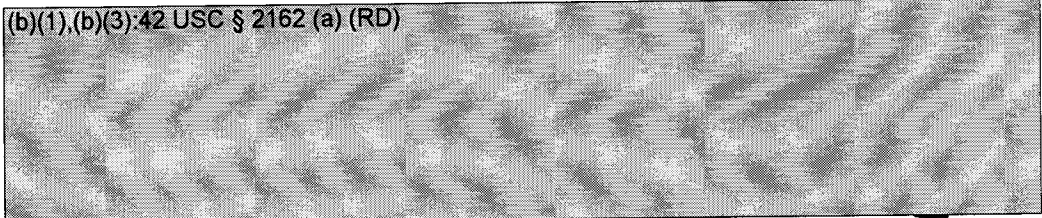

Our May 1, 1958 Planning Estimates indicated 60 Mark 30 warheads for July 1, 1959. Since the most recent JCS guidance indicates the same number of this type weapon for July 1, 1960, I propose that the July 1, 1959 number be reduced to 30 to be consistent with missile availability. DOD

The July 8, 1958 letter* from the Chairman, AEC to Mr. Quarles advised that due to the results of (b)(1),(b)(3):42 USC § 2162 (a) (RD)



Since this letter also states a requirement for the Mark 35 warhead, I assume that the July 8, 1958 letter did not arrive in time to be considered in the August 6 guidance. Consequently, we still plan to produce additional Mark 49 weapons instead of Mark 35's. However, in the absence of a reply to our July 8 letter, we are planning to start production of this high yield version of the Mark 49 (Mark 49 Y-2) in November 1958 with first production units delivered in January 1959. Numbers have been increased slightly to provide a smoother workload throughout the production period.



To compensate for the reduction, we have retained a like number of Mark 36 weapons.

Deliveries of the Mark 27 bomb are reduced due to the non-availability of certain electro-mechanical components.

As requested by letter from the Chairman, MLC dated October 16, 1958 we have discontinued development work on the TX-46. To partially compensate for this reduction in deliveries we do not now plan to retire any Mark 15 weapons during this time period.

The Mark 40 program has been rescheduled to provide a smoother production approach to the July 1, 1960 numbers. The numbers for the Mark 12 bomb, the Mark 39 Y-2 warhead and Mark 39 B/WCC have been revised to satisfy the latest JCS guidance on the desired composition of the stockpile for July 1, 1960.

Attachment 2 also provides in as much detail as is now possible the planned net withdrawals from stockpile for the stockpile sampling program as of the dates indicated. Programs which indicate zero withdrawals should not be interpreted to mean that stockpile sampling is not being conducted but rather withdrawals and all returns are made within the quarter.

Results of HARDTACK, Phase I are attached. In view of the conclusion of HARDTACK Phase II concurrently with the date of these estimates, our report of these tests and the status of development projects will be forwarded later after preliminary analyses can be completed.

Your concurrence in the forecasted weapons deliveries is requested.
