

APPENDIX H: Fiscal Year 2005 Sikes Act Reporting Data

CONSERVATION

The Sikes Act, as amended in 1997, requires Department of Defense (DoD) installations to prepare Integrated Natural Resource Management Plans (INRMPs). The plans assist base commanders in conserving and rehabilitating natural resources while supporting the military mission. Installations must review and update these plans every five years.

Installations are required to seek the cooperation of the U.S. Fish and Wildlife Service (FWS) and appropriate state fish and wildlife agencies concerning natural resource management. This is to ensure that DoD, FWS, and state agencies concur on resource management practices and to provide DoD with access to the expert knowledge of FWS and state agencies. Some installations that have reported INRMPs in the past may no longer be required to report if the installation has closed, is in the process of closing, has been granted an official waiver, or no longer meets the criteria for requiring an INRMP. DoD spent approximately \$100 million developing and implementing INRMPs in FY2005, as shown in Figure H-1.

Installations are required to report specific data annually. Figure H-2 depicts the status of required INRMPs on an installation level. The data category "Current List of Projects," refers to whether or not the installation has a current list of projects or methodologies essential to implement the plan's objectives for the next fiscal year. These data are current as of September 30, 2005.
