The Census must count every person living in the United States on April 1, 2010.

The Census Bureau also counts people in institutions and other places, so:

- Do not count anyone living away either at college or in the Armed Forces.
- Do not count anyone in a nursing home, jail, prison, detention facility, etc., on April 1, 2010.
- Leave these people off your form, even if they will return to live here after they leave college, the nursing home, the military, jail, etc. Otherwise, they may be counted.

The Census must also include people without a usual place to stay, so:

- If someone who has no permanent place to live here on April 1, 2010, count that person even if she may be missed in the census.
