The Low-Income Housing Tax Credit (LIHTC) program has addressed the nation's affordable rental housing needs by financing nearly two million low-income units over the past two decades. Banks that invest in LIHTC-financed projects can earn attractive rates of return, reduce their federal tax liability, and obtain Community Reinvestment Act (CRA) credit. LIHTC funds spread investment

risk among many investors and properties in diverse geographic markets. Banks considering their first LIHTC investment may find these funds to be a good initial approach. At this Web and telephone seminar, you will learn about the LIHTC fund business from an OCC official, a regional fund manager, and a low-income housing tax credit investment advisor.

- How the LIHTC program works.
- Fund investments and CRA consideration.
- Financial, tax, and accounting benefits.
- Examples of successful fund investments.
