#### **Articles**

#### **Article B06: Containers And Conveyances For Items**

The Purchaser will furnish all containers, labor and equipment necessary for the accumulation and removal of material in a sanitary manner. All containers will be leak proof. A clean empty container will be provided to replace each container removed. Transfer of waste from container to container or container to truck will not be permitted at any removal point. Containers are not to be filled above four inches from the top to prevent spillage during handling and/or transit. Leakage and scattering of waste on roads and areas within the military installation will not be permitted. The purchaser will immediately clean up any spillage which may occur. Sufficient containers shall be furnished to provide for segregation of the items. Containers are subject to sanitary inspection at any time.

#### **Article B15: Pre-payment And Payments On Term Contracts**

- (a) For each line item awarded, a pre-payment of 20% of the total price estimated for a 1 year's generation is required and must be made prior to or at the time of first removal. No property will be released to the purchaser or his duly authorized agent before pre-payment has been received by the Sale's Contracting Officer. The Pre-payment submitted by the Purchaser will be retained by the Government and applied against the last delivery effected under the contract.
- (b) All payments, including those for storage charges, liquidated damages and interest must be in U.S. currency. Acceptable payments may be made by cashier's check, certified check, traveler's check, bank draft, money order, credit card (Master Card, Visa, Discover Card, American Express) or debit card (Master Card and Visa). When a credit/debit card is used as payment, the credit card number, the name as printed on the credit card, and the expiration date must be provided. If more than one credit card is used, the bidder must identify the exact monetary amount to be applied against each credit card. NOTE: The maximum dollar amount allowed for credit card transaction is \$49,999. You may not split individual transaction greater than \$49,999 into two or more transactions over one or multiple days. Any attempts to do multiple transactions on the same day with the same credit card that causes the total charge to exceed the limit of \$49,999 will be rejected. There is no maximum dollar amount for debit card transaction. #### Article B45: Sale And/Or Consumption of Foodstuffs:

In the event the Purchaser disposes of the foodstuffs directly to the general public for human consumption, he shall not do so until the material has been reprocessed to such an extent that it meets all Federal, state and local requirements governing the sale and/or consumption of foodstuffs. In the event the Purchaser disposes of the material to persons or organizations for resale to the general public, he shall require such persons or organizations to process the material to the same extent as required above prior to disposal thereof for human consumption. Dear Customers:

DLA Finance has advised DLA Disposition Services that the US Department of Treasury, Financial Management Service (FMS) has released policy statement A-2012-2 to announce upcoming changes pertaining to limitations on credit and debit card transactions.

Therefore, we are advising our sales customers of the policy changes regarding credit card payment limitations that will be effective on <u>June 30, 2012</u>. The new policy lowers the maximum dollar amount allowed for a credit card transaction to \$49,999.

Large dollar card transactions are costlier for the Federal Government than small dollar transactions. We incur a variety of fees for each transaction, the largest of which is an interchange fee based on a percentage of the dollar value of the transaction. Paying high fees for accepting credit card transactions is not in the Federal Government's best interest.

Agencies may not split individual transaction greater than \$49,999 into two or more transactions over one or multiple days. Splitting a transaction violates the credit card network and FMS rules. For a customer that attempts multiple transactions on the same day with the same credit card, those transactions that cause the total charge to exceed the limit of \$49,999 will be rejected.

This policy also <u>eliminates</u> the maximum dollar amount for debit card transactions. Therefore, DLA Finance will accept and process VISA/MasterCard branded Debit card for payments. Other acceptable forms of payments are cash, certified check, cashier's check, travelers check, bank draft, or money order.

Currently our DLA Finance is working with both the FMS and the Card Acquiring Service to see if any alternatives are available for our public sale buyers. In the meantime, the above policy will be implemented effective on <u>June 30, 2012</u> for the credit card transaction limitation to \$49,999.
