DLA Disposition Services Transition to Reutilization Business Integration (RBI)

RBI Fielding Update

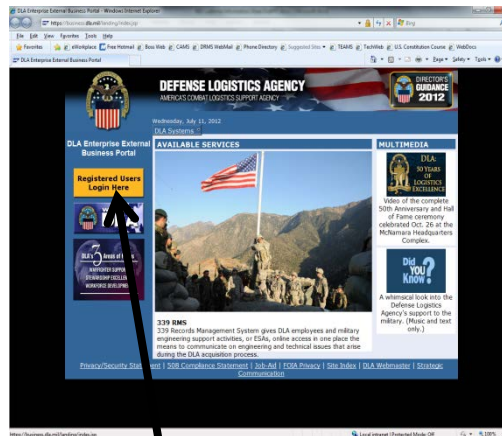
DLA Disposition Services is integrating its systems with the DLA Enterprise Business System. This significant shift is scheduled to occur **August 27, 2012**.

One of the major changes for customers is the activation of the DLA Enterprise External Web Portal. Access to applications such as Electronic Turn-in Documents (ETID) and Reutilization/Transfer/Donation (RTD) search and requisition tools are through this single sign-on portal.

Customers must request user access to our new Portal and roles through the DLA Account Management and Provisioning System (AMPS).

You will be able to enter the External Portal for Customers and start using RTD and ETID beginning August 27, 2012 at: <https://business.dla.mil>.



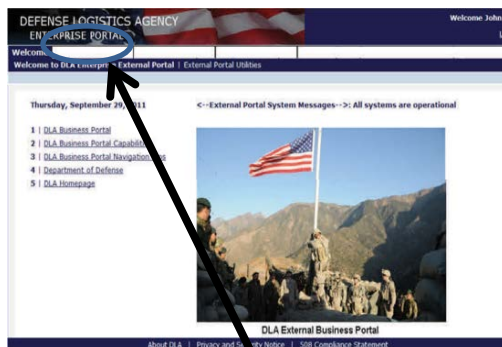

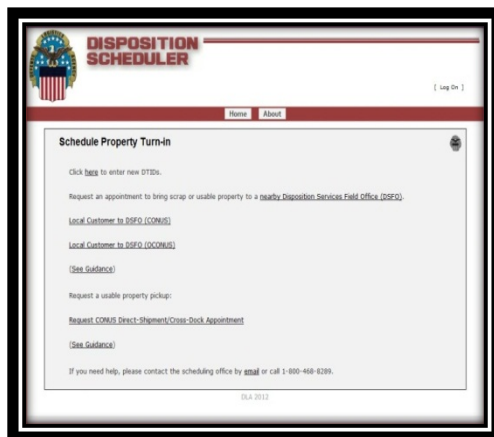
Disposition Services' Transportation Scheduler

The new DLA Disposition Services' Transportation Scheduler will go live on **August 27, 2012.**

The application can be found on the Disposition Services Home Page at <http://www.dispositionservices.dla.mil/>. Select "Schedule Property Turn-In".

Transportation Scheduler does **NOT** require AMPS access.

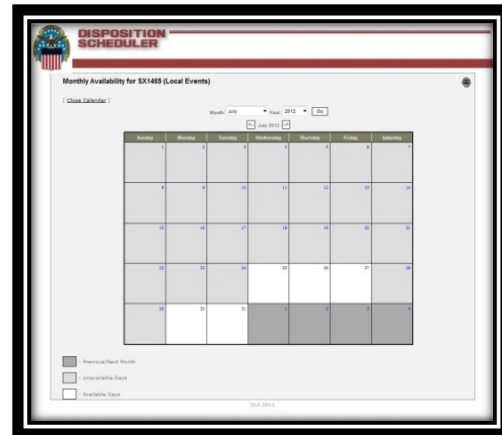
The new Scheduler has some new features and an updated appearance. All of the current fields will remain similar to the current system, but with greater functionality.



One of the new functions of the Scheduler is the new calendar. This calendar is visible to customers and will allow them to pick a date/time slot for turn-in.

Dates available for scheduling a turn-in will be in white.

Non-available dates will be "grayed out". This should alleviate some of the frustrations our customers have had with requests being cancelled or overbooked.



This new Scheduler will also send out automatic emails of confirmation to all personnel involved with the scheduling process. This will speed up the process of gaining confirmation that a request has been received, reviewed and accepted.
