Purpose of Modification:

The purpose of this modification is to incorporate changes to Section H, Special Contract Requirements. Modification M108 made the change to DOE O 226.1A in Section J, Attachment E, para (b), but did not include making the change to Clause H.46. Modification M077 added Clause H.49 for DOE O 210.2, but the title and text are being changed in this Modification to more accurately reflect the description of the actual previous change.

Description of Modification:

- 1) Section H.46- Change DOE O 226.1 to DOE O 226.1A in the title and in the text.
- 2) Section H.49- Change title from "DOE Directives" to "Corporate Operating Experience DOE O 210.2"; and delete the existing text, replacing with the following sentence:

"The Contractor is responsible for complying with the Contractor Requirements Document (CRD) of DOE Order 210.2 Corporate Operating Experience Program."
- 3) Revise Section H Table of Contents to reflect the changes above.
- 4) All other terms and conditions remain the same.
