**Purpose of Modification:**

The purpose of this modification is to update Section B, *Supplies or Services and Prices/Costs*. The subject modification definitizes Request for Equitable Adjustment (REA) 2011-011, *Multi-Employer Pension Plan Contribution for Plan Year 2011*.

**Description of Modification:**

1. The table in Section B, *Supplies or Services and Prices/Costs*, Contract Section B.2 *Obligation and Availability of Funds and Contract Value*, paragraph (c) is deleted in its entirety and replaced with the following table, which incorporates the following revisions:

- Increase the Total Estimated Contract Cost (TECC) by \$427,217, from \$10,556,162,212 to \$10,556,589,429;
- Increase the Total Estimated Contract Price (TECP) by \$427,217 from \$11,164,294,914 to \$11,164,722,131; and
- Said REA, 2011-011, is non-fee bearing, therefore there is no change in Total Maximum Available Fee.
