GOV Scope and Applicability

- Vehicles issued from the Interagency Fleet Management System (IFMS) or on permanent dispatch from garrison motor pools should be issued a fuel card from the responsible organization
- Organizations / Units that own or long-term lease vehicles directly (not issued from IFMS or garrisons) should review slide 5
- Organizations / Units that rent or short-term lease vehicles for official use should review slide 6
- All personnel operating government vehicles and using a government fuel card must review video training modules (on DVD or from shopmyexchange.com web page)

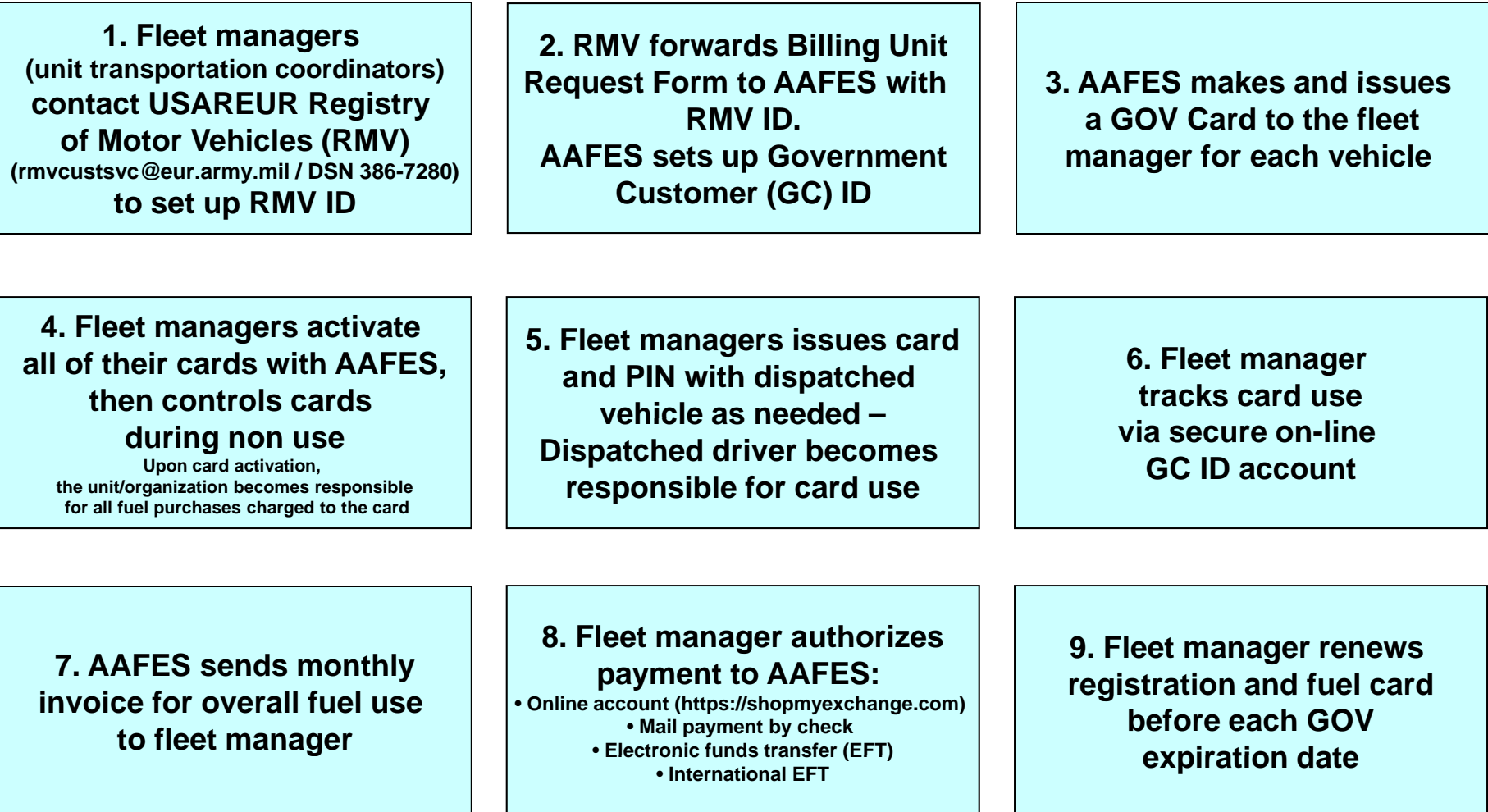

Rental or Short-term Lease GOV Process

- Official-use fuel policy is based on Army Europe Regulation 710-2, Chapter 8-14
- Unit/organization with short-term official use (rental or lease) need must already have at least one official-use vehicle registered with USAREUR and have an AAFES government customer account
- Unit transportation coordinator or fleet manager sends request to RMV (rmvcustsvc@eur.army.mil) along with scanned copy of the rental or lease copy
- RMV lists the vehicle within RMV data, within the unit/organization account
- RMV Emails scanned AE Form 190-1A authorization form to the transportation coordinator or fleet manager. There is no ration limit for the authorized vehicle, but the authorization form expires on the same day that the rental/lease contract expires
- Unit/organization owes \$15 to RMV for this service. Payment process to RMV via Government Purchase Card.
- Unit/organization rep takes authorization form to AAFES card issue site
- AAFES issues card, unit/organization rep assigns PIN to activate, then uses card along with authorization form form IAW standard procedures for fuel card transactions at AAFES and Esso in Germany
- Upon card activation, the unit/organization becomes responsible for all fuel purchases charged to the card.
- At the end of the rental/lease period, the transportation coordinator or fleet manager retains the card thru one billing period. After the monthly bill has been paid for all fuel used by the rental/leased vehicle, the transportation coordinator or fleet manager destroys the fuel card
- AAFES adds rental/lease vehicle fuel use to existing monthly invoice for all other organization GOVs
- The above info is subject to final review and publication by AE Regulation 710-2 proponent
