Mr. BISHOP of Utah, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 830) to rescind the unobligated funding for the FHA Refinance Program and to terminate the program.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the State of the Union for consid-
5 eration of the bill (H.R. 830) to rescind the unobligated
6 funding for the FHA Refinance Program and to terminate
7 the program. The first reading of the bill shall be dis-

1 pensed with. All points of order against consideration of
2 the bill are waived. General debate shall be confined to
3 the bill and shall not exceed one hour equally divided and
4 controlled by the chair and ranking minority member of
5 the Committee on Financial Services. After general debate
6 the bill shall be considered for amendment under the five-
7 minute rule. It shall be in order to consider as an original
8 bill for the purpose of amendment under the five-minute
9 rule the amendment in the nature of a substitute rec-
10 ommended by the Committee on Financial Services now
11 printed in the bill. Each section of the committee amend-
12 ment in the nature of a substitute shall be considered as
13 read. All points of order against the committee amend-
14 ment in the nature of a substitute are waived. No amend-
15 ment to the committee amendment in the nature of a sub-
16 stitute shall be in order except those received for printing
17 in the portion of the Congressional Record designated for
18 that purpose in clause 8 of rule XVIII in a daily issue
19 dated March 9, 2011, or earlier and except pro forma
20 amendments for the purpose of debate. Each amendment
21 so received may be offered only by the Member who caused
22 it to be printed or a designee and shall be considered as
23 read if printed. At the conclusion of consideration of the
24 bill for amendment the Committee shall rise and report
25 the bill to the House with such amendments as may have

1 been adopted. Any Member may demand a separate vote
2 in the House on any amendment adopted in the Com-
3 mittee of the Whole to the bill or to the committee amend-
4 ment in the nature of a substitute. The previous question
5 shall be considered as ordered on the bill and amendments
6 thereto to final passage without intervening motion except
7 one motion to recommit with or without instructions.
