RESOLUTION

- Providing for consideration of the concurrent resolution (H. Con. Res. 34) establishing the budget for the United States Government for fiscal year 2012 and setting forth appropriate budgetary levels for fiscal years 2013 through 2021.
 - 1 *Resolved*, That at any time after the adoption of this
 - 2 resolution the Speaker may, pursuant to clause 2(b) of
 - 3 rule XVIII, declare the House resolved into the Committee
 - 4 of the Whole House on the state of the Union for consider-

ation of the concurrent resolution (H. Con. Res. 34) estab-1 2 lishing the budget for the United States Government for 3 fiscal year 2012 and setting forth appropriate budgetary 4 levels for fiscal years 2013 through 2021. The first read-5 ing of the concurrent resolution shall be dispensed with. All points of order against consideration of the concurrent 6 7 resolution are waived. General debate shall not exceed four 8 hours, with three hours confined to the congressional 9 budget equally divided and controlled by the chair and 10 ranking minority member of the Committee on the Budget and one hour on the subject of economic goals and policies 11 12 equally divided and controlled by Representative Brady of 13 Texas and Representative Hinchey of New York or their respective designees. After general debate the concurrent 14 15 resolution shall be considered for amendment under the five-minute rule. It shall be in order to consider as an 16 17 original concurrent resolution for the purpose of amendment under the five-minute rule the amendment in the na-18 ture of a substitute printed in part A of the report of the 19 20 Committee on Rules accompanying this resolution. That 21 amendment in the nature of a substitute shall be consid-22 ered as read. All points of order against that amendment 23 in the nature of a substitute are waived. No amendment 24 to that amendment in the nature of a substitute shall be 25 in order except those printed in part B of the report of

the Committee on Rules. Each amendment may be offered 1 2 only in the order printed in the report, may be offered 3 only by a Member designated in the report, shall be con-4 sidered as read, shall be debatable for the time specified 5 in the report equally divided and controlled by the proponent and an opponent, and shall not be subject to 6 7 amendment. All points of order against the amendments 8 printed in part B of the report are waived except that the 9 adoption of an amendment in the nature of a substitute shall constitute the conclusion of consideration of amend-10 ments to the amendment in the nature of a substitute 11 12 made in order as original text. After the conclusion of con-13 sideration of the concurrent resolution for amendment and 14 a final period of general debate, which shall not exceed 15 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on the Budg-16 17 et, the Committee shall rise and report the concurrent res-18 olution to the House with such amendment as may have been adopted. Any Member may demand a separate vote 19 20 in the House on any amendment adopted in the Com-21 mittee of the Whole to the concurrent resolution or to the 22 amendment in the nature of a substitute made in order 23 as original text. The previous question shall be considered 24 as ordered on the concurrent resolution and amendments 25 thereto to final adoption without intervening motion except amendments offered by the chairman of the Com mittee on the Budget pursuant to section 305(a)(5) of the
Congressional Budget Act of 1974 to achieve mathe matical consistency. The concurrent resolution shall not
be subject to a demand for division of the question of its
adoption.
