Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3578) to amend the Balanced Budget and Emergency Deficit Control Act of 1985 to reform the budget baseline, and providing for consideration of the bill (H.R. 3582) to amend the Congressional Budget Act of 1974 to provide for macroeconomic analysis of the impact of legislation.

- 1 *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order to consider in the House the bill (H.R.
- 3 3578) to amend the Balanced Budget and Emergency

1 Deficit Control Act of 1985 to reform the budget baseline.
2 All points of order against consideration of the bill are
3 waived. In lieu of the amendment in the nature of a sub-
4 stitute recommended by the Committee on the Budget now
5 printed in the bill, an amendment in the nature of a sub-
6 stitute consisting of the text of the Rules Committee Print
7 112-9 dated January 25, 2012, shall be considered as
8 adopted. The bill, as amended, shall be considered as read.
9 All points of order against provisions in the bill, as amend-
10 ed, are waived. The previous question shall be considered
11 as ordered on the bill, as amended, and on any further
12 amendment thereto, to final passage without intervening
13 motion except: (1) one hour of debate equally divided and
14 controlled by the chair and ranking minority member of
15 the Committee on the Budget; (2) the further amendment
16 printed in part A of the report of the Committee on Rules
17 accompanying this resolution, if offered by Representative
18 Jackson Lee of Texas or her designee, which shall be in
19 order without intervention of any point of order, shall be
20 considered as read, shall be separately debatable for 10
21 minutes equally divided and controlled by the proponent
22 and an opponent, and shall not be subject to a demand
23 for division of the question; and (3) one motion to recom-
24 mit with or without instructions.

1 SEC. 2. At any time after the adoption of this resolu-
2 tion the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3582) to amend the Congressional
6 Budget Act of 1974 to provide for macroeconomic analysis
7 of the impact of legislation. The first reading of the bill
8 shall be dispensed with. All points of order against consid-
9 eration of the bill are waived. General debate shall be con-
10 fined to the bill and shall not exceed one hour equally di-
11 vided and controlled by the chair and ranking minority
12 member of the Committee on the Budget. After general
13 debate the bill shall be considered for amendment under
14 the five-minute rule. In lieu of the amendment in the na-
15 ture of a substitute recommended by the Committee on
16 the Budget now printed in the bill, it shall be in order
17 to consider as an original bill for the purpose of amend-
18 ment under the five-minute rule an amendment in the na-
19 ture of a substitute consisting of the text of the Rules
20 Committee Print 112-10 dated January 25, 2012. That
21 amendment in the nature of a substitute shall be consid-
22 ered as read. All points of order against that amendment
23 in the nature of a substitute are waived. No amendment
24 to that amendment in the nature of a substitute shall be
25 in order except those printed in part B of the report of

1 the Committee on Rules accompanying this resolution.
2 Each such amendment may be offered only in the order
3 printed in the report, may be offered only by a Member
4 designated in the report, shall be considered as read, shall
5 be debatable for the time specified in the report equally
6 divided and controlled by the proponent and an opponent,
7 shall not be subject to amendment, and shall not be sub-
8 ject to a demand for division of the question in the House
9 or in the Committee of the Whole. All points of order
10 against such amendments are waived. At the conclusion
11 of consideration of the bill for amendment the Committee
12 shall rise and report the bill to the House with such
13 amendments as may have been adopted. Any Member may
14 demand a separate vote in the House on any amendment
15 adopted in the Committee of the Whole to the bill or to
16 the amendment in the nature of a substitute made in order
17 as original text. The previous question shall be considered
18 as ordered on the bill and amendments thereto to final
19 passage without intervening motion except one motion to
20 recommit with or without instructions.
