AREA members vote in officers; OK constitution, bylaws changes

AREA members voted in May to reelect three officers and approve changes to AREA's constitution and bylaws.

President Chuck Poffenbarger will serve another term as will Gerry Peterson, Treasurer, and Don Smith, Secretary. The three incumbents took office on June 1.

The position of President-Elect remains vacant, but a search is on for someone to fill the position. Tom Harmon, board member, agreed to head the search committee. As with all officers on the AREA Executive Board, the person in this position must be a resident of the Dallas-Fort Worth area and able to attend board meetings in Dallas.

The man or woman who will become President-Elect will serve the remaining period of time in the 2009-2011 term of office.

The incumbent will then be in position to run as AREA President in the next AREA election in 2011.

The four elective officers on the Board of Directors serve two-year terms.

Social Security Benefits Everyone

Social Security reaches almost every family, and at some point touches the lives of nearly all Americans. It has an impact on the very fabric of the American economy.



Social Security helps not only older Americans, but also workers who become disabled and families in which a spouse or parent dies. Today, about 162 million people work and pay Social Security taxes and more than 51 million people receive monthly Social Security benefits. In 2008 alone, those benefits came to about \$614 billion.

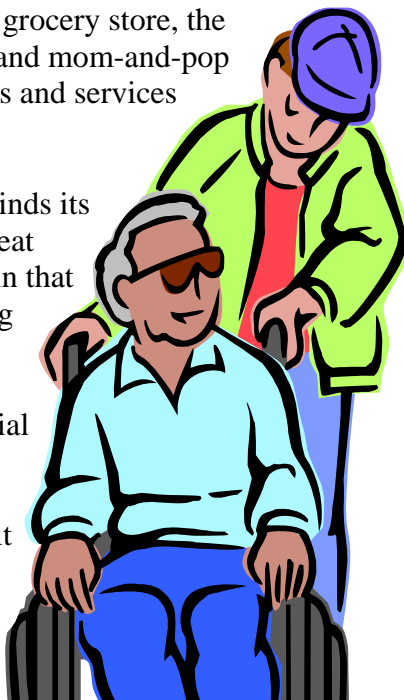

AAFES health benefits claims jump 10.6% in '08

The total claims cost for AAFES in the Department of Defense NonAppropriated Fund Health Benefits Program (DoD NAF HBP) for plan year 2008 was **\$145.5M** compared to **\$131.5M** in 2007. The 2008 claims cost increased 10.6% from 2007.

AAFES 2008 Total Claims Cost

Pharmacy	\$38.0M

Key drivers of the claims cost were the treatment of chronic illnesses and prescription drug cost. In 2008 the top 5 chronic diseases and drugs were:

2008 Top 5 Chronic Diseases & Drugs	
Chronic Diseases	Drugs
Hypertension	Nexium (heartburn and ulcer)
Hyperlipidemia (cholesterol)	Lipitor (high cholesterol)
Diabetes	Prevacid (heartburn and ulcer)
Nonspecific Gastritis/Dyspepsia	Plavix (heart disease)
Allergy	Actos (diabetes)

Hypertension and *Hyperlipidemia* (high cholesterol) are both precursors to more serious heart disease.

Ways we all can help control cost

- Utilizing the preventive services that are offered in the plan
 - Covered at 100% no copay/no deductible.
- Use urgent care facilities instead of the emergency room (ER)
 - Use ER only in the case of emergency
- Use mail order drug (MOD) benefit
 - Use MOD for your maintenance drugs – 90-day supply (medications you are taking on a regular basis such as high blood pressure; cholesterol; diabetes and etc.)
- Using MOD you'll pay less for medication because you can order up to a 90-day supply of medication for the cost of a 60-day supply...you **save** one copay
 - Use generic prescriptions if available
- A generic is the equivalent for a brand name drug; however it **costs less** than the brand name
 - Using generics **save** on cost for you and the medical plan
- Participate in the disease management program, if applicable
- Change to a healthier lifestyle

Note: The DoD NAF HBP is a self-insured program. Self-insured means the employers assume the risk for paying the claims and administrative fees to a company that administers the program. Aetna is the third party administrator that processes/pays the claims for the DoD NAF HBP.

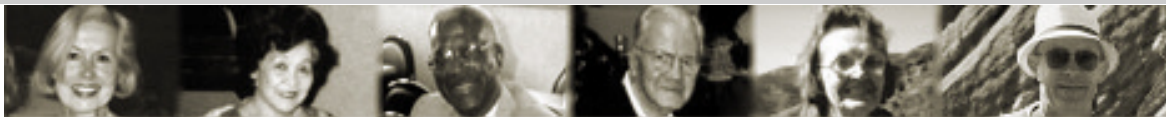

COO reports on strong AAFES performance

Much has happened since the last time I had the privilege of writing an article in this newsletter. We finished one of the most difficult years in our nearly 114-year history with challenges all around us.

As you are aware, the U.S. economy has been in recession for at least the past year, the war in Iraq is drawing down, and military operations in Afghanistan are building up. Simultaneously, AAFES is keeping the focus on providing the best customer service possible as evidenced by our strong Customer Satisfaction Index score. In addition, our Associate Satisfaction Index also remains strong for the third straight year in a row.

You'll be happy to know that AAFES continues to meet our mission of providing goods and services at competitive prices while returning a dividend to Soldiers and Airmen and their families.

In fact, 2008, despite the challenges presented by a declining economy, AAFES' performance was truly outstanding. Sales and earnings for 2008 were 2 percent and 1.10 percent respectively higher than in 2007. These figures go against the retail industry trend with very few exceptions

Industry retail sales (excluding autos, gasoline and restaurants) showed improvement for the first three months of 2009. However, retailers will continue to face challenging economic conditions and sales gains will be difficult to achieve for the balance of this year. The strongest quarter this year should be the fourth quarter as comparisons to last year are the easiest and the economy should be strengthening. Even though the quarterly pattern of sales will improve as the year progresses, for the year as a whole, sales are anticipated to be down .5 to 1% from last year.

AAFES compared to its key competitors was well positioned for the economic downturn. We have been diligent in strengthening our value proposition which has resonated with our customers. Additionally, job security, one of the key factors influencing consumer spending, has not been as important with our customers.

For the first three months, AAFES has continuously outperformed most of its competitors and together with Wal-Mart stayed in the positive territory.

earnings through April, ahead of the same period for 2008. The increases in our sales and earnings are because our customers have rediscovered the value of shopping at AAFES. With increased emphasis on solution selling, we've increased the number of customer transactions and number of items purchased with each transaction.



And our increases don't only come at our brick-and-mortar exchanges. AAFES' Web site, www.AAFES.com, is growing every year.

In 2009, online sales on the Web site so far are trending upward about 2 percent. The site's 18 million products provides customers with "endless aisles" of choices.

If you haven't shopped www.AAFES.com lately, you could be missing some great bargains.

This year will also see new shopping centers and other retail and food facilities open. The Kaiserslautern Military Community Center (KMCC) will open in the fall, a long anticipated facility that will become a reality for Soldiers, Airmen and their families across Europe.

In addition to numerous restaurants around the AAFES world, other facilities that opened recently include the Fort Riley Shopping Center, Eielson AFB Shopping Center, mini-malls at Fort Bragg, Beale AFB and Fort Bliss.

The first-ever AAFES Lifestyle Center will begin construction this year at Fort Bliss, Texas, and will incorporate the best of AAFES facilities with the best of industry and the military community to bring world-class convenience and service to our customers. In addition to traditional AAFES facilities, they can enjoy a multiplex movie theater, name-brand casual dining, and a first-class food court with all the popular brands. The commissary, fitness center and other community activities also will be located within the Lifestyle Center.

As always, I count on our AAFES retired community to continue to be goodwill ambassadors and faithful customers. Together, we can continue to move this organization we love in a positive direction and make life easier for military members and their families around the world.

AAFES Retired Employees Association (AREA) 2009 Scholarship Program

This year AREA awarded scholarships totaling \$42,500. Although the Board initially approved twelve scholarship awards earlier in the year, it was obvious during the evaluation process that there were more than twelve deserving applicants. The Scholarship Committee asked the board to approve six additional \$1,000 awards. The board unanimously endorsed the proposal. We were able to award scholarship monies to eighteen qualified applicants. I am proud to tell you that \$388,795 in awards has been made to 221 deserving students since the AREA scholarship program's inception in 1985. A brief recap of each 2009 awardees accomplishments and aspirations is shown on the following pages.

This was another banner year for the AREA Scholarship Program. With sixty-six applications received and thirty-nine of those meeting AREA criteria, 2009 proved to be the highest participation rate since the program began. Having said that, I would be remiss if I failed to mention how funds have been and continue to be made available for this outstanding "AAFES Employee Oriented" program. The program garners support from both industry partners and from many within our own ranks who choose to recognize loved ones with a donation to the AREA Scholarship fund. Industry support and individual donations are key factors to the program's past and future success.

Here is a summary of this year's process. All applicants were screened to assure minimum requirements were met. After meeting the "AAFES Employee, Son or Daughter" and minimum academic criteria, each application was assigned a file number used to track applications throughout the evaluation process. Qualified applicant files were reviewed privately by each member of the evaluation committee and ranked using academic achievement, awards, school and outside activity participation, letters of recommendation and finally, an essay themed on "why I deserve this scholarship..."

All scores were aggregated, ties were broken and the award roster finalized. After that, an applicant summary together with the committee's additional awards recommendation was sent to Chuck Poffenbarger, AREA President. The AREA BOD reviewed the committee's recommendations and by vote approved the six additional awards. Chuck Poffenbarger then sent congratulatory letters to each awardee detailing the scholarship.

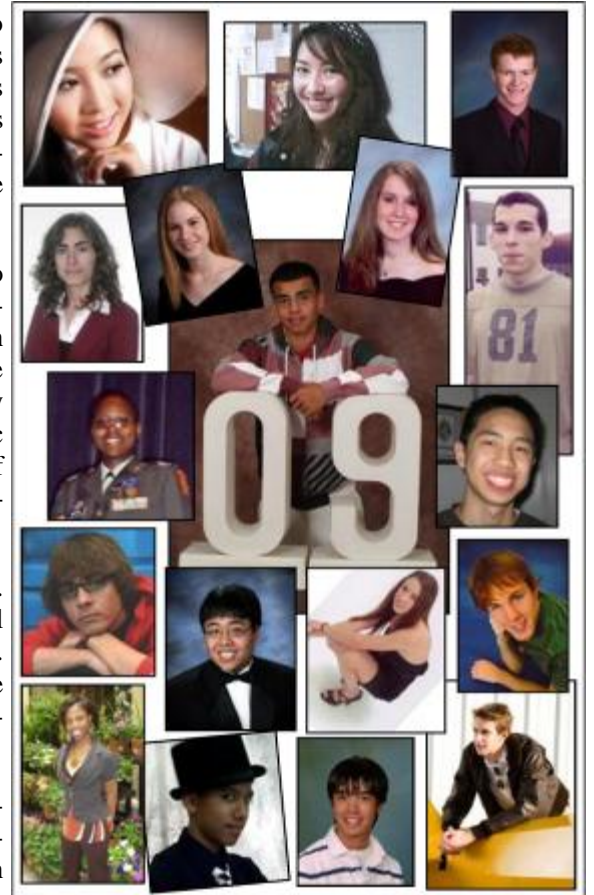

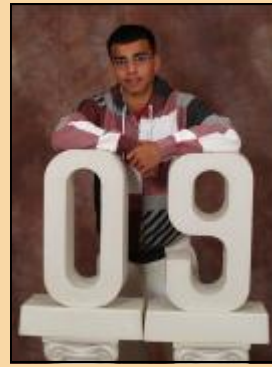

We stopped in Enterprise, AL to visit retired AAFES friends Marty Maston and Don Allen. They have two Shelties, and one is blind. Chappy was welcomed into their home, and he did fine as long as he was velcroed to my

By the time we arrived at the rally the grounds were puddles and 3,000 RVs had to park in those mud puddles. It was a mess! Several of the big rigs got stuck in the mud. IN REMEMBRANCE

PHELPS FREDRIC POND, 93, of Dallas, died on May 25 in Dallas. Born on January 29, 1916, in Middlebury, Vermont, the son of Ira and Edith Coolihan Pond, he was preceded in death by his three brothers.

At a young age he began to caddy at the local golf course and developed a love for the game of golf that would last a lifetime. He was blessed with the good health to play his favorite game until the age of 88. Phelps graduated from the University of Vermont and was a member of the Sigma Phi fraternity. After college he worked for GE and later served in the Army during the War. He was stationed in Atlanta, Georgia where he met his future bride, Mary Lewis.

On June 7, 1944, one day after the invasion of Europe and nearly 65 years ago Phelps and Mary were wed in Atlanta. During the war Phelps worked for what would one day become the Army and Air Force Exchange Service (AAFES). Phelps and Mary raised three children, Mia, Tom, and Fred. After many years of living in New Jersey and working at Hq. AAFES in New York City, Phelps was transferred to the European Headquarters of AAFES in 1965. The Pond family lived in Nurnberg, Germany until 1968 when they returned to the US, this time to Dallas, Texas, the new home of AAFES. Phelps completed his distinguished AAFES career as the Assistant to the Commander, AAFES, the highest-ranking civilian position (which is now the Chief Operating Officer).

Phelps and Mary settled in Duncanville and built their dream home in 1971. Phelps retired as a Colonel in the Army Reserve, and later from AAFES, filling his days with his passion for golf. A charter member of AREA, he served as AREA president from 1978-80. In 2002 Phelps and Mary moved to a retirement community, The Forum at Park Lane, in Dallas. Phelps was a member of the Presbyterian Church, a volunteer for Meals on Wheels for many years, and a contributor to numerous charitable causes. Phelps is survived by his wife, Mary, a daughter Mia Pond, and sons Thomas Pond and his wife Joann, and Lt. Colonel Phelps Pond, Jr. and his wife Zameena. Other survivors include grandchildren Lee Pond, Stacey Pond Harth, Iman Woods, Nadia Haddad, Jack Pond, Laila Pond and two great grandchildren.

ROBERT BARLOW, 83, died March 15 in Leominster, Mass. The former Fort Devons Retail Manager retired in 1982.

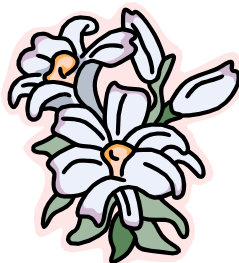
ALEXANDER CONNORS, 76, died March 8 in Niceville, FL. The former Elgin AFB Exchange Manager retired in 1989.
