

## **Funds to Help Revitalize Properties**

EPA's Brownfields Program provides funding to state, local and tribal governments through Brownfields Revolving Loan Fund (RLF) grants. These grants are used to make loans and subgrants to help communities carry out cleanup activities, redevelopment projects, and create jobs for local residents living near brownfields sites. On August 4, 2009, EPA announced the following grantees were selected to receive supplemental funding under the Recovery Act and regular program funding to replenish their RLF grants:

\*Grantee received both Recovery Act and regular program funding.

### **Alabama**

- Alabama Department of Environmental Management  
\$630,000 for hazardous substances (Recovery Act Funding)  
\$300,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at as many as six shovel-ready projects identified by the state that are contaminated with hazardous substances and petroleum.

### **California**

- City of Anaheim  
\$450,000 for hazardous substances (Recovery Act Funding)  
Hazardous substances funds will be used to replenish the RLF, from which the City will provide loans and subgrants to support cleanup activities at the City of Anaheim Ross Park Expansion Site.
- California Department of Toxic Substances Control  
\$1,800,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at as many as six shovel-ready hazardous substances projects that have been identified by the Department.
- \*City of Emeryville  
\$500,000 for petroleum (Recovery Act Funding)  
\$500,000 for petroleum (Regular Program Funding)  
Recovery Act funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as four shovel-ready petroleum projects that have been identified by the city. In addition, general brownfields funds will be used to provide loans and subgrants to support cleanup activities at two petroleum projects.
- City of Oakland  
\$200,000 for hazardous substances (Regular Program Funding)

\$200,000 for petroleum (Regular Program Funding)

Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as nine projects identified by the city that are contaminated with hazardous substances and petroleum.

## **Colorado**

- City of Aurora  
\$450,000 for hazardous substances (Recovery Act Funding)  
\$1,000,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as seven shovel-ready projects identified by the city that are contaminated with hazardous substances and petroleum.
- Colorado Department of Public Health & Environment  
\$1,350,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at several of the 10 shovel-ready hazardous substances projects that have been identified by the Department.

## **Connecticut**

- \*City of Bridgeport  
\$400,000 for petroleum (Recovery Act Funding)  
\$500,000 for hazardous substances (Regular Program Funding)  
Recovery Act funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as six shovel-ready petroleum projects that have been identified by the city. In addition, general brownfields funds will be used to provide loans and subgrants to support cleanup activities at up to 10 hazardous substances projects.
- Connecticut Department of Economic and Community Development  
\$600,000 for hazardous substances (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at as many as nine hazardous substances projects that have been identified by the Department.
- Valley Council of Governments  
\$900,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Council will provide loans and subgrants to support cleanup activities at several of the eight shovel-ready hazardous substances projects that have been identified by the Council.

## **Florida**

- Treasure Coast Regional Planning Council  
\$450,000 for hazardous substances (Recovery Act Funding)

Hazardous substances funds will be used to replenish the RLF, from which the Council will support cleanup activities at a former incinerator and landfill site in the City of West Palm Beach.

## **Idaho**

- \*Sage Community Resources  
\$400,000 for hazardous substances (Recovery Act Funding)  
\$1,100,000 for hazardous substances (Regular Program Funding)  
Recovery Act funds will provide loans and subgrants to support cleanup activities at as many as four shovel-ready hazardous substances projects that have been identified by Sage. In addition, general brownfields funds will be used to provide loans and subgrants to support cleanup activities for several other hazardous substances projects.

## **Illinois**

- Illinois Environmental Protection Agency  
\$1,000,000 for hazardous substances (Regular Program Funding)  
\$1,000,000 for petroleum (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the Agency will provide loans and subgrants to support cleanup activities at several of the 21 projects identified by the Agency that are contaminated with hazardous substances and petroleum.
- City of Rockford  
\$500,000 for petroleum (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at several of the more than 40 petroleum projects that have been identified by the city.

## **Indiana**

- Indiana Finance Authority  
\$900,000 for hazardous substances (Recovery Act Funding)  
\$1,600,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at several of the 31 shovel-ready projects identified by municipalities in the state that are contaminated with hazardous substances and petroleum.
- City of South Bend  
\$360,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at two shovel-ready hazardous substances projects that have been identified by the city.

## **Iowa**

- Sioux City  
\$450,000 for hazardous substances (Recovery Act Funding)  
\$200,000 for petroleum (Recovery Act Funding)

Hazardous substances and petroleum funds will be used to replenish the RLF, from which the city will provide a loan to support cleanup activities at the KD Station project at the former Swift & Company plant.

## **Maine**

- City of Bath  
\$360,000 for hazardous substances (Recovery Act Funding)  
\$200,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as three shovel-ready projects identified by the city that are contaminated with hazardous substances and petroleum.
- Southern Maine Regional Planning Commission  
\$300,000 for hazardous substances (Regular Program Funding)  
\$400,000 for petroleum (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the Commission will provide loans and subgrants to support cleanup activities at several of the 15 projects identified by the Commission that are contaminated with hazardous substances and petroleum.

## **Massachusetts**

- Boston Redevelopment Authority  
\$720,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at as many as four shovel-ready hazardous substances projects that have been identified by the Authority.
- Franklin Regional Council of Governments  
\$500,000 for hazardous substances (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the Council will provide loans and subgrants to support cleanup activities at as many as five hazardous substances projects that have been identified by the Council.
- Pioneer Valley Planning Commission  
\$500,000 for hazardous substances (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the Commission will provide loans and subgrants to support cleanup activities at hazardous substances projects in Hampden and Hampshire Counties in western Massachusetts.
- City of Taunton  
\$500,000 for hazardous substances (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at three hazardous substances projects that have been identified by the city.
- City of Worcester

\$720,000 for hazardous substances (Recovery Act Funding)

\$200,000 for petroleum (Recovery Act Funding)

Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as five shovel-ready projects identified by the city that are contaminated with hazardous substances and petroleum.

## **Michigan**

- \*Downriver Community Conference

\$1,000,000 for petroleum (Recovery Act Funding)

\$300,000 for hazardous substances (Regular Program Funding)

\$350,000 for petroleum (Regular Program Funding)

Recovery Act funds will be used to replenish the RLF, from which the Conference will provide loans and subgrants to support cleanup activities at as many as five shovel-ready petroleum projects that have been identified by the Conference in four member communities. In addition, general brownfields funds will be used to provide loans and subgrants to support cleanup activities at as many as nine hazardous substances and petroleum projects that have been identified in seven member communities.

- City of Monroe

\$250,000 for hazardous substances (Regular Program Funding)

\$500,000 for petroleum (Regular Program Funding)

Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as five projects identified by the city that are contaminated with hazardous substances and petroleum.

- Wayne County

\$699,904 for hazardous substances (Recovery Act Funding)

Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at several of the 11 shovel-ready hazardous substances projects that have been identified by the county.

## **Minnesota**

- Hennepin County

\$1,800,000 for hazardous substances (Recovery Act Funding)

Funds will be used to replenish the RLF, from which the county will provide loans and subgrants to support cleanup activities at as many as five shovel-ready hazardous substances projects that have been identified by the county.

- Minnesota Department of Employment and Economic Development

\$1,000,000 for hazardous substances (Regular Program Funding)

\$1,000,000 for petroleum (Regular Program Funding)

Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at several projects around the state that are contaminated with hazardous substances and petroleum.

- Saint Paul Port Authority

\$500,000 for hazardous substances (Regular Program Funding)

Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at as many as three hazardous substances projects that have been identified by the Authority.

## **Missouri**

- Environmental Improvement & Energy Resources Authority  
\$360,000 for hazardous substances (Recovery Act Funding)  
\$800,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at as many as five shovel-ready projects identified by the Authority that are contaminated with hazardous substances and petroleum.
- \*Kansas City  
\$360,000 for hazardous substances (Recovery Act Funding)  
\$200,000 for petroleum (Recovery Act Funding)  
\$600,000 for hazardous substances (Regular Program Funding)  
Recovery Act funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as eight shovel-ready projects identified by the city that are contaminated with hazardous substances and petroleum. In addition, general brownfields funds will be used to provide loans and subgrants to support cleanup activities at as many as nine hazardous substances projects.
- St. Louis Development Corporation  
\$540,000 for hazardous substances (Recovery Act Funding)  
\$420,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Corporation will provide loans and subgrants to support cleanup activities at several of the 12 shovel-ready projects identified by the Corporation that are contaminated with hazardous substances and petroleum.
- City of Springfield  
\$360,000 for hazardous substances (Recovery Act Funding)  
\$150,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at several of the 11 shovel-ready projects identified by the city that are contaminated with hazardous substances and petroleum.

## **Montana**

- City of Missoula  
\$900,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as six shovel-ready hazardous substances projects that have been identified by the city.

## **New Hampshire**

- New Hampshire Department of Environmental Services  
\$1,800,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the NHDES will provide loans and subgrants to support as many as nine shovel-ready hazardous substances cleanup projects that have been identified by the state.

### **New Mexico**

- New Mexico Environmental Department  
\$1,440,000 for hazardous substances (Recovery Act Funding)  
\$400,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at as many as five shovel-ready projects identified by the Department that are contaminated with hazardous substances and petroleum.

### **New York**

- Niagara County  
\$900,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the county will provide loans and subgrants to support cleanup activities at as many as four shovel-ready hazardous substances projects that have been identified by the county.

### **North Carolina**

- Land of Sky Regional Council  
\$360,000 for hazardous substances (Recovery Act Funding)  
\$300,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Council will provide loans and subgrants to support cleanup activities at as many as three shovel-ready projects identified by the Council that are contaminated with hazardous substances and petroleum.

### **Ohio**

- Cuyahoga County  
\$900,000 for hazardous substances (Recovery Act Funding)  
\$1,000,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the county will provide loans and subgrants to support cleanup activities at several of the 20 shovel-ready projects identified by the county that are contaminated with hazardous substances and petroleum.
- Ohio Department of Development  
\$1,800,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at several of the 126 shovel-ready hazardous substances projects that have been identified by the Department.
- City of Toledo  
\$540,000 for hazardous substances (Recovery Act Funding)

Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as six shovel-ready hazardous substances projects that have been identified by the city.

## **Oklahoma**

- Oklahoma City  
\$900,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the city will provide loans and subgrants to support cleanup activities at as many as four shovel-ready hazardous substances projects that have been identified by the city.
- Oklahoma Department of Environmental Quality  
\$1,350,000 for hazardous substances (Recovery Act Funding)  
\$605,580 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at as many as seven shovel-ready projects identified by the Department that are contaminated with hazardous substances and petroleum.

## **Oregon**

- Oregon Economic & Community Development Department  
\$414,000 for hazardous substances (Recovery Act Funding)  
\$200,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at as many as five shovel-ready projects identified by the Department that are contaminated with hazardous substances and petroleum.

## **Pennsylvania**

- County of Bucks  
\$500,000 for hazardous substances (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the county will provide loans and subgrants to support cleanup activities at as many as seven hazardous substances projects that have been identified by the county.
- City of Lehigh  
\$900,000 for hazardous substances (Recovery Act Funding)  
Hazardous substances funds will be used to replenish the RLF, from which the county will support cleanup activities at the Martin Tower project at the former Bethlehem Steel headquarters site.
- Johnstown Redevelopment Authority  
\$900,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at several shovel-ready hazardous substances projects that have been identified by the Authority.



- Northampton County  
\$300,000 for hazardous substances (Recovery Act Funding)  
Hazardous substances funds will be used to replenish the RLF, from which the county will support cleanup activities at the former Electric Furnace Shop project in the former Bethlehem Steel Foundry.

### **South Carolina**

- South Carolina Department of Health & Environmental Control  
\$1,350,000 for hazardous substances (Recovery Act Funding)  
\$500,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the SCDHEC will provide loans and subgrants to support cleanup activities at many of the 12 shovel-ready projects identified by the state that are contaminated with hazardous substances and petroleum.

### **Vermont**

- Southern Windsor County Regional Planning Commission  
\$540,000 for hazardous substances (Recovery Act Funding)  
\$50,000 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Commission will provide loans and subgrants to support cleanup activities at as many as seven shovel-ready projects identified by the Commission that are contaminated with hazardous substances and petroleum.
- Vermont Agency of Commerce & Community Development  
\$612,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Agency will provide loans and subgrants to support cleanup activities at as many as five shovel-ready hazardous substances projects that have been identified by the Agency.

### **Washington**

- Washington Department of Community, Trade & Economic Development  
\$400,000 for hazardous substances (Recovery Act Funding)  
\$2,225,920 for petroleum (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at several of the 18 shovel-ready projects identified by the Department that are contaminated with hazardous substances and petroleum.

### **Wisconsin**

- Redevelopment Authority of the City of Milwaukee  
\$450,000 for hazardous substances (Recovery Act Funding)  
Funds will be used to replenish the RLF, from which the Authority will provide loans and subgrants to support cleanup activities at several of the 10 shovel-ready hazardous substances projects that have been identified by the Authority.

- Wisconsin Department of Natural Resources  
\$500,000 for hazardous substances (Regular Program Funding)  
Funds will be used to replenish the RLF, from which the Department will provide loans and subgrants to support cleanup activities at several of the 65 hazardous substances projects that have been identified by the Department.
