Illinois General Distribution/Wine Distribution

- Three Tier State
- Direct Shipment Permit State
- Limited Self Distribution Rights

Top Tier Licenses

Illinois Manufacturer Licenses

- Distiller (\$3600)
- Rectifier (\$3600)
- Brewer (\$900)
- First Class Wine Manufacturer (\$600)
- Second Class Wine Manufacturer (\$1200)
- First Class Wine Maker (\$600)
- Second Class Wine Maker (\$1200)
- Limited Wine Manufacturer (\$120)

Top Tier Licenses (continued)

Non Resident Dealer (NRD)

- 1. Out of State Manufacturer/agent
- 2. Primary US Importer/agent
- Must sell to foreign importer or importing distributor.
- Business location may be inside Illinois

Fees: \$270 >500,000 gallons \$90<500,000 gallons

Top Tier Licenses (continued)

Foreign Importer

- Business must be located in Illinois
- Product must be warehoused in Illinois
- May import from unlicensed overseas manufacturer
- Must obtain Federal COLAs and Basic Permit
- May be held by a Distributor
- Must purchase US domestic products from NRD

Fees: \$25 (in addition to other Distributor license fees)

Second Tier Licenses

Distributors

- Distributor (General within State) (\$270)
- Importing Distributor only issued to Illinois
 Distributors (\$25)

General licensing procedures

- Manufacturers
 - Distributors

Application process:

- Obtain Federal Basic Permit and Label Approvals Call 800-937-8864 or visit the web at ttb.gov.
- 2. Contact local jurisdiction for licensing requirements.
- 3. Obtain FEIN by calling **800-829-3676**.
- 4. Obtain an Illinois Business Tax (IBT) number by calling 217-785-3707 or visit tax.illinois.gov (click on "For Businesses" and then "Business Registration").
- 5. To register as a corporation or LLC, contact the Illinois Secretary of State at **312-793-3380**.

Once above is completed, you can begin completing the Illinois liquor license application

Submissions for Manufacturers, Non-Resident Dealers, Foreign Importers:

- 1. Completed application.
- 2. Federal Label Approvals
- 3. Copy of **Federal Basic Permit**.
- 4. Registration Statement if applicable (download form at www.state.il.us/lcc).
- 5. Appointment letter for agent NRDs
- 6. Original bond issued by Illinois Dept. of Revenue (not for NRDs).
- 7. Bond fund questions? Call 217/782-6045.

Stand Alone Registrations (without application):

Mail In the following:

- 1. Registration Statement (download form at www.state.il.us/lcc).
- 2. Cover Letter state whether registration is for a new label, label revision, new distributor, etc.. Also include e-mail contact information.
- 3. Federal Label Approvals
- 4. Appointment letter for agent NRDs (if the NRD has not been previously appointed for the brand.
- 5. New on-line process (expected by end of 2009)

Required for Distributor's License:

Submit the following to ILCC

- State Application
- Basic Permit
- Lease (Warehouse Location)
- Illinois Business Tax Number
- Federal Employee ID
- Bond Form
- Inspection Required (takes a 2-4 weeks)
- Separation of Office/Warehouse is allowed
- Issued to the address on the Basic Permit (preferably where the liquor is stored).
- License will not be issued to a private residence even with local zoning approval.
- Original Illinois Dept. of Revenue (IDOR) bond form.

Revenue Bond forms (Required for 1st and 2nd Tier Licensing

RL-1 Liquor Tax Statement of Liability:

- \$1000 cashier's check payable to IDOR (may be adjusted after the first year);
- CD opened in your business name;
- Check usually released after two years.

REG-4-D Irrevocable Letter of Credit Bond:

- Obtained through a bank;
- Signed by bank officer with bank's seal.
- Approval by IDOR is required;
- Can take up to 5-7 business days.

Revenue Bond forms (cont'd.)

• REG-4-A Financial Responsibility Bond:

- Obtained through insurance company;
- Requires signature, power of attorney, company seal.
- Approval by IDOR is required;
- Can take up to 5-7 business days

Miscellaneous Tax Division:

- Verifies bond information;
- Notifies ILCC of bond approval.

Required for a Direct Wine Shipper's License (approx. 2 weeks)

- In-State/Out-of-State Makers of Wine
- Direct Ship to Consumers
 - Up to 12 cases per year per adult resident
 - Shipping requirements include "over 21" signature and identification requirements.
- Fees
 - <250,000 gallons per year = \$150.00
 - Between 250,000 and 500,000 = \$500.00
 - >500,000 gallons per year = \$1000.00
- Application requirements (Out-of-state wineries)
 - Out-of-State wine makers license
 - One Permit per license (Custom Crush example)
 - Label approvals (if not already approved)
 - Tax Bond Requirement = \$1000.00 (must call the ILCC to determine if new bond is needed).
 - Registration Statement

Self Distribution (to retailers) Exemption

- Eligibility In-State Wine Maker or Out of State Winery Holding Direct Shippers License
- Small Wineries Produce less than 25,000 gallons annually
- Distribute not more than 5,000 gallons to retailers annually
- Must file a simple exemption form with ILCC
