

ICCAT Recommendation 11-02

Quota Measures:

- Maintained:
 - North Atlantic total allowable catch (TAC) of 13,700 mt www
 - U.S. baseline allocation of 3,907 mt ww
- Removed annual quota transfer from U.S. to Canada
- Established 150 mt ww quota transfer from U.S. to Morocco
- Altered the underharvest carryover limit
 - CPCs with an allocation greater than 500 mt ww limited to underharvest carryover of 25 %
 - •All other CPCs underharvest carryover limit maintained at 50%
- Established through 2013



Proposed Quota Alternatives

- Alternative 1: No Action, maintain current baseline quota of 3,907
 mt ww and 50% underharvest carry over provision
- Alternative 2: Implement ICCAT quota provisions preferred alternative
 - U.S. baseline quota of 3,907 mt ww
 - 150 mt ww quota transfer to Morocco
 - Underharvest carryover reduction from 50% to 25%


Minimum Size Measure:


New alternative minimum size of 25" cleithrum-caudal keel
 (CK)



Swordfish Minimum Size Considerations

- Currently, the LJFL measurement applies to fish with the head naturally attached; CK applies to fish with the head removed
- Existing U.S. 29" CK minimum length was domestically calculated to ensure near 100% compliance with the 47" LJFL measurement
- 25" CK minimum length introduced to better accommodate dressed fish


Proposed Minimum Size Alternatives

Alternative 3: *Implement the new 25" CK minimum size – preferred alternative*

- Alternative 4: No longer use the LJFL minimum size, use CK as the sole minimum size standard
- Alternative 5: Allow the LJFL minimum size to be applied to swordfish without a bill preferred alternative
- Alternative 6: Reintroduce the 33 lb minimum weight

Other:

■ Enforce the minimum size beyond the point of offloading, until the point that the carcass is altered from the measurable, round form





Timeline


- Proposed Rule Published May 1st
- Comment Period Ends June 5th
- Final Rule should publish in late summer

Measures would become effective 30 days after Final Rule publication

The Alternatives

<u>Alternative 1</u>: No Action. Do not implement the 2011 ICCAT North Atlantic swordfish Recommendation 11-02 or any other new management measures

Alternative 2: Implement the 2011 ICCAT North Atlantic swordfish Recommendation 11-02, which includes an annual quota transfer of 112.8 mt dw from the U.S. to Morocco and an annual underharvest carryover limit of 25 percent of the base quota (annual carryover limit of 734.4 mt dw); maintain status quo for North Atlantic quotas – Preferred Alternative

<u>Alternative 3</u>: Implement the alternative swordfish CK minimum size measurement of 25 inches per the 2011 ICCAT North Atlantic swordfish Recommendation 11-02 – Preferred Alternative

Alternative 4: Use the CK measurement as the sole minimum size and discontinue the use of the LJFL minimum length standard in U.S. domestic fisheries

Alternative 5: Allow the LJFL minimum size to be applied to swordfish without a bill, provided the bill has been removed forward of the anterior tip of the lower jaw— Preferred Alternative

Alternative 6: Reintroduce the 33 pound minimum weight standard
