

## NMFS ANNOUNCES PROPOSED RULE TO ADJUST THE 2010 NORTH AND SOUTH ATLANTIC SWORDFISH QUOTAS

This proposed rule would, consistent with ICCAT recommendations 09-02 and 09-03:

- adjust the North Atlantic quota to 4,406.4 mt dw based on 2009 underharvest,
- □ adjust the South Atlantic quota to 75.2 mt dw (under recommendation 09-03, 100 mt ww (75.2 mt dw) of 2009 underharvest was transferred to Namibia (50 mt ww, 37.6 mt dw), Cote d' Ivore (25 mt ww, 18.8 mt dw) and Belize (25 mt ww, 18.8 dw)), and
- □ transfer 18.8 mt dw from the North Atlantic reserve to Canada.

Specifics on landings and quotas can be found in Table 1.
