NMFS Announces Proposed Rule to Adjust the 2011 North and South Atlantic Swordfish Quotas

This proposed rule would, consistent with ICCAT recommendations 10-02 and 09-03:

- adjust the North Atlantic quota to 4,406.4 mt dw based on 2010 underharvest,
- transfer 18.8 mt dw from the North Atlantic reserve category to Canada,
- adjust the South Atlantic quota to 75.0 mt dw, and
- transfer 75.0 mt dw of 2010 South Atlantic underharvest and 0.2 mt of 2011 South Atlantic baseline quota to Namibia (50 mt ww, 37.6 mt dw), Cote d'Ivore (25 mt ww, 18.8 mt dw) and Belize (25 mt ww, 18.8 dw).

Specifics on landings and quotas can be found in Table 1.

The comment period for this proposed rule is open until July 25, 2011. NMFS will accept anonymous comments (enter N/A in the required fields, if you wish to remain anonymous). You may submit attachments to electronic comments in Microsoft Word, Excel, WordPerfect, or Adobe PDF file formats only.
