The United States is a Member of the World Trade Organization (WTO). Under the Agreement on Technical Barriers to Trade (TBT) all Members report proposed technical regulations that affect trade with other Members.

WTO Members review and comment on these regulations while they are in a draft stage and subject to revision. In this way, international free trade, international transparency, and international harmonization of standards are encouraged.
