ICD-10-PCS Code Changes

- Two codes added in parallel with new technology ICD-9-CM procedure code valid October 1, 2012
- New ICD-9-CM code, *00.95* Injection or infusion of glucarpidase
- Two new ICD-10-PCS codes, **3E033GQ** Introduction of Glucarpidase into Peripheral Vein, Percutaneous Approach; **3E043GQ** Introduction of Glucarpidase into Central Vein, Percutaneous Approach

Revised Code Titles

- Individual code titles revised in response to public input
 - o In the Medical and Surgical section, device value *Hearing Device, Bone Conduction* applied to Skull body part was shortened to *Hearing Device* in order to include cochlear implant devices implanted in the skull (14 codes)
 - o Revised description pattern in Bypass table for coronary artery body parts to correctly identify the body part bypassed "from" in relationship to the

body part bypassed "to", e.g., *Bypass Coronary Artery, One Site from Right Internal Mammary, Open Approach* (248 codes)

New/Revised Index Entries

- New and revised index entries in response to public input, including
 - o Root operation for index entry Angiocardiography revised to Fluoroscopy
 - Body system for entries Hemilaminectomy and Laminectomy revised to Upper Bones and Lower Bones
 - o Body part for index entry *Pleurodesis*, *pleurosclerosis*, *Chemical injection* **revised** to *Pleural Cavity*
 - o **New** index entry *Infusion*, *glucarpidase* refers to new PCS codes
 - **New** index entry *Lavage*, *bronchial alveolar*, *diagnostic—see Drainage*, *Respiratory System*
 - o New index entry Lithotripsy, with removal of Fragments—see Extirpation

New/Revised Body Part Key Entries

- New body part key entries in response to public input
 - o Humerus, distal **use** Humeral Shaft
 - o Humerus, distal involving joint, **use** Joint, Elbow

New/Revised Device Key Entries

- Revised and deleted device key entries in response to public input, including
 - o Flair Endovascular Stent Graft key **revised** to use Intraluminal Device
 - o InterStim Therapy neurostimulator key **revised** to use Stimulator Generator, Single Array
 - o Talent Abdominal Stent Graft System entry **revised** to read Talent Stent Graft (Abdominal) (Thoracic)
 - o *Implantable Pain Pump* entry **revised** to read *Implantable drug infusion* pump (anti-spasmodic) (chemotherapy) (pain)
 - o Impella® (2.5)(5.0)(LD) cardiac assist device **deleted**—used temporarily and does not meet PCS criteria for classification as a device
 - o *Intra-aortic balloon pump* **deleted**—used temporarily and does not meet PCS criteria for classification as a device
 - o *Talent Captiva* (sic) entry **deleted**—part of the delivery system and does not meet PCS criteria for classification as a device
 - Percutaneous tibial nerve stimulation (PTNS) lead deleted—used only during the procedure and does not meet PCS criteria for classification as a device
- Many new device key entries in response to public input, including
 - o Tunneled spinal (intrathecal) catheter, **use** Infusion Device
 - Enterra gastric neurostimulator, use Stimulator Generator, Multiple Array
 - o Cardiac event recorder, **use** Monitoring Device
 - o Versa, use Pacemaker, Dual Chamber
 - o Hancock Bioprosthesis (aortic) (mitral) valve, **use** Zooplastic Tissue
