**AMENDED CERTIFICATION UNDER SECTION 1201 OF
THE AMERICAN RECOVERY AND REINVESTMENT ACT**

Dear Secretary LaHood:

Pursuant to Title XII, Section 1201 of the American Recovery and Reinvestment Act [P.L. 111-5 (February 17, 2009)] ("ARRA"), I, Faoa A. Sunia, Acting Governor of American Samoa, hereby certify to the U.S. Secretary of Transportation that the Territory of American Samoa will maintain its effort with regard to State/Territorial funding for the types of projects that are funded by ARRA for DOT "covered programs."

This amended certification is submitted in response to a formal DOT request to Governors recommending States and Territories to review their initial 1201 certifications and make any necessary changes. The enclosed amended 1201 Certification complies with DOT directives, and ensures that all applicable modes of transportation and directly related allowable activities in the Territory are included and eligible for ARRA funding and other Recovery Act assistance.

It is understood that if American Samoa is not able to maintain the level of funding identified in this list of the types of projects under the DOT "covered programs" funded under ARRA, the Territory will be prohibited by the Secretary of Transportation from receiving additional limitation on obligations for Federal-aid highway and highway safety construction programs slated for August Fiscal Year 2011.

This submission will supersede our initial certification dated March 19, 2009.
