

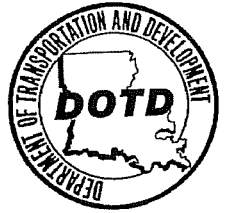

Pursuant to Title XV, Subtitle A, section 1511 of the American Recovery and Reinvestment Act (Pub. L. 111-5(Feb.17, 2009) ("ARRA"), I, Sherri H. (1) Original ARRA Cost Estimate

This amount reflects the "original planning" cost estimate of ARRA funding to be used on the respective project prior to the advertisement for the receipt of bids and includes construction, construction inspection, contingencies, and indirect costs.

(2) Original Total Cost Estimate

This amount represents the "original planning" cost estimate of ARRA and Non-ARRA funding to be used on the respective project prior to the advertisement for the receipt of bids. This amount includes construction, construction inspection, contingencies, and indirect costs.

(3) Total Current Construction Cost Estimate (ARRA and Non-ARRA)

This amount represents the current construction cost estimate immediately prior to advertising the project for the receipt of bids.

(4) Total Authorized Amount (ARRA)

This amount reflects the amount of Federal Recovery funds authorized for the respective project. Included in this amount are construction, construction inspection, contingencies, and indirect costs.

(If a value is not present in this column, the project has not been advertised for the receipt of bids.)
