Pursuant to Title XV, Subtitle A, section 1511 of the American Recovery and Reinvestment Act (Pub. L. 11-5 (Feb. 17, 2009)) (ARRA), I, Ted Strickland, Governor of the State of Ohio, hereby certify (Certification #19) that the attached infrastructure investments funded with amounts appropriated by ARRA under the following headings have received the full review and vetting required by law and that I accept responsibility that such investments are appropriate uses of taxpayer dollars:

I understand that my state or local agency may not receive ARRA infrastructure investment funding unless this certification is made and posted.
