

**DEPARTMENT OF THE TREASURY
FY 2010 ACQUISITIONS FROM ENTITIES THAT
MANUFACTURE ARTICLES, MATERIALS, OR SUPPLIES
OUTSIDE OF THE UNITED STATES**

Introduction

Federal Acquisition Regulation (FAR) Section 25.004 requires the reporting of acquisition of end products manufactured outside the United States. In accordance with Title VIII, Subsection C, Section 8306 of the U.S. Troop Readiness, Veterans' Care, Katrina Recovery, and Iraq Accountability Act of 2007 (Public Law 110-28) the head of each Federal agency must submit a report to Congress on the amount of acquisitions of articles, materials, and supplies purchased from entities that manufacture the articles, materials, or supplies outside of the United States for fiscal years 2007 through 2011. This report is in accordance with both FAR Section 25.004 and Title VIII, Subsection C, Section 8306 of Public Law 110-28.

Summary

1. Dollar value of articles, materials, or supplies purchased that were manufactured outside of the United States:

Response: The Department of the Treasury purchased items totaling \$43,087,886.56 that were manufactured outside of the United States.

2. Itemized list of all waivers granted with respect to such articles, materials, or supplies under the Buy American Act (41 U.S.C. 10a *et seq.*) with a citation to the treaty, international agreement, or other law under which each waiver was granted and the specific exception that was used to purchase such articles, materials, and supplies:

Response: Per contract information contained in the Federal Procurement Data System, Treasury executed 581 contract actions for items manufactured outside of the United States in FY 2010.
