State and Local Climate and Energy Economic Recovery Resources **April 15, 2009**

The American Recovery and Reinvestment Act of 2009 (ARRA 2009) was signed into law by President Barack Obama on February 17, 2009. ARRA is a wide-ranging effort to jumpstart the weakened economy and to lay the groundwork for developing an economy that will be able to meet the challenges of the 21st century through investments in infrastructure, energy, education, and tax incentives. If successful, ARRA could create up to 3.5 million jobs by the end of 2010. The ARRA includes a large number of funding opportunities and tax incentives to support investment in clean energy at the state and local levels. These incentives are designed to strengthen the economy and to promote clean and renewable energy.

ARRA will directly foster improved energy efficiency and increased production and use of renewable energy sources through grants and loans for specific projects and indirectly through tax incentives. Direct funding opportunities include grants for weatherization and energy improvements for affordable housing projects; schools; local government operations; water quality protection programs; and research and job training to prepare workers for careers in renewable energy and energy efficiency industries. Tax incentives in ARRA that are relevant to state and local governments include expansions of pre-existing tax credits for installation of renewable energy generation and related utility installation; an entirely new tax credit for facilities that invest in, rather than produce, renewable energy sources; and expansion of a credit for installing alternative fuel pumps. This guide is designed to help state and local governments see which EPA programs can be leveraged to expand or develop clean energy initiatives in their locality. It includes short summaries of resources offered by EPA climate and energy partnership programs. Each program description includes:

- Potential target audiences;
- Highlights of ready-to-go tools and resources; and
- Suggestions of possible actions a state or local government could take to leverage EPA's offerings.

A table also summarizes which programs can be used to develop initiatives in six categories—buildings; industry; electric power and renewable energy; transportation; energy education; and policy, planning, and energy security.
