I support the proposed rule by the Tax and Trade Bureau (TTB) which states that a flavored malt beveragehs alcohol content from distilled alcohol cannot exceed 0.5% in order to be classified as a beer. Beer is not made through the distillation process 13eer is not distilled spirits, nor is it fortified wine. Currently the seemingly clear definition of what constitutes beer is hazy. However, the adoption of a 0.5% by volume standard on FMBs would once again ensure the clear definition of beer.
