**USFK Supplement 1  
To USCINCPAC Instruction  
3480.6K**

**EVENT/INCIDENT REPORT (SHORT TITLE: OPREP-3)**

**SUPPLEMENTATION.** Supplementation of this supplement and establishment of command and local forms are prohibited without prior approval of the Commander, USFK, ATTN: FKJ3-OP, Unit #15237, APO AP 96205-0010. Existing subordinate command policy in conflict with this supplement is canceled.

USCINCPAC Instruction 3480.6K, 23 January 2001, is supplemented as follows:

**Page 3, Paragraph 3, Background.** Add the following paragraphs after paragraph 3c.

d. Commander, United States Forces, Korea (COMUSKOREA) Supplemental Instructions.

(1) Major Subordinate Commanders. All major subordinate commanders within the Korean theater will notify Command Center Seoul (CC Seoul) as soon as possible following the occurrence of an OPREP-3 reportable incident, which includes, but is not limited to the incidents listed in the attached OPREP-3 Reports Matrix. Reporting will not be delayed because of incomplete information. Follow-up reports will be made as required. In most cases, the initial report will be by voice to CC Seoul followed up with a hard copy message. Questions regarding whether an incident is OPREP-3 reportable should be referred to CC Seoul for resolution.

(2) United States (U.S.) Army organizations. Eighth United States Army (8th Army) subordinate commanders will submit critical incident reports (CIRs) and serious incident reports (SIRs) to Commander, 8th Army (CC Seoul), for relay or OPREP-3 reporting to higher headquarters as appropriate. Upon receiving the initial voice report, CC Seoul may establish a voice conference call with applicable higher headquarters (for example, USCINCPAC and Army Operations Center). All organizations must ensure that 8th Army is informed of all OPREP-3 events that are being reported to off-peninsula parent organizations. Additionally, the United States Forces, Korea (USFK) Provost Marshal (FKPM) will provide CC Seoul information copies of SIRs to be screened for possible OPREP-3 reporting. In the event the SIR is OPREP-3 reportable, CC Seoul will coordinate the release of the OPREP-3 with the Office of the Provost Marshal.

(3) Commander, U.S. Air Forces Korea (COMUSAFK). COMUSAFK will submit OPREP-3 reports in accordance with applicable PACAF directives. COMUSAFK command center will conference CC Seoul on OPREP-3 voice reports and will include COMUSKOREA as an information addressee on OPREP-3 message reports. This is particularly significant when the event affects the country-unique or military-political affairs of USFK.

(4) Commander, Naval Forces Korea (COMUSNAVFORKOREA). COMUSNAVFORKOREA will submit OPREP-3 reports for incidents involving U.S. Navy and U.S. Marine Corps personnel stationed in Korea, and will assist deployed units in submitting OPREP-3 reports to higher authority when U.S. Navy or U.S. Marine Corps units are involved. Voice reports will be routed through CC Seoul for conference when possible. Additionally, COMUSKOREA will be included as an info addressee on all OPREP-3s, to include OPREP-3 Navy Blue (U.S. Navy and U.S. Marine Corps).

(5) Responsibility. In order to prevent multiple OPREP-3 reports, CC Seoul will assign OPREP-3 responsibility when more than one military service is involved.

(6) Communications. OPREP-3 reports are to be transmitted by IMMEDIATE or FLASH precedence, depending on the scope of the incident, by the following means:

**Page 3-1, Paragraph 1, Purpose.** Add the following paragraphs at the end of paragraph 1e.

- f. Declaration of ROK Counter-Infiltration Alert System, Chin Do Kae level 1 or 2.
- g. Major violations of the Korean Armistice Agreement.
- h. Shots fired in the Demilitarized Zone (DMZ) or Joint Security Area (JSA).

**Page 4-1, Paragraph 2, General Information.** Add the following paragraphs at the end of paragraph 2h.

i. Discovery or detonation of explosive devices against U.S. or ROK Forces, installations, equipment, or personnel, or friendly forces.

j. Attacks of any nature against a ROK, U.S., or friendly force installation or attempt to penetrate the perimeter of a ROK, U.S., or friendly force installation.
