Delaware is proud to report a second consecutive year of meeting all seventeen of our performance goals for Adult, Dislocated Worker and Youth Workforce Investment Act programs! Delaware continues to demonstrate remarkable improvement, based in part on the dramatic efforts to validate the quality of our data through enhanced provider relations, especially with our Youth contract providers.

The communication with our Workforce Investment Act training providers has improved through the combined efforts of Delaware Workforce Investment Board (DWIB) and the Delaware Department of Labor, Division of Employment & Training (DET) contract management team. DWIB hosts annual provider forums and DET hosts quarterly "Results & Learning" sessions with the contracted youth providers. This formal interaction, combined with ongoing informal dialogue, has tremendously improved the communication of federally-mandated reporting elements and required documentation. The ongoing effort has greatly enhanced our ability to perform "just in time" adjustments to better meet the needs of our customers. DWIB and DET staff provide continuous feedback to our providers regarding changes in labor market demand, as the information becomes available through both Delaware Department of Labor, Division of Occupational & Labor Market Information and the private sector DWIB leadership.

12 of 17 performance standards including increased Adult Earnings, Employment and Employability (credentials) and Younger Youth Diploma and Skill Attainment rates illustrate a positive correlation of our WIA investments. Our performance outcomes for Dislocated Workers and Older Youth were slightly lower then last year, as a result of some massive layoffs in the Manufacturing sector. We continue to work toward High Growth Job Training Initiatives to off-set the job loss in this sector. We are working closely with Delaware Economic Development Office (DEDO) to adapt our training programs to meet the needs of the industry clusters that are targeted for growth in Delaware. We have aggressively recruited business DWIB members from the Delaware Economic Development Office industry cluster teams. In addition, we are consistently working on continuous improvement of our Certified Provider List to ensure that there are viable training opportunities for customers who seek entry level training in basic, relatively low-skill jobs as well as those who seek training in high-tech, high-skill jobs. In response to labor market demand, we have developed intensive Biotechnology Mentor programs, funded by a U.S. Department of Labor grant under the President's High Growth Job Training Initiative through the Business Relations Group.

The photo below illustrates an example of the successful integration of a newly trained Mentor, a student at Delaware Technical & Community College (right) setting up a Biotechnology Laboratory experiment with a teacher in the Howard Vo-Tech High School. The Mentors improved the teacher-student ratio during the experiments, which created an intensive experiential learning experience for the students. This is a program that has received national recognition as a Best Practice by the Biotechnology Institute. We presented during the July, 2005 Best Practices Day in Philadelphia and have been invited to present again in April, 2006 in Chicago.



Delaware continues to focus on intensity of services for our customers, especially those who are eligible for Intensive Services and Individual Training Accounts, to ensure strong supportive services that enhance their success and maximize their employability at the highest possible level. That intensity of service delivery is evident in our overall \$2,622 cost per participant in Program Year 2004, which is almost the same as the \$2,637 cost per participant reported in Program Year 2003. The Return on Investment is evident in our significant improvement in meeting and exceeding our Performance goals for PY03 & PY04.
