When Ordering

Ordering activities will order from BPA holders based on the location of the work to be performed. For a listing of BPA holders by region, please visit www.gsa.gov/energyservicesbpa and click on the BPA Holders link.

For orders at or below micro-purchase threshold: ordering activities may place orders directly with any BPA Holder.

For orders above the micro-purchase threshold and up to \$150,000: ordering activities shall forward the requirement, or statement of work and evaluation criteria, to at least three (3) BPA Holders.

For orders above \$150,000: ordering activities shall forward the requirement or statement of work and evaluation criteria to more than three BPA Holders.
