To: People Interested in BPA's 2002 Power Rate Case Field Hearings

On August 13, 1999, the Bonneville Power Administration published its initial rate proposal for FY 2002-2006 wholesale power rates. The initial proposal describes how BPA intends to develop rates to implement BPA's Power Subscription Strategy, published in December 1998. The Power Subscription Strategy outlined a process that will enable the people of the Northwest to share the benefits of the Federal Columbia River Power System after 2001 when current rates and most firm power contracts expire. BPA will make a final decision on its rates in early to mid 2000 after the Administrator considers the record developed through the formal rate hearing process.

An important part of the record is the testimony we receive during our rate case field hearings. These hearings are an opportunity for those not participating in the rate case as an official party to share with us their thoughts and concerns about the initial proposal. The field hearings will be held throughout the region and presided over by the hearing officer conducting the rate case. Each meeting will include a brief explanation of the initial proposal, an opportunity to ask questions of BPA representatives and provide formal comment for the official rate case record. All meetings will begin at **6:30 p.m.** A complete list of field hearing sites is on the back.
