AMERICAN RECOVERY AND REINVESTMENT ACT OF 2009

Total funds received: \$5.55 billion
Projects in all 50 states, the District of Columbia, and two territories will position PBS to meet federally mandated energy targets and propel PBS to become a 'Green Proving Ground' for the American building industry

CHILD CARE

Over 8,000 children in 110 centers in 31 states, the District of Columbia, and Puerto Rico

89% of eligible centers are accredited by the National Association for the Education of Young Children

COURTHOUSE PROGRAMS

10 courthouses with 74 courtrooms were under construction at a total estimated project cost of \$1.1 billion, and will be completed in FY10-12

ENERGY

Reduction in energy usage in Btus/GSF of 14.29% from the new 2003 baseline established in the Energy Policy Act of 2005

HISTORIC BUILDINGS

480 historic buildings including:
12 national historic landmarks
92 buildings contributing to the national historic landmark districts
7 buildings contributing to a national historic site
1 national monument

Over 25 percent of the owned inventory by square footage is historic buildings

LAND PORTS OF ENTRY (LPOE)

GSA controls 119 LPOEs (97 owned and 22 leased)

Approximately 320,000 vehicles, 136,000 pedestrians and 30,000 trucks pass through LPOE's on the US/Mexico and US/Canada borders on a daily basis
